## Legislative Update

The 2009 legislative sessions will soon be upon us, and we're getting ready for a very busy year. As of now, every state except one has provided their plans for next year, and the numbers are impressive: more than 300 planned introductions for 2009. Expect to see lots of activity with the Uniform Anatomical Gift Act, the Uniform Prudent Management of Institutional Funds Act, the Uniform Adult Guardianship and Protective Proceedings Act, and the Uniform Debt Management Services Act, along with many others. As a matter of fact, we've already recorded our first two enactments of the new year: the District of Columbia has enacted the Uniform Adult Guardianship and Protective Proceedings Jurisdiction Act and California has enacted the Uniform Prudent Management of Institutional Funds Act.

## New Members

Our newest commissioner in Wyoming is Harvey Gelb, a professor at the University of Wyoming College of Law in Laramie. Prof. Gelb replaces Harold Meier.
