5	SECTION 102. DEFINITIONS. In this [act]:
6	* * *
7	(7) "Governing jurisdiction" means the jurisdiction whose law governs the internal
8	affairs of an entity.
9	(7) (8) "Jurisdiction", used to refer to a political entity, means the United States, a state, a
10	foreign country, or a political subdivision of a foreign country.
11	(8) "Jurisdiction of formation" means the jurisdiction whose law governs the
12	internal affairs of an entity.
13	[Note to Drafting Committee: The UUOA currently use the term "jurisdiction of
14	formation" to refer to the jurisdiction whose law governs the internal affairs of an entity.
15	That term works well in most cases because the vast majority of entities remain governed
16	throughout their life by the law of the jurisdiction in which they are first formed. It is not
17	entirely correct, however, because the law governing the internal affairs of an entity may
18	change as the result of a fundamental transaction (merger, conversion, etc.) or because of
19	the operation of the organic law governing the entity's affairs (see the definition of
20	"partnership" below.
21	
22	To align more correctly the defined term and its substantive meaning, the Model
23	Nonprofit Corporation Act has switched to the term "governing jurisdiction," which avoids
24	the implied temporal aspect of the term jurisdiction of formation. At the previous meeting
25	of the Drafting Committee, the committee decided to consider adopting the term governing
26	jurisdiction. As part of its consideration of using the new term, the Drafting Committee will
27	need to consider not only the wording of the definition of the new term, but also how the
28	new term will mesh with the definitions of "jurisdiction" and "organic law."
29	These are ever 40 accurrences of "invisdiction of formation" in the Uniform
30	There are over 40 occurrences of "jurisdiction of formation" in the Uniform
31 32	Partnership Act. Making this change will thus require a lot of amendments. We can assume that a similar situation will be found in the other unincorporated entity acts. The Drafting
32 33	Committee needs to decide whether its final work product will be discrete amendments to
33 34	the UUOA or whether each of the UUOA should be restated in its entirety. There is a good
34 35	argument that the amendments being developed are already significant and detailed

1 2 3 4 5	enough to justify restating the acts. If that approach is taken, the Chair and Reporters recommend that the committee adopt the change to "governing jurisdiction." If the acts are not restated, the Committee should probably abandon the change to governing jurisdiction.]
6	(9) "Limited liability partnership" <del>, except in the phrase "foreign limited liability</del>
7	partnership" and in [Article] 11, or "domestic limited liability partnership" means a
8	partnership that has filed a statement of qualification under Section 901 and does not have a
9	similar statement in effect in any other jurisdiction.

11	(11) "Partnership"; or "domestic partnership" except in [Article] 11, means an
12	association of two or more persons to carry on as co-owners a business for profit <u>entity</u>
13	formed under this [act] or <b>that becomes subject to</b> whose internal affairs become governed by
14	this [act] under <u>Section 104 or 110 or</u> [Article] 11 or Section 110. The term includes terms
15	include a domestic limited liability partnership but not a foreign limited liability partnership.

17	(14) "Person" means an individual, business corporation, nonprofit corporation,
18	partnership, limited partnership, limited liability company, [general cooperative
19	association,] limited cooperative association, unincorporated nonprofit association,
20	statutory trust, business trust, common-law business trust, estate, trust, association, joint
21	venture, public corporation, business or nonprofit entity, government or governmental
22	subdivision, agency, or instrumentality, or any other legal or commercial entity, or any other
23	legal construct that is a person but not an entity under the law of this state. <sup>1</sup>

<sup>&</sup>lt;sup>1</sup> This definition has been amended to follow the recently approved revision of the definition of "person" in the ULC Drafting Rules and Style Manual. See Rule 304(3) in the Drafting Rules. The last clause has been added to the new definition so that protected series are included in the definition because a protected series is not an entity and thus would otherwise not be included. The same changes will be made to the definition of "person" in the other individual uniform entity laws. Addition of the final clause raises the question of whether the expanded definition is

3	<u>anything considered a person under other law that is described only in the new last clause of</u>

8	"Partnership" [(11)]—This definition, combined with Section 202(a), makes clear that a
9 10	general partnership is a <i>business</i> organization. This definition makes no reference to a partnership having partners upon formation, but Section 202(a) does.
11 12 13	Because a partnership is defined as "an entity that is formed under this [act] or the internal effeirs of which became governed by this [act] " references in this set to "a
14	<u>internal affairs of which become governed by this [act]," references in this act to "a</u> <u>partnership" mean a domestic partnership. The more complete term "domestic</u>
15	partnership" is used in several places in this act to highlight the scope of particular
16	provisions. Use of the term "domestic partnership" in those places is not intended to affect
17	the meaning of partnership when it appears elsewhere in the act.

21	<u>"Person" [14] – This term is the standard definition used in uniform acts generally,</u>
22	with the exception of the last clause which has been added so that protected series are

3	SECTION 801. EVENTS CAUSING DISSOLUTION. A partnership is dissolved,
4	and its business must be wound up, upon the occurrence of any of the following:
5	(1) in a partnership at will, the partnership knows or has notice of a person's express will
6	to withdraw as a partner, other than a <b>partner <u>person</u></b> that has dissociated <u>as a partner</u> under
7	Section 601(2) through (10), but, if the person has specified a withdrawal date later than the date
8	the partnership knew or had notice, on the later date;
9	* * *
10	(5) on application by a transferee, the entry by [the appropriate court] of an order
11	dissolving the partnership on the ground that it is equitable to wind up the partnership business:
12	* * *
13	(B) at any time, if the partnership was a partnership at will at the time of the
14	transfer or entry of the charging order that gave rise to the transfer; or
15	(6) the passage of 90 consecutive days during which the partnership does not have at
16	<del>least two partners</del> <u>has only one partner unless, before the end of the period, one or more</u>
17	persons are admitted as partners; or
18	(7) the passage of 90 consecutive days during which the partnership has no partners
19	unless, before the end of the period:
20	(A) consent to admit at least two specified persons as partners is given by
21	transferees owning the rights to receive a majority of distributions as transferees at the

2	SECTION 803. RESCINDING DISSOLUTION.
3	(a) A partnership may rescind its dissolution, unless a statement of termination applicable
4	to the partnership has become effective or [the appropriate court] has entered an order under
5	Section 801(4) or (5) dissolving the partnership.
6	(b) Rescinding dissolution under this section requires:
7	(1) if the dissolution occurred under Section 801(1), the affirmative vote or
8	consent of the person whose express will to withdraw as a partner caused the dissolution;
9	(2) if the dissolution occurred under Section 801(2) or (3), the affirmative vote
10	or consent of each partner;
11	(3) if the dissolution occurred under Section 801(4), the affirmative vote or
12	<u>consent of each partner;</u>
13	(4) if the dissolution occurred under Section 801(5), the affirmative vote or
14	consent of each partner and each applicant transferee;
15	(5) if the dissolution occurred under Section 801(6), the affirmative vote or
16	<u>consent of:</u>
17	(A) the remaining partner; and
18	(B) at least one person that becomes a partner after the dissolution;
19	(6) if the dissolution occurred under Section 801(7):
20	(A) consent to admit at least two specified persons as partners is given
21	by transferees owning the rights to receive a majority of distributions as transferees at the
22	time dissolution is to be effective; and
23	(B) at least two of the persons named in the consent are partners in

# accordance with the consent; and

2	(2) (7) if the partnership has delivered to the [Secretary of State] for filing a
3	statement of dissolution and:
4	(A) the statement has not become effective, delivery to the [Secretary of
5	State] for filing of a statement of withdrawal under Section 115 applicable to the statement of
6	dissolution; or
7	(B) the statement of dissolution has become effective, delivery to the
8	[Secretary of State] for filing of a statement of rescission stating the name of the partnership and
9	that dissolution has been rescinded under this section.
10	(c) If a partnership rescinds its dissolution:
11	(1) the partnership resumes carrying on its business as if dissolution had never
12	<u>not</u> occurred;
13	(2) subject to paragraph (3), <b>any</b> liability <b>incurred by the partnership</b> of a
14	person for an act occurring after the dissolution and before the rescission has become effective
15	is determined as if dissolution had never occurred; and
16	(3) the rights of a third party arising out of conduct in reliance on the dissolution
17	before the third party knew or had notice of the rescission may not be adversely affected.

3	SECTION 504. CHARGING ORDER.
4	(a) On application by a judgment creditor of to enforce a judgment against a partner or
5	<del>transferee</del> other holder of a transferable interest in a domestic partnership or foreign
6	partnership, a court may enter a charging order against the transferable interest of the judgment
7	debtor for the unsatisfied amount of the judgment. A charging order constitutes a lien on a
8	judgment debtor's transferable interest and requires the <b>domestic</b> partnership or foreign
9	partnership to pay over to the person to which the charging order was issued any distribution
10	that otherwise would be paid to the judgment debtor.
11	(b) To the extent necessary to effectuate the collection of distributions pursuant to a
12	charging order in effect under subsection (a), the court may:
13	(1) appoint a receiver of the distributions subject to the charging order, with the
14	power to make all inquiries the judgment debtor might have made; and
15	(2) make all other orders necessary to give effect to the charging order.
16	(c) Upon a showing <b>by a judgment creditor</b> that distributions under a charging order
17	will not pay the judgment debt within a reasonable time, the:
18	(1) The court may foreclose the lien and order the sale of the transferable interest
19	<u>in a domestic partnership</u> .
20	(2) The court may foreclose the lien and order the sale of the transferable
21	interest in a foreign partnership if the law of the jurisdiction of formation of the
22	partnership allows foreclosure. The foreclosure and sale must be conducted under the law
23	<u>of this state.</u>

1	(d) The purchaser at the foreclosure sale under subsection (c) obtains only the
2	transferable interest, does not thereby become a partner, and is subject to Section 503.
3	(d) (e) At any time before foreclosure completion of a sale under subsection (c), the
4	partner or transferee whose transferable interest is subject to a charging order under subsection
5	(a) may extinguish the charging order by satisfying the judgment and filing a certified copy of
6	the satisfaction with the court that issued the charging order.
7	(e) (f) At any time before foreclosure under subsection (c), a the domestic partnership
8	or foreign partnership or one or more partners whose transferable interests are not subject to the
9	charging order may pay to the judgment creditor the full amount due under the judgment and
10	thereby succeed to the rights of the judgment creditor, including the charging order.
11	(f) (g) This [act] does not deprive any partner or transferee of the benefit of any
12	exemption law applicable to the transferable interest of the partner or transferee.
13	(g) (h) This section provides the exclusive remedy by which a person seeking in the
14	capacity of a judgment creditor to enforce a judgment against a partner or transferee other
15	holder of a transferable interest in a domestic partnership or foreign partnership may
16	satisfy the judgment from the judgment debtor's transferable interest.

18 19 20 21 22 23 24 25	The charging order concept dates back to the English Partnership Act of 1890 and in the United States has been a fundamental part of law of unincorporated business organizations since 1914. See UPA (1914) § 28. As much a remedy limitation as a remedy, the charging order is the sole method by which a person acting as judgment creditor of a partner or <b>transferee other holder of a transferable interest in a domestic partnership or foreign partnership</b> can extract value from the partner's or <b>transferee's other person's</b> ownership interest in a partnership. See the comment to Subsection (g).
25 26 27 28 29	Under this section, the judgment creditor of a partner or <b>transferee</b> <u>other holder of a</u> <u>transferable interest in a domestic partnership or foreign partnership</u> is entitled to a charging order against the relevant transferable interest. While in effect, that order entitles the judgment creditor to whatever distributions would otherwise be due to the partner or <b>transferee</b>

- 1 <u>other person</u> whose interest is subject to the order. However, the judgment creditor has no say in 2 the timing or amount of those distributions. The charging order does not entitle the judgment 3 creditor to accelerate any distributions or to otherwise interfere with the management and 4 activities of the partnership.

6 By its terms, this section does not apply to applies to both domestic and foreign partnerships. Subsection (a)—The phrase "judgment debtor" encompasses both partners and
transferees other holders of a transferable interest. A charging order is available against
the holder of a transferable interest regardless of whether the holder received the
transferable interest in a transfer. For example, if a person is dissociated as a partner, the
person may continue to hold a transferable interest and that interest will be available to
satisfy the claim of a judgment creditor of the person dissociated as a partner.

- The lien <u>of a charging order</u> pertains only to a distribution, which excludes "amounts constituting reasonable compensation for present or past service or payments made in the ordinary course of business under a bona fide retirement plan or other bona fide benefits program "Section 102(4)(P). #### SECTION 503. CHARGING ORDER.

2	(a) On application by a judgment creditor of a member or transferee in a domestic
3	limited liability company or foreign limited liability company, a court may enter a charging
4	order against the transferable interest of the judgment debtor for the unsatisfied amount of the

7	liability company or foreign limited liability company or one or more members whose

10	including the charging order.

6 7	By its terms, this section <b>does not apply to applies to both domestic and</b> foreign
8	limited liability companies. See Section 102(8) (defining "[l]imited liability company" to mean "an entity formed under this [act] or which becomes subject to this [act]") (emphasis
9	added); see also "Limited liability company" is defined in Section 102(8) to mean "an entity

42	permits foreclosure, a foreclosure proceeding may be brought under the [act] as provided
43	in subsection (c)(2). The rule in subsection (d) that a purchaser acquires only a transferable
44	interest in a foreclosure sale does not apply in the case of a single member foreign limited
45	liability company because subsection (d) defers to the rule in subsection (f) in that case.

22 23 24 25	<u>Subsection (c) – Some states use different terms to refer to the types of transactions</u> <u>authorized in this article. For example, Delaware uses the terms "transfer" and</u> <u>"continuance," as well as the term "domestication" to refer to a transaction in which a</u> <u>Delaware limited liability company becomes a limited liability company under the law of a</u>

1	foreign country. 6 Del. Code § 18-213. Similarly, Delaware uses the term "conversion" to
2	refer to a transaction in which a Delaware limited liability company becomes a limited
3	liability company under the law of another state. 6 Del. Code § 18-216. Those transactions
4	under Delaware law would all be considered a "domestication" under Part 5.

23 24	Subsection $(b)(1)(C)$ – This act does not specify what constitutes "a company opportunity," but ample case law exists. See, e.g., Ebenezer United Methodist Church v.

1 2	Riverwalk Development Phase, II, LLC, 45 A.3d 883, 887 (Md. App. 2012) (discussing the "interest or reasonable expectancy test"); In re McCook Metals, L.L.C., 319 B.R. 570, 596

21	indemnified under subsection (c).
22	(e) A partnership may purchase and maintain insurance on behalf of a partner against
23	liability asserted against or incurred by the partner in that capacity or arising from that status

1	even if, under Section 105(c)(7), the partnership agreement could not eliminate or limit the
2	person's liability to the partnership for the conduct giving rise to the liability.
3	(f) A partnership shall reimburse a partner for an advance to the partnership beyond the
4	amount of capital the partner agreed to contribute.
5	(g) A payment or advance made by a partner which gives rise to a partnership obligation
6	under subsection (b) or (f) constitutes a loan to the partnership which accrues interest from the
7	date of the payment or advance.
8	SECTION 405. SHARING OF AND RIGHT TO DISTRIBUTIONS BEFORE
9	DISSOLUTION.
10	(a) Any distribution made by a partnership before its dissolution and winding up must be
11	in equal shares among partners, except to the extent necessary to comply with a transfer effective
12	under Section 503 or charging order in effect under Section 504.
13	(b) Subject to Section 701, a person has a right to a distribution before the dissolution and
14	winding up of a partnership only if the partnership decides to make an interim distribution.
15	(c) A person does not have a right to demand or receive a distribution from a partnership
16	in any form other than money. Except as otherwise provided in Section 806, a partnership may
17	distribute an asset in kind only if each part of the asset is fungible with each other part and each
18	person receives a percentage of the asset equal in value to the person's share of distributions.
19	(d) If a partner or transferee becomes entitled to receive a distribution, the partner or
20	transferee has the status of, and is entitled to all remedies available to, a creditor of the
21	partnership with respect to the distribution. However, the partnership's obligation to make a
22	distribution is subject to offset for any amount owed to the partnership by the partner or a person
23	dissociated as partner on whose account the distribution is made.

# SECTION 806. DISPOSITION OF ASSETS IN WINDING UP; WHEN

2 **CONTRIBUTIONS REQUIRED.** 3 (a) In winding up its business, a partnership shall apply its assets, including the 4 contributions required by this section, to discharge the partnership's obligations to creditors, 5 including partners that are creditors. 6 (b) After a partnership complies with subsection (a), any surplus must be distributed in 7 the following order, subject to any charging order in effect under Section 504: 8 (1) to each person owning a transferable interest that reflects contributions made 9 and not previously returned an amount equal to the value at the time of contribution of the 10 unreturned contributions; and 11 (2) among persons owning transferable interests in proportion to their respective 12 rights to share in distributions immediately before the dissolution of the partnership. 13 (c) If a partnership's assets are insufficient to satisfy all its obligations under subsection 14 (a), with respect to each unsatisfied obligation incurred when the partnership was not a limited 15 liability partnership, the following rules apply: 16 (1) Each person that was a partner when the obligation was incurred and that has 17 not been released from the obligation under Section 703(c) and or (d) shall contribute to the 18 partnership for the purpose of enabling the partnership to satisfy the obligation. The contribution

due from each of those persons is in proportion to the right to receive distributions in thecapacity of a partner in effect for each of those persons when the obligation was incurred.

(2) If a person does not contribute the full amount required under paragraph (1)
with respect to an unsatisfied obligation of the partnership, the other persons required to
contribute by paragraph (1) on account of the obligation shall contribute the additional amount

necessary to discharge the obligation. The additional contribution due from each of those other
 persons is in proportion to the right to receive distributions in the capacity of a partner in effect
 for each of those other persons when the obligation was incurred.

The requirements stated in this subsection (a) are mandatory. 7 8 Subsection (a)(1) – Subsection (a)(1) requires that the plan of merger identify the 9 merging entities parties to the merger. Section 102(24) defines a merging entity as "an 10 entity that is a party to a merger and exists immediately before the merger becomes effective." The name of a merging entity as it appears in the plan of merger will be its name in 11 12 its jurisdiction of formation. See the comment to Section 205(b)(1) and (2). 13 14 Subsection (a)(2) – Separately from the identification of the merging entities in 15 subsection (1)(1), the plan of merger is also required by subsection (a)(2) to identify the 16 surviving entity.
