3	[ARTICLE] 1
4	GENERAL PROVISIONS
5	
6	SECTION 101. DEFINITIONS. In this [Act] [act]:
7	(1) "Business" includes every trade, occupation, and profession.
8	(2) "Contribution", except in the phrase "right of contribution," means any benefit
9	provided by a person to partnership in order to become a partner or in the person's capacity as a
10	partner;
11	(2) (3) "Debtor in bankruptcy" means a person who is the subject of:
12	(i) (A) an order for relief under Title 11 of the United States Code or a comparable
13	order under a successor statute of general application; or
14	(ii) (B) a comparable order under federal, state, or foreign law governing
15	insolvency.
16	(3) (4) "Distribution", except in Section 402A(b), means a transfer of money or other
17	property from a partnership to a partner in the partner's capacity as a partner or to the partner's-
18	transferee a person because of a transferable interest or in the person's capacity as a partner. The
19	term includes:
20	(A) a redemption or other purchase by a partnership of a transferable interest; and
21	(B) a transfer to a partner in return for the partner's relinquishment of any right to
22	participate as a partner in the management or conduct of the partnership's business or to have
23	access to records or other information concerning the partnership's business.

1	(4) (5) "Foreign limited liability partnership" means a partnership that: (i) is formed
2	under laws other than the laws of this State the law of a jurisdiction other than this state and (ii)
3	has the status of denominated by that law as a limited liability partnership-under those laws.
4	(5) (6) "Limited liability partnership" means a partnership that has filed a statement of
5	qualification under Section 1001 and does not have a similar statement in effect in any other
6	jurisdiction.
7	(7) "Partner" means a person that has become a partner of a partnership under Section
8	202 and has not dissociated under Section 601.
9	(6) (8) "Partnership" means an association of two or more persons to carry on as co-
10	owners a business for profit formed under Section 202, predecessor law, or comparable law of
11	another jurisdiction.
12	(7) (9) "Partnership agreement" means the agreement, whether written, oral, or implied,
13	among the partners concerning the partnership, including amendments to the partnership
14	agreement or not referred to as a partnership agreement and whether oral, in a record, implied, or
15	in any combination thereof, of all the partners of a partnership concerning the matters described
16	in Section 103(a). The term includes the agreement as amended or restated.
17	(8) (10) "Partnership at will" means a partnership in which the partners have not agreed
18	to remain partners until the expiration of a definite term or the completion of a particular
19	undertaking.
20	(9) "Partnership interest" or "partner's interest in the partnership" means all of a
21	partner's interests in the partnership, including the partner's transferable interest and all-
22	management and other rights.
23	(10) (11) "Person" means an individual, corporation, business trust, estate, trust,

1	partnership, association, joint venture, government, governmental subdivision, agency, or
2	instrumentality, or any other legal or commercial entity "Person" means an individual, business
3	corporation, nonprofit corporation, partnership, limited partnership, limited liability company,
4	[general cooperative association,] limited cooperative association, unincorporated nonprofit trust
5	association, statutory trust, business trust, or common-law business trust, estate, trust,
6	association, joint venture, public corporation, government or governmental subdivision, agency,
7	or instrumentality, or any other legal or commercial entity.
8	(12) "Principal office" means the principal executive office of a partnership or a foreign
9	limited liability partnership, whether or not the office is located in this state.
10	(11) (13) "Property" means all property, whether real, personal, or mixed, or tangible or
11	intangible, or any interest therein.
12	(14) "Record", used as a noun, means information that is inscribed on a tangible medium
13	or that is stored in an electronic or other medium and is retrievable in perceivable form.
14	(15) "Sign" means, with the present intent to authenticate or adopt a record:
15	(A) to execute or adopt a tangible symbol; or
16	(B) to attach to or logically associate with the record an electronic symbol,
17	sound, or process.
18	(12) (16) "State" means a State state of the United States, the District of Columbia, the-
19	Commonwealth of Puerto Rico, the United States Virgin Islands, or any territory or insular
20	possession subject to the jurisdiction of the United States.
21	(13) (17) "Statement" means a statement of partnership authority under Section 303, a
22	statement of denial under Section 304, a statement of dissociation under Section 704, a statement
23	of dissolution under Section 805, a statement of merger under Section 907, a statement of

qualification under Section 1001, a statement of foreign qualification under Section 1102, or an
 amendment or cancellation of any of the foregoing.

3 (14) (18) "Transfer" includes an assignment, conveyance, lease, mortgage, deed, 4 encumbrance to assign, convey, sell, lease, encumber including by mortgaging or granting a 5 security interest, make a gift, and transfer by operation of law. 6 (19) "Transferable interest" means the right, as initially owned by a person in the 7 person's capacity as a partner, to receive distributions from a partnership in accordance with the 8 partnership agreement. The term applies, whether or not the person remains a partner or 9 continues to own any part of the right and includes any fraction of the right. 10 (20) "Transferee" means a person to which all or part of a transferable interest has been 11 transferred, whether or not the transferor is a partner. 12 **Reporters'** Note 13 14 Section 101(2) defines "contribution" to harmonize with ULPA Section 102(2) and RULLCA Section 102(2). 6	(b) A limited liability partnership continues to be the same entity that existed before the
7	filing of a statement of qualification under Section 1001.
8	SECTION 202. FORMATION OF PARTNERSHIP.
9	(a) Except as otherwise provided in subsection (b), the association of two or more
10	persons to carry on as co-owners a business for profit forms a partnership, whether or not the
11	persons intend to form a partnership.
12	(b) An association formed under a statute other than this [Act] [act], a predecessor statute,
13	or a comparable statute of another jurisdiction is not a partnership under this [Act] [act].
14	(c) In determining whether a partnership is formed, the following rules apply:
15	(1) Joint tenancy, tenancy in common, tenancy by the entireties, joint property,

7	of the collateral, or rights to income, proceeds, or increase in value derived from the collateral; or
8	(vi) (F) for the sale of the good will of a business or other property by
9	installments or otherwise.
10	SECTION 203. PARTNERSHIP PROPERTY. Property acquired by a partnership is
11	property of the partnership and not of the partners individually.
12	SECTION 204. WHEN PROPERTY IS PARTNERSHIP PROPERTY.
13	(a) Property is partnership property if acquired in the name of:
14	(1) the partnership; or
15	(2) one or more partners with an indication in the instrument transferring title to
16	the property of the person's capacity as a partner or of the existence of a partnership but without
17	an indication of the name of the partnership.
18	(b) Property is acquired in the name of the partnership by a transfer to:

18	partnership property held in the name of the partnership may be transferred by an instrument of
19	transfer executed by a partner in the partnership name.
20	(2) Partnership property held in the name of one or more partners with an
21	indication in the instrument transferring the property to them of their capacity as partners or of
22	the existence of a partnership, but without an indication of the name of the partnership, may be
23	transferred by an instrument of transfer executed by the persons in whose name the property is
24	held.

1	(3) Partnership property held in the name of one or more persons other than the
2	partnership, without an indication in the instrument transferring the property to them of their
3	capacity as partners or of the existence of a partnership, may be transferred by an instrument of
4	transfer executed by the persons in whose name the property is held.
5	(b) A partnership may recover partnership property from a transferee only if it proves that
6	execution of the instrument of initial transfer did not bind the partnership under Section 301 and:
7	(1) as to a subsequent transferee who gave value for property transferred under
8	subsection (a)(1) and (2), proves that the subsequent transferee knew or had received a
9	notification that the person who executed the instrument of initial transfer lacked authority to
10	bind the partnership; or
11	(2) as to a transferee who gave value for property transferred under subsection
12	(a)(3), proves that the transferee knew or had received a notification that the property was
13	partnership property and that the person who executed the instrument of initial transfer lacked
14	authority to bind the partnership.
15	(c) A partnership may not recover partnership property from a subsequent transferee if the
16	partnership would not have been entitled to recover the property, under subsection (b), from any
17	earlier transferee of the property.
18	(d) If a person holds all of the partners' interests in the partnership, all of the partnership
19	property vests in that person. The person may execute a document in the name of the partnership
20	to evidence vesting of the property in that person and may file or record the document.

(d) A person does not continue to be liable as a partner merely because of a failure to file

19	incurred by the partner in the course of the partner's activities on behalf of the partnership, if the
20	partner complied with the duties stated in Sections 403 and 405 in making the payment or
21	incurring the debt, obligation, or liability.
22	(c) A partnership shall indemnify and hold harmless a partner with respect to any claim or
23	demand against the person by reason of the person's former or present capacity as partner, if the
24	claim or demand does not arise from the person's breach of a duty stated in Section 403 or 405.

1	(d) As a activity in the ordinary course of its activities, a partnership may advance
2	expenses, including reasonable attorney's fees and costs, incurred by a partner in connection with
3	a claim or demand against the person by reason of the person's former or present capacity as a
4	partner, upon an undertaking by the person to repay the partnership if the person ultimately is
5	determined not to be entitled to be indemnified under subsection (b).
6	(d) (e) A partnership shall reimburse a partner for an advance to the partnership beyond
7	the amount of capital the partner agreed to contribute.
8	(e) (f) A payment or advance made by a partner which gives rise to a partnership
9	obligation under subsection (c) or (d) subsections (b), (c), (d) or (e) constitutes a loan to the
10	partnership which accrues interest from the date of the payment or advance.
11	(f) (g) Each partner has equal rights in the management and conduct of the partnership
12	business.
13	(g) (h) A partner may use or possess partnership property only on behalf of the
14	partnership.
15	(h) (i) A partner is not entitled to remuneration for services performed for the partnership,
16	except for reasonable compensation for services rendered in winding up the business of the
17	partnership.
18	(i) (j) A person may become a partner only with the consent of all of the partners.
19	(j) (k) A difference arising as to a matter in the ordinary course of business of a
20	partnership may be decided by a majority of the partners. An act outside the ordinary course of
21	business of a partnership, and an amendment to the partnership agreement, and the approval of a
22	merger, conversion, or domestication may be undertaken only with the consent of all of the
23	partners.

22	practices and principles that are reasonable in the circumstances or on a fair valuation or other
23	method that is reasonable under the circumstances.
24	(d) The effect of a distribution under subsection (b) is measured:
25	(1) in the case of a distribution of indebtedness:

(A) as of the date the indebtedness is distributed; and again
(B) as of the date each payment of principal or interest is made with each
payment treated as a distribution; and
(2) in all other cases, as of the date:
(A) the distribution is authorized, if the payment occurs not later than 120
days after that date; or
(B) the payment is made, if the payment occurs more than 120 days after
the distribution is authorized.
(e) A limited liability partnership's indebtedness, including indebtedness issued in
connection with or as part of a distribution, is not a liability for purposes of subsection (b) if the
terms of the indebtedness provide that payment of principal and interest are made only to the
extent that a distribution could be made under this section.
(f) A limited liability partnership's indebtedness incurred by reason of a distribution
made in accordance with this section has the same priority as the partnership's indebtedness to
its general, unsecured creditors except to the extent subordinated by agreement.
(g) This section does not apply to distributions under Section 807.
Reporters' Note
Section 405 is new. Prior to the LLP amendments to RUPA, a distributions liability rule was not necessary because all partners were liable for all partnership obligations. When the limited liability partnership amendments were added in 1997, the drafting committee considered the matter but in the interest of simplicity preferred to allow fraudulent transfer and conveyance law to solve the problem. Section 405 now conforms to RULLCA Section 405 to make a partner of a limited liability partnership subject to the same liability rules applicable to other entity forms with a liability shield. The phrase "limited liability partnership" is repeated even within a subsection to clarify this section only applies to an LLP and not to a general partnership. For partnerships in transition, the limitation will only apply when a distribution occurred while the entity was a limited liability partnership. Section 405(b)(2) conforms to RULLCA Section 405(2) but without the concept of termination. Section 405 does not apply to distributions made in winding up a limited liability partnership.

17	the interest in distributions transferred and retains all duties and obligations of a member.

11	partner or transferee whose transferable interest is subject to a charging order under subsection
12	(a) may extinguish the charging order by satisfying the judgment and filing a certified copy of
13	the satisfaction with the court that issued the charging order.
14	(e) This section provides the exclusive remedy by which a judgment creditor of a partner-
15	or partner's transferee may satisfy a judgment out of the judgment debtor's transferable interest
16	in the partnership. At any time before foreclosure under subsection (c), a partnership or one or
17	more partners whose transferable interests are not subject to the charging order may pay to the
18	judgment creditor the full amount due under the judgment and thereby succeed to the rights of
19	the judgment creditor, including the charging order.
20	(f) This [act] does not deprive any partner or transferee of the benefit of any exemption
21	law applicable to the transferable interest of the partner or transferee.
22	(g) This section provides the exclusive remedy by which a person seeking to enforce a

19	(ii) (B) there has been a transfer of all or substantially all of that the partner's
20	transferable interest in the partnership, other than:
21	(i) a transfer for security purposes; or
22	(ii) a court order charging the partner's interest charging order in effect
23	under Section 504 which has not been foreclosed;

1	(iii) within 90 days after the partnership notifies a corporate partner that it
2	will be expelled because it has filed a certificate of dissolution or the equivalent, its charter has-
3	been revoked, or its right to conduct business has been suspended by the jurisdiction of its-
4	incorporation, there is no revocation of the certificate of dissolution or no reinstatement of its-
5	charter or its right to conduct business; or the person is a corporation and, within 90 days after
6	the partnership notifies the person that it will be expelled as a member because the person has
7	filed a certificate of dissolution or the equivalent, its charter has been revoked, or its right to
8	conduct business has been suspended by the jurisdiction of its incorporation, the certificate of
9	dissolution has not been revoked or its charter or right to conduct business has not been
10	reinstated; or
11	(iv) the person is a limited liability company or a partnership that is a
12	partner has been dissolved and its whose business is being wound up;
13	(5) on application by the partnership-or another partner, the partner's expulsion, the
14	person is expelled as a partner by judicial determination order because the person:
15	(i) (A) the partner has engaged or is engaging in wrongful conduct that has
16	adversely and materially affected, or will affect, the partnership business;
17	(ii) (B) the partner has willfully or persistently committed, or is willfully and
18	persistently committing, a material breach of the partnership agreement or of a duty the person's
19	duties or obligations owed to the partnership or the other partners-under Section 404 408; or
20	(iiii) (C) the partner has engaged, or is engaging, in conduct relating to the
21	partnership partnership's business which makes it not reasonably practicable to carry on the
22	partnership with the partner business with the person as a partner;
23	(6) the partner's:

1	(i) (A) becoming a debtor in bankruptcy;
2	(ii) (B) executing an assignment for the benefit of creditors;
3	(iii) (C) seeking, consenting to, or acquiescing in the appointment of a trustee,
4	receiver, or liquidator of that partner or of all or substantially all of that partner's property; or
5	(iv) (D) failing, within 90 days after the appointment, to have vacated or stayed
6	the appointment of a trustee, receiver, or liquidator of the partner or of all or substantially all of
7	the partner's property obtained without the partner's consent or acquiescence, or failing within
8	90 days after the expiration of a stay to have the appointment vacated;
9	(7) in the case of a partner who is an individual:
10	(i) (A) the partner's death;
11	(ii) (B) the appointment of a guardian or general conservator for the partner is
12	appointed; or
13	(iii) (C) there is a judicial determination that the partner has otherwise become
14	incapable of performing the partner's duties under this [act] or the partnership agreement;
15	(8) in the case of a partner that is a trust or is acting as a partner by virtue of being a
16	trustee of a trust, the trust's distribution of the trust's entire transferable interest is distributed; in
17	the partnership; but not merely by reason of the substitution of a successor trustee;
18	(9) in the case of a partner that is an estate or is acting as a partner by virtue of being a
19	personal representative of an estate, distribution of the estate's entire transferable interest in the
20	partnership is distributed; but not merely by reason of the substitution of a successor personal-
21	representative; or
22	(10) termination in the case of a partner that is not an individual, partnership, limited
23	liability company, corporation, trust, or estate, the termination of the partner;

1	(11) the partnership participates in a merger under [Article] 9, if:
2	(A) the partnership is not the surviving entity, or
3	(B) otherwise as a result of the merger, the person ceases to be a partner;
4	(12) the partnership participates in a conversion under [Article] 9; or
5	(13) the partnership participates in a domestication under [Article] 9, if, as a result of the
6	domestication, the person ceases to be a partner.

3	(iii) (C) the partner person is dissociated as a partner by becoming a debtor
4	in bankruptcy; or
5	(iv) (D) in the case of a partner who person that is not an individual, a trust
6	other than a business trust, or <u>an</u> estate, <u>or an individual</u> , the partner <u>person</u> is expelled <u>as a</u>
7	partner or otherwise dissociated because it willfully dissolved or terminated.
8	(c) A partner who that wrongfully dissociates as a partner is liable to the partnership and
9	to the other partners for damages caused by the dissociation. The liability is in addition to any
10	other <u>debt</u> , obligation, <u>or other liability</u> of the partner to the partnership or to the other partners.

Interest must be paid from the date the amount owed becomes 18 due to the date of payment. 19 (d) A partnership shall indemnify a dissociated partner person whose interest is being 20 purchased against all partnership liabilities, whether incurred before or after the dissociation, 21 except liabilities incurred by an act of the dissociated partner under Section 702. 22 (e) If no agreement for the purchase of a dissociated partner's person's interest is reached 23 within 120 days after a written demand for payment, the partnership shall pay, or cause to be 24 paid, in cash to the dissociated partner person the amount the partnership estimates to be the

buyout price and accrued interest, reduced by any offsets and accrued interest under subsection
 (c).

3	(f) If a deferred payment is authorized under subsection (h), the partnership may tender a
4	written offer to pay the amount it estimates to be the buyout price and accrued interest, reduced
5	by any offsets under subsection (c), stating the time of payment, the amount and type of security
6	for payment, and the other terms and conditions of the obligation.
7	(g) The payment or tender required by subsection (e) or (f) must be accompanied by the
8	following:
9	(1) a statement of partnership assets and liabilities as of the date of dissociation;
10	(2) the latest available partnership balance sheet and income statement, if any;
11	(3) an explanation of how the estimated amount of the payment was calculated;
12	and
13	(4) written notice that the payment is in full satisfaction of the obligation to
14	purchase unless, within 120 days after the written notice, the dissociated partner person
15	commences an action to determine the buyout price, any offsets under subsection (c), or other
16	terms of the obligation to purchase.
17	(h) A partner person who wrongfully dissociates before the expiration of a definite term
18	or the completion of a particular undertaking is not entitled to payment of any portion of the
19	buyout price until the expiration of the term or completion of the undertaking, unless the partner
20	person establishes to the satisfaction of the court that earlier payment will not cause undue
21	hardship to the business of the partnership. A deferred payment must be adequately secured and
22	bear interest.

23

(i) A dissociated partner person may maintain an action against the partnership, pursuant

1 to Section $\frac{405(b)(2)(ii)}{408(b)(2)(ii)}$, to determine the buyout price of that partner's person's 2 interest, any offsets under subsection (c), or other terms of the obligation to purchase. The action 3 must be commenced within 120 days after the partnership has tendered payment or an offer to 4 pay or within one year after written demand for payment if no payment or offer to pay is 5 tendered. The court shall determine the buyout price of the dissociated partner's person's interest, 6 any offset due under subsection (c), and accrued interest, and enter judgment for any additional 7 payment or refund. If deferred payment is authorized under subsection (h), the court shall also 8 determine the security for payment and other terms of the obligation to purchase. The court may 9 assess reasonable attorney's fees and the fees and expenses of appraisers or other experts for a 10 party to the action, in amounts the court finds equitable, against a party that the court finds acted 11 arbitrarily, vexatiously, or not in good faith. The finding may be based on the partnership's 12 failure to tender payment or an offer to pay or to comply with subsection (g).

13 SECTION 702. DISSOCIATED PARTNER'S POWER TO BIND AND LIABILITY 14 TO PARTNERSHIP.

(a) For two years after a partner person dissociates without resulting in a dissolution and
winding up of the partnership business, the partnership, including a surviving partnership under
[Article] 9, is bound by an act of the dissociated partner person which would have bound the
partnership under Section 301 before dissociation only if at the time of entering into the
transaction the other party:

(1) reasonably believed that the dissociated partner person was then a partner;
(2) did not have notice of the partner's person's dissociation; and
(3) is not deemed to have had knowledge under Section 303(e) or notice under

23 Section 704(c).

- (b) A dissociated partner person is liable to the partnership for any damage caused
 to the partnership arising from an obligation incurred by the dissociated partner after dissociation
 for which the partnership is liable under subsection (a).

SECTION 703. DISSOCIATED PARTNER'S LIABILITY TO OTHER PERSONS.

(a) A partner's person's dissociation does not of itself discharge the partner's person's
liability for a partnership obligation incurred before dissociation. A dissociated partner person is
not liable for a partnership obligation incurred after dissociation, except as otherwise provided in
subsection (b).

9 (b) A partner person who dissociates without resulting in a dissolution and winding up of 10 the partnership business is liable as a partner person to the other party in a transaction entered 11 into by the partnership, or a surviving partnership under [Article] 9, within two years after the 12 partner's person's dissociation, only if the partner person is liable for the obligation under 13 Section 306 and at the time of entering into the transaction the other party: 14 (1) reasonably believed that the dissociated partner person was then a partner; 15 (2) did not have notice of the partner's person's dissociation; and 16 (3) is not deemed to have had knowledge under Section 303(e) or notice under

17 Section 704(c).

(c) By agreement with the partnership creditor and the partners continuing the business, a
 dissociated partner person may be released from liability for a partnership obligation.

(d) A dissociated partner person is released from liability for a partnership obligation if a
 partnership creditor, with notice of the partner's person's dissociation but without the partner's
 person's consent, agrees to a material alteration in the nature or time of payment of a partnership
 obligation.

SECTION 704. STATEMENT OF DISSOCIATION.

2 (a) A dissociated partner person or the partnership may file a statement of dissociation
3 stating the name of the partnership and that the partner person is dissociated from the
4 partnership.

5 (b) A statement of dissociation is a limitation on the authority of a dissociated partner
6 person for the purposes of Section 303(d) and (e).

7 (c) For the purposes of Sections 702(a)(3) and 703(b)(3), a person not a partner person is
8 deemed to have notice of the dissociation 90 days after the statement of dissociation is filed.

9 SECTION 705. CONTINUED USE OF PARTNERSHIP NAME. Continued use of a 10 partnership name, or a dissociated partner's person's name as part thereof, by partners continuing 11 the business does not of itself make the dissociated partner person liable for an obligation of the 12 partners or the partnership continuing the business.

3 4	SECTION 801. EVENTS CAUSING DISSOLUTION AND WINDING UP OF
5	PARTNERSHIP BUSINESS. A partnership is dissolved, and its business-must be wound up,

7	(1) in a partnership at will, the partnership's having notice from a partner, other than a

16	the express will consent of at least half of the remaining partners to wind up the partnership
17	business, for which purpose a partner's rightful dissociation pursuant to Section 602(b)(2)(i)
18	constitutes the expression of that partner's will to wind up the partnership business;
19	(ii) (B) the express will consent of all of the partners to wind up the partnership
20	business; or
21	$\frac{(iii)}{(C)}$ the expiration of the term or the completion of the undertaking;
22	(3) an event agreed to in or circumstance that the partnership agreement resulting in the
23	winding up of the partnership business states causes the dissolution;
24	(4) an event that makes it unlawful for all or substantially all of the business of the

1	partnership to be continued, but a cure of illegality within 90 days after notice to the partnership
2	of the event is effective retroactively to the date of the event for purposes of this section;
3	(5) on application by a partner, a judicial determination that:
4	(i) (A) the economic purpose of the partnership is likely to be unreasonably
5	frustrated;
6	(ii) (B) another partner has engaged in conduct relating to the partnership business
7	which makes it not reasonably practicable to carry on the business in partnership with that
8	partner; or
9	$\frac{(iii)}{(C)}$ it is not otherwise reasonably practicable to carry on the partnership
10	business in conformity with the partnership agreement; or
11	(6) on application by a transferee of a partner's person's transferable interest, a judicial
12	determination that it is equitable to wind up the partnership business:
13	(i) (A) after the expiration of the term or completion of the undertaking, if the
14	partnership was for a definite term or particular undertaking at the time of the transfer or entry of
15	the charging order that gave rise to the transfer; or
16	(ii) (B) at any time, if the partnership was a partnership at will at the time of the
17	transfer or entry of the charging order that gave rise to the transfer.

19 20 21 22 23 24	Section 801 conformed to RULLCA Article 7, when possible. Under RULLCA, dissociation of a member no longer threatens entity dissolution but the concept remains relevant to RUPA because of the RUPA Article 7 purchase on dissociation without dissolution. Unlike RULLCA, Section 801(5) does not state oppression as cause for judicial dissolution.

SECTION 802. PARTNERSHIP CONTINUES AFTER DISSOLUTION WINDING

2 <u>UP</u>.

3 (a) Subject to subsection (b), a partnership continues after dissolution only for the
4 purpose of winding up its business. The partnership is terminated when the winding up of its
5 business is completed.

(b) At any time after the dissolution of a partnership and before the winding up of its
business is completed, all of the partners, including any dissociating partner person other than a
wrongfully dissociating partner person, may waive the right to have the partnership's business
wound up and the partnership terminated. In that event:

(1) the partnership resumes carrying on its business as if dissolution had never
occurred, and any liability incurred by the partnership or a partner person after the dissolution
and before the waiver is determined as if dissolution had never occurred; and

- (2) the rights of a third party accruing under Section 804(1) or arising out of
 conduct in reliance on the dissolution before the third party knew or received a notification of the
 waiver may not be adversely affected.

SECTION 803. RIGHT TO WIND UP PARTNERSHIP BUSINESS.

(a) After dissolution, a partner person who has not wrongfully dissociated may participate
in winding up the partnership's business, but on application of any partner, partner's legal
representative, or transferee, the [designate the appropriate court], for good cause shown, may
order judicial supervision of the winding up.

(b) The legal representative of the last surviving partner may wind up a partnership's
business.

(c) A person winding up a partnership's business may preserve the partnership business or

1	property as a going concern for a reasonable time, prosecute and defend actions and proceedings,
2	whether civil, criminal, or administrative, settle and close the partnership's business, dispose of
3	and transfer the partnership's property, discharge the partnership's liabilities, distribute the assets

6	SECTION 804. PARTNER'S POWER TO BIND PARTNERSHIP AFTER
7	DISSOLUTION. Subject to Section 805, a partnership is bound by a partner's person's act after
8	dissolution that:
9	(1) is appropriate for winding up the partnership business; or
10	(2) would have bound the partnership under Section 301 before dissolution, if the other
11	party to the transaction did not have notice of the dissolution.
12	SECTION 805. STATEMENT OF DISSOLUTION.
13	(a) After dissolution, a partner person who has not wrongfully dissociated as a partner
14	may file deliver to the [Secretary of State] for filing a statement of dissolution stating the name
15	of the partnership and that the partnership has dissolved and is winding up its business.
16	(b) A statement of dissolution cancels a filed statement of partnership authority for the
17	purposes of Section 303(d) and is a limitation on authority for the purposes of Section 303(e).
18	(c) For the purposes of Sections 301 and 804, a person not a partner is deemed to have
19	notice of the dissolution and the limitation on the partners' authority as a result of the statement
20	of dissolution 90 days after it is filed.
21	(d) After the filing and, if appropriate, recording a statement of dissolution, a dissolved
22	partnership may file deliver to the [Secretary of State] for filing and, if appropriate, record a
23	statement of partnership authority which will operate with respect to a person not a partner as

1	provided in Section 303(d) and (e) in any transaction, whether or not the transaction is
2	appropriate for winding up the partnership business.
3	SECTION 806. PARTNER'S LIABILITY TO OTHER PARTNERS AFTER
4	DISSOLUTION.
5	(a) Except as otherwise provided in subsection (b) and Section 306, after dissolution a
6	partner person is liable to the other partners for the partner's person's share of any partnership
7	liability incurred under Section 804.
8	(b) A partner person who, with knowledge of the dissolution, incurs a partnership liability
9	under Section 804(2) by an act that is not appropriate for winding up the partnership business is
10	liable to the partnership for any damage caused to the partnership arising from the liability.

16	SECTION 807. SETTLEMENT OF ACCOUNTS AND CONTRIBUTIONS
17	AMONG PARTNERS.
18	(a) In winding up a partnership's business, the assets of the partnership, including the
19	contributions of the partners required by this section, must be applied to discharge its obligations-
20	to creditors, including, to the extent permitted by law, partners who are creditors. Any surplus-
21	must be applied to pay in cash the net amount distributable to partners in accordance with their-
22	right to distributions under subsection (b). In winding up its business, a partnership shall
23	discharge the partnership's debts, obligations, or other liabilities, settle and close the
24	partnership's business, and marshal and distribute the assets of the partnership.
25	(b) Each partner is entitled to a settlement of all partnership accounts upon winding up-

1	the partnership business. In settling accounts among the partners, profits and losses that result
2	from the liquidation of the partnership assets must be credited and charged to the partners'

4	of the credits over the charges in the partner's account. A partner shall contribute to the
5	partnership an amount equal to any excess of the charges over the credits in the partner's account
6	but excluding from the calculation charges attributable to an obligation for which the partner is
7	not personally liable under Section 306. If partnership assets are not adequate to satisfy
8	partnership debts, obligations or other liabilities, each person shall contribute to the partnership
9	an equal share of the excess excluding from the calculation charges attributable to an obligation
10	for which the person is not personally liable under Section 306.
11	(c) If a partner person fails to contribute the full amount required under subsection (b), all
12	of the other partners shall contribute, in the proportions in which those partners share partnership
13	losses, the additional amount necessary to satisfy the partnership obligations for which they are
14	personally liable under Section 306. A partner person or partner's person's legal representative
15	may recover from the other partners any contributions the partner person makes to the extent the
16	amount contributed exceeds that partner's person's share of the partnership obligations for which
17	the partner person is personally liable under Section 306.
18	(d) After the settlement of accounts, each partner shall contribute, in the proportion in-
19	which the partner shares partnership losses, the amount necessary to satisfy partnership
20	obligations that were not known at the time of the settlement and for which the partner is-
21	personally liable under Section 306.
22	(e) (d) The estate of a deceased partner person is liable for the partner's person's
23	obligation to contribute to the partnership.

1	(f) (e) An assignee for the benefit of creditors of a partnership or a partner person, or a
2	person appointed by a court to represent creditors of a partnership or a partner person, may
3	enforce a partner's person's obligation to contribute to the partnership.

9	SECTION 808. KNOWN CLAIMS AGAINST A DISSOLVED PARTNERSHIP.

12	(b) A dissolved partnership may notify in a record its known claimants of the dissolution.

11	does not exceed the total amount of assets distributed to the person after dissolution.

18	(6) "Domesticated partnership" means the limited liability partnership that exists after a
19	domesticating foreign partnership or limited liability partnership effects a domestication pursuant
20	to Sections 910 through 913.
21	(7) "Domesticating partnership" means the limited liability partnership that effects
22	domestication pursuant to Sections 910 through 913.
23	(8) "Foreign partnership" means a partnership that has its principal office in a jurisdiction

1	other than this state or that has specified in its partnership agreement that relations among the				
2	partners and between the partners and the partnership will be governed by the law of a				
3	jurisdiction other than this state.				
4	(9) "Governing statute" means the statute that governs an organization's internal affairs.				
5	(10) "Organization" means a general partnership, including a limited liability partnership,				
6	limited partnership, including a limited liability limited partnership, limited liability company,				
7	business trust, corporation, or any other person having a governing statute. The term includes a				
8	domestic or foreign organization regardless of whether organized for profit.				
9	(11) "Organizational documents" means:				
10	(A) for a domestic or foreign general partnership, its partnership agreement;				
11	(B) for a limited partnership or foreign limited partnership, its certificate of				
12	limited partnership and partnership agreement;				
13	(C) for a domestic or foreign limited liability company, its certificate or articles of				
14	organization and operating agreement, or comparable records as provided in its governing				
15	statute;				
16	(D) for a business trust, its agreement of trust and declaration of trust;				
17	(E) for a domestic or foreign corporation for profit, its articles of incorporation,				
18	bylaws, and other agreements among its shareholders which are authorized by its governing				
19	statute, or comparable records as provided in its governing statute; and				
20	(F) for any other organization, the basic records that create the organization and				
21	determine its internal governance and the relations among the persons that own it, have an				
22	interest in it, or are members of it.				
23	(12) "Personal liability" means liability for a debt, obligation, or other liability of an				

organization that is imposed on a person that co-owns, has an interest in, or is a member of the
organization:

3 (A) by the governing statute solely by reason of the person co-owning, having an 4 interest in, or being a member of the organization; or 5 (B) by the organization's organizational documents under a provision of the 6 governing statute authorizing those documents to make one or more specified persons liable for 7 all or specified debts, obligations, or other liabilities of the organization solely by reason of the 8 person or persons co-owning, having an interest in, or being a member of the organization. 9 (13) "Surviving organization" means an organization into which one or more other 10 organizations are merged whether the organization preexisted the merger or was created by the 11 merger. 12 SECTION 902. 8	takes effect. If the other party to a transaction with the limited partnership reasonably believes-					
9	when entering the transaction that the limited partner is a general partner, the limited partner is					
10	liable for an obligation incurred by the limited partnership within 90 days after the conversion					
11	takes effect. The limited partner's liability for all other obligations of the limited partnership-					
12	incurred after the conversion takes effect is that of a limited partner as provided in the [State-					
13	Limited Partnership Act].					
14	(a) A partnership may merge with one or more other constituent organizations pursuant to					
15	this section, Sections 903 through 905, and a plan of merger, if:					
16	(1) the governing statute of each of the other organizations authorizes the merger;					
17	(2) the merger is not prohibited by the law of a jurisdiction that enacted any of the					
18	governing statutes; and					
19	(3) each of the other organizations complies with its governing statute in effecting					
20	the merger.					
21	(b) Unless each constituent organization and the surviving organization are partnerships					
22	other than limited liability partnerships, a plan of merger must be in a record and must include:					
23	(1) the name and form of each constituent organization;					

1	(2) the name and form of the surviving organization and, if the surviving					
2	organization is to be created by the merger, a statement to that effect;

12	(d) After a plan of merger is approved and before the merger takes effect, the plan may be

7	not authorized to transact business in this state appoints the [Secretary of State] as its agent for					
8	service of process for the purposes of enforcing a debt, obligation, or other liability under this					
9	subsection. Service of any process, notice, or demand on the [Secretary of State] as agent for a					
10	surviving organization that is a foreign organization may be made by delivering to the [Secretary					
11	of State] duplicate copies of the process, notice, or demand. If a process, notice, or demand is					
12	served upon the [Secretary of State], the [Secretary of State] shall forward one of the copies by					
13	registered or certified mail, return receipt requested, to the organization at its registered office.					
14	Service is effected under this subsection at the earliest of:					
15	(1) the date the surviving organization receives the process, notice, or demand;					
16	(2) the date shown on the return receipt, if signed on behalf of the organization; or					
17	(3) five days after the process, notice, or demand is deposited with the United					
18	States Postal Service, if correctly addressed and with sufficient postage.					
19	SECTION 906. EFFECT OF MERGER CONVERSION.					
20	(a) When a merger takes effect:					
21	(1) the separate existence of every partnership or limited partnership that is a party-					
22	to the merger, other than the surviving entity, ceases;

10	shall promptly notify the [Secretary of State] of the mailing address of its chief executive office-
11	and of any change of address. Upon receipt of process, the [Secretary of State] shall mail a copy-
12	of the process to the surviving foreign partnership or limited partnership.
13	(c) A partner of the surviving partnership or limited partnership is liable for:
14	(1) all obligations of a party to the merger for which the partner was personally-
15	liable before the merger;
16	(2) all other obligations of the surviving entity incurred before the merger by a
17	party to the merger, but those obligations may be satisfied only out of property of the entity; and
18	(3) except as otherwise provided in Section 306, all obligations of the surviving-
19	entity incurred after the merger takes effect, but those obligations may be satisfied only out of

21	(d) If the obligations incurred before the merger by a party to the merger are not satisfied

12	(a) An organization other than a partnership or a foreign partnership may convert to a
13	partnership, and a partnership may convert to an organization other than a foreign partnership

15	(1) the other organization's governing statute authorizes the conversion;
16	(2) the conversion is not prohibited by the law of the jurisdiction that enacted the
17	other organization's governing statute; and
18	(3) the other organization complies with its governing statute in effecting the
19	conversion.
20	(b) A plan of conversion must be in a record and must include:
21	(1) the name and form of the organization before conversion;
22	(2) the name and form of the organization after conversion;
23	(3) the terms and conditions of the conversion, including the manner and basis for

1	converting interests in the converting organization into any combination of money, interests in
2	the converted organization, and other consideration; and
3	(4) the organizational documents of the converted organization that are, or are
4	proposed to be, in a record.
5	SECTION 907. STATEMENT OF MERGER ACTION ON PLAN OF
6	CONVERSION BY CONVERTING PARTNERSHIP.
7	(a) After a merger, the surviving partnership or limited partnership may file a statement
8	that one or more partnerships or limited partnerships have merged into the surviving entity.
9	(b) A statement of merger must contain:
10	(1) the name of each partnership or limited partnership that is a party to the merger;
11	(2) the name of the surviving entity into which the other partnerships or limited
12	partnership were merged;
13	(3) the street address of the surviving entity's chief executive office and of an office

20	(d) For the purposes of Section 302, real property of the surviving partnership or limited
21	partnership which before the merger was held in the name of another party to the merger is-
22	property held in the name of the surviving entity upon recording a certified copy of the statement
23	of merger in the office for recording transfers of that real property.

1	(e) A filed and, if appropriate, recorded statement of merger, executed and declared to be-
2	accurate pursuant to Section 105(c), stating the name of a partnership or limited partnership that
3	is a party to the merger in whose name property was held before the merger and the name of the
4	surviving entity, but not containing all of the other information required by subsection (b),
5	operates with respect to the partnerships or limited partnerships named to the extent provided in-
6	subsections (c) and (d).
7	(a) Subject to Section 914, a plan of conversion must be consented to by all the partners
8	of a converting partnership.
9	(b) Subject to Section 914 and any contractual rights, after a conversion is approved, and
10	at any time before articles of conversion are delivered to the [Secretary of State] for filing under
11	Section 908, a converting partnership may amend the plan or abandon the conversion:
12	(1) as provided in the plan; or
13	(2) except as otherwise prohibited in the plan, by the same consent as was
14	required to approve the plan.
15	SECTION 908. FILINGS REQUIRED FOR CONVERSION; EFFECTIVE DATE.
16	(a) After a plan of conversion is approved:
17	(1) a converting limited liability partnership shall deliver to the [Secretary of
18	State] for filing articles of conversion, which must be signed as provided in Section 105 and
19	<u>must include;</u>
20	(A) a statement that the limited liability partnership has been converted
21	into another organization;
22	(B) the name and form of the converted organization and the jurisdiction
23	of its governing statute;

1	(C) the date the conversion is effective under the governing statute of the
2	converted organization;
3	(D) a statement that the conversion was approved as required by this act;
4	(E) a statement that the conversion was approved as required by the
5	governing statute of the converted organization; and
6	(F) if the converted organization is a foreign organization not authorized to
7	transact business in this state, the street and mailing addresses of an office which the [Secretary
8	of State] may use for the purposes of Section 909(c); and
9	(2) if the converting organization is not a converting partnership or limited
10	liability partnership, the converting organization shall deliver to the [Secretary of State] for filing
11	a statement of conversion, which must include:
12	(A) a statement that the converted organization was converted from
13	another organization, and whether the converted organization is a partnership or a limited
14	liability partnership;
15	(B) the name and form of that converting organization and the jurisdiction
16	of its governing statute; and
17	(C) a statement that the conversion was approved in a manner that
18	complied with the converting organization's governing statute.
19	(b) A conversion becomes effective:
20	(1) if the converted organization is a partnership, as provided in the plan or
21	statement of conversion;
22	(2) if the converted organization is a limited liability partnership, after the filing
23	of the statement of conversion required by subsection (a)(2) and upon the filing of the statement

1	of qualification pursuant to Section 1001 with the [Secretary of State], or on the date provided in
2	the statement, whichever is later; or
3	(3) if the converted organization is not a partnership or limited liability
4	partnership, as provided by the governing statute of the converted organization.
5	SECTION 909. EFFECT OF CONVERSION.
6	(a) An organization that has been converted pursuant to this [article] is for all purposes
7	the same entity that existed before the conversion.
8	(b) When a conversion takes effect:
9	(1) all property owned by the converting organization remains vested in the
10	converted organization;
11	(2) all debts, obligations, or other liabilities of the converting organization
12	continue as debts, obligations, or other liabilities of the converted organization;
13	(3) an action or proceeding pending by or against the converting organization may
14	be continued as if the conversion had not occurred;
15	(4) except as prohibited by law other than this [act], all of the rights, privileges,
16	immunities, powers, and purposes of the converting organization remain vested in the converted
17	organization;
18	(5) except as otherwise provided in the plan of conversion, the terms and
19	conditions of the plan of conversion take effect; and
20	(6) except as otherwise agreed, the conversion does not dissolve a converting
21	partnership for the purposes of [Article] 8.
22	(c) A converted organization that is a foreign organization consents to the jurisdiction of
23	the courts of this state to enforce any debt, obligation, or other liability for which the converting

1	partnership or limited liability partnership is liable if, before the conversion, the converting
2	partnership or limited liability partnership was subject to suit in this state on the debt, obligation,
3	or other liability. A converted organization that is a foreign organization and not authorized to
4	transact business in this state appoints the [Secretary of State] as its agent for service of process
5	for purposes of enforcing a debt, obligation, or other liability under this subsection. Service on
6	the [Secretary of State] under this subsection of any process, notice, or demand as agent for a
7	converted organization that is a foreign organization may be made by delivering to the [Secretary
8	of State] duplicate copies of the process, notice, or demand. If a process, notice, or demand is
9	served upon the [Secretary of State], the [Secretary of State] shall forward one of the copies by
10	registered or certified mail, return receipt requested, to the organization at its registered office.
11	Service is effected under this subsection at the earliest of:
12	(1) the date the converted organization receives the process, notice, or demand;
13	(2) the date shown on the return receipt, if signed on behalf of the organization; or
14	(3) five days after the process, notice, or demand is deposited with the United
15	States Postal Service, if correctly addressed and with sufficient postage.
16	SECTION 910. DOMESTICATION.
17	(a) A foreign limited liability partnership may become a limited liability partnership
18	pursuant to this section, Sections 911 through 913, and a plan of domestication, if:
19	(1) the foreign limited liability partnership's governing statute authorizes the
20	domestication;
21	(2) the domestication is not prohibited by the law of the jurisdiction that enacted
22	the governing statute; and
23	(3) the foreign limited liability partnership complies with its governing statute in

1 <u>effecting the domestication.</u>

2	(b) A limited liability partnership may become a foreign limited liability partnership
3	pursuant to this section, Sections 911 through 913, and a plan of domestication, if:
4	(1) the foreign limited liability partnership's governing statute authorizes the
5	domestication;
6	(2) the domestication is not prohibited by the law of the jurisdiction that enacted
7	the governing statute; and
8	(3) the foreign limited liability partnership complies with its governing statute in
9	effecting the domestication.
10	(c) A plan of domestication must be in a record and must include:
11	(1) the name of the domesticating limited liability partnership before
12	domestication and the jurisdiction of its governing statute;
13	(2) the name of the domesticated limited liability partnership after domestication
14	and the jurisdiction of its governing statute;
15	(3) the terms and conditions of the domestication, including the manner and basis
16	for converting interests in the domesticating limited liability partnership into any combination of
17	money, interests in the domesticated limited liability partnership, and other consideration; and
18	(4) the organizational documents of the domesticated company that are, or are
19	proposed to be, in a record.
20	SECTION 911. ACTION ON PLAN OF DOMESTICATION BY
21	DOMESTICATING PARTNERSHIP.
22	(a) A plan of domestication must be consented to:
23	(1) by all the partners, subject to Section 914, if the domesticating company is a

1	limited liability partnership; and
2	(2) as provided in the domesticating company's governing statute, if the company
3	is a foreign limited liability partnership.
4	(b) Subject to any contractual rights, after a domestication is approved, and at any time
5	before articles of domestication are delivered to the [Secretary of State] for filing under Section
6	912, a domesticating limited liability partnership may amend the plan or abandon the
7	domestication:
8	(1) as provided in the plan; or
9	(2) except as otherwise prohibited in the plan, by the same consent as was
10	required to approve the plan.
11	SECTION 912. FILINGS REQUIRED FOR DOMESTICATION; EFFECTIVE
12	DATE.
13	(a) After a plan of domestication is approved, a domesticating limited liability partnership
14	shall deliver to the [Secretary of State] for filing articles of domestication, which must include:
15	(1) a statement to that effect if the limited liability partnership has been
16	domesticated from or into another jurisdiction;
17	(2) the name of the domesticating limited liability partnership and the jurisdiction
18	of its governing statute;
19	(3) the name of the domesticated limited liability partnership and the jurisdiction
20	of its governing statute;
21	(4) the date the domestication is effective under the governing statute of the
22	domesticated limited liability partnership;
23	(5) if the domesticating company was a limited liability partnership, a statement

1	that the domestication was approved as required by this [act];
2	(6) if the domesticating limited liability partnership was a foreign limited liability
3	partnership, a statement that the domestication was approved as required by the governing statute
4	of the other jurisdiction; and
5	(7) if the domesticated limited liability partnership is a foreign limited liability
6	partnership not authorized to transact business in this state, the street and mailing addresses of an
7	office that the [Secretary of State] may use for the purposes of Section 913(b).
8	(b) A domestication becomes effective:
9	(1) upon the filing of the statement of qualification pursuant to section 1001 or on
10	the date provided therein, whichever is later, if the domesticated partnership is a limited liability
11	partnership; and
12	(2) according to the governing statute of the domesticated limited liability
13	partnership, if it is a foreign limited liability partnership.
14	SECTION 913. EFFECT OF DOMESTICATION.
15	(a) When a domestication takes effect:
16	(1) the domesticated limited liability partnership is for all purposes the limited
17	liability partnership that existed before the domestication;
18	(2) all property owned by the domesticating limited liability partnership remains
19	vested in the domesticated limited liability partnership;
20	(3) all debts, obligations, or other liabilities of the domesticating limited liability
21	partnership continue as debts, obligations, or other liabilities of the domesticated limited liability
22	partnership;
23	(4) an action or proceeding pending by or against a domesticating limited liability

1	partnership may be continued as if the domestication had not occurred;
2	(5) except as prohibited by other law, all of the rights, privileges, immunities,
3	powers, and purposes of the domesticating limited liability partnership remain vested in the
4	domesticated limited liability partnership;
5	(6) except as otherwise provided in the plan of domestication, the terms and
6	conditions of the plan of domestication take effect; and
7	(7) except as otherwise agreed, the domestication does not dissolve a
8	domesticating limited liability partnership for the purposes of [Article] 8.
9	(b) A domesticated limited liability partnership that is a foreign limited liability
10	partnership consents to the jurisdiction of the courts of this state to enforce any debt, obligation,
11	or other liability owed by the domesticating limited liability partnership, if, before the
12	domestication, the domesticating limited liability partnership was subject to suit in this state on
13	the debt, obligation, or other liability. A domesticated limited liability partnership that is a
14	foreign limited liability partnership and not authorized to transact business in this state appoints
15	the [Secretary of State] as its agent for service of process for purposes of enforcing a debt,
16	obligation, or other liability under this subsection. Service on the [Secretary of State] under this
17	subsection of any process, notice, or demand as agent for a domesticated limited liability
18	partnership that is a foreign limited liability partnership may be made by delivering to the
19	[Secretary of State] duplicate copies of the process, notice, or demand. If a process, notice, or
20	demand is served upon the [Secretary of State], the [Secretary of State] shall forward one of the
21	copies by registered or certified mail, return receipt requested, to the organization at its registered
22	office. Service is effected under this subsection at the earliest of:
23	(1) the date the domesticated foreign limited liability partnership receives the

process, notice, or demand;

2	(2) the date shown on the return receipt, if signed on behalf of the limited liability
3	partnership; or
4	(3) five days after the process, notice, or demand is deposited with the United
5	States Postal Service, if correctly addressed and with sufficient postage.
6	(c) If a limited liability partnership has adopted and approved a plan of domestication
7	under Section 910 providing for the limited liability partnership to be domesticated in a foreign
8	jurisdiction, a statement pursuant to Section 1001(d) cancelling the limited liability partnership's

3	(b) A partner does not give the consent required by subsection (a) merely by consenting

6	SECTION 915. AMENDMENT OR ABANDONMENT OF PLAN OF MERGER,
7	CONVERSION, DOMESTICATION.
8	(a) Subject to Section 914, a plan of merger, domestication, or conversation of a
9	partnership may be amended:
10	(1) in the same manner as the plan was approved, if the plan does not provide for
11	the manner in which it may be amended; or
12	(2) by the partners of the partnership in the manner provided in the plan, but a
13	member that was entitled to vote on or consent to approval of the plan is entitled to vote on or
14	consent to any amendment of the plan that will change:
15	(A) the amount or kind of interests, securities, obligations, rights to
16	acquire interests or securities, cash, or other property, or any combination of the foregoing, to be
17	received by the members of any party to the plan;
18	(B) the organizational documents of the surviving, converted, or
19	domesticated organization that will be in effect immediately after the merger, conversion, or
20	domestication becomes effective, except for changes that, under the governing statute of the
21	organization, do not require approval of the persons considered by the governing statute to be
22	owners of the organization; or
23	(C) any other terms or conditions of the plan, if the change would

1	adversely affect the partner in any material respect.
2	(b) After a plan of merger, conversion, or domestication has been approved by a
3	partnership and before a statement of merger, conversion, or domestication becomes effective,
4	the plan may be abandoned:
5	(1) as provided in the plan; or
6	(2) unless prohibited by the plan, in the same manner as the plan was approved.
7	(c) If a plan of merger is abandoned after a statement of merger, conversion, or
8	domestication has been filed with the [Secretary of State] and before the filing becomes
9	effective, a statement of abandonment, signed on behalf of a constituent organization, converting
10	organization, or domesticating organization, must be filed with the [Secretary of State] before the
11	time the statement of merger, conversion, or domestication becomes effective. The statement of
12	abandonment takes effect upon filing, and the merger, conversion, or domestication is abandoned
13	and does not become effective. The statement of abandonment must contain:
14	(1) the name of each constituent organization that is [authorized] [registered] to
15	do business in this state or whose governing statute is a statute of this state;
16	(2) the date on which the statement of merger, conversion, or domestication was
17	filed; and
18	(3) a statement that the merger, conversion, or domestication has been abandoned
19	in accordance with this section.

4	SECTION 1001. STATEMENT OF QUALIFICATION.
5	(a) A partnership may become a limited liability partnership pursuant to this section.
6	(b) The terms and conditions on which a partnership becomes a limited liability
7	partnership must be approved by the vote necessary to amend the partnership agreement except,
8	in the case of a partnership agreement that expressly considers obligations to contribute to the
9	partnership, the vote necessary to amend those provisions.

11	liability partnership by filing a statement of qualification. The statement must contain:

18	(5) a deferred effective date, if any.

20	individual who is a resident of this State state or other person authorized to do business in this

22	(e) The status of a partnership as a limited liability partnership is effective on the later of
23	the filing of the statement or a date specified in the statement. The status remains effective,

1	regardless of changes in the partnership, until it is canceled pursuant to Section $\frac{105(d)}{107(g)}$ or
2	revoked pursuant to Section 1003.
3	(f) The status of a partnership as a limited liability partnership and the liability of its
4	partners is not affected by errors or later changes in the information required to be contained in
5	the statement of qualification under subsection (c).
6	(g) The filing of a statement of qualification establishes that a partnership has satisfied all
7	conditions precedent to the qualification of the partnership as a limited liability partnership.
8	(h) An amendment or cancellation of a statement of qualification is effective when it is
9	filed or on a deferred effective date specified in the amendment or cancellation.

23	(d) Service of process, notice, or demand on a registered agent must be in a written
24	record. Receipt of a written process, notice, or demand by the registered agent of a partnership

17	that fails to file an annual report when due or pay the required filing fee. To do so, the [Secretary
18	of State] shall provide the partnership at least 60 days' written notice of intent to revoke the
19	statement. The notice must be mailed to the partnership at its chief executive office set forth in
20	the last filed statement of qualification or annual report. The notice must specify the annual
21	report that has not been filed, the fee that has not been paid, and the effective date of the

2	FOREIGN LIMITED LIABILITY PARTNERSHIP
3	
4	SECTION 1101. LAW GOVERNING FOREIGN LIMITED LIABILITY
5	PARTNERSHIP.
6	(a) The law under which a foreign limited liability partnership is formed governs relations
7	among the partners and between the partners and the partnership and the liability of partners for-
8	obligations of the partnership:
9	(1) the internal affairs of the limited liability partnership; and
10	(2) the liability of a partner as partner for the debts, obligations, or other liabilities
11	of the partnership.
12	(b) A foreign limited liability partnership may not be denied a statement of foreign-
13	qualification by reason of any difference between the law under which the partnership was-
14	formed and the law of this State. A foreign limited liability company may not be precluded from
15	registering to do business in this state because of any difference between the law of the limited
16	liability partnership's jurisdiction of formation and the laws of this state.
17	(c) A statement of foreign qualification does not authorize a foreign limited liability
18	partnership to engage in any business or exercise any power that a partnership may not engage in
19	or exercise in this State as a limited liability partnership. Registration as a foreign limited
20	liability partnership to do business in this state does not authorize that partnership to engage in
21	any business or exercise any power that a limited liability partnership may not engage in or
22	exercise in this state.

4	business in this State without a statement of foreign qualification.
5	(d) If a foreign limited liability partnership transacts business in this State without a-
6	statement of foreign qualification, the [Secretary of State] is its agent for service of process with
7	respect to a right of action arising out of the transaction of business in this State.
8	SECTION 1104. ACTIVITIES NOT CONSTITUTING TRANSACTING
9	BUSINESS.
10	(a) Activities of a foreign limited liability partnership which do not constitute transacting-
11	business for the purpose of this [article] include:
12	(1) maintaining, defending, or settling an action or proceeding;
13	(2) holding meetings of its partners or carrying on any other activity concerning
14	its internal affairs;
15	(3) maintaining bank accounts;
16	(4) maintaining offices or agencies for the transfer, exchange, and registration of
17	the partnership's own securities or maintaining trustees or depositories with respect to those-
18	securities;
19	(5) selling through independent contractors;
20	(6) soliciting or obtaining orders, whether by mail or through employees or agents
21	or otherwise, if the orders require acceptance outside this State before they become contracts;
22	(7) creating or acquiring indebtedness, with or without a mortgage, or other-
23	security interest in property;

1	(8) collecting debts or foreclosing mortgages or other security interests in
2	property securing the debts, and holding, protecting, and maintaining property so acquired;
3	(9) conducting an isolated transaction that is completed within 30 days and is not
4	one in the course of similar transactions; and
5	(10) transacting business in interstate commerce.
6	(b) For purposes of this [article], the ownership in this State of income-producing real-
7	property or tangible personal property, other than property excluded under subsection (a),
8	constitutes transacting business in this State.
9	(c) This section does not apply in determining the contacts or activities that may subject a
10	foreign limited liability partnership to service of process, taxation, or regulation under any other
11	law of this State.
12	SECTION 1103. FOREIGN REGISTRATION STATEMENT. To register to do
13	business in this state, a foreign limited liability partnership must deliver a foreign registration
14	statement to the [Secretary of State] for filing. The application must set forth:
15	(1) the name of the partnership and, if the name does not comply with Section 1005, an
16	alternate name adopted pursuant to Section 1106(a);
17	(2) the name of the jurisdiction under whose law the partnership is formed;

10	(4) deliver to the [Secretary of State] for filing a statement of a change under
11	Section 1003 not later than 30 days after a change has occurred in the name or address of the
12	registered agent.
13	(b) The [Secretary of State] may terminate the registration of a foreign limited liability
14	partnership by filing a notice of termination or noting the termination in the record of the
15	[Secretary of State] and by sending a copy of the notice or the information in the notation to the
16	partnership's registered agent in this state, or if the partnership does not appoint and maintain a
17	proper registered agent in this state, to the partnership's office. The notice must state:
18	(1) the effective date of the termination, which must be at least [60 days] after the
19	date the [Secretary of State] sends the copy; and
20	(2) the grounds for termination under subsection (a).
21	(c) The authority of a foreign limited liability partnership to do business in this state
22	ceases on the effective date of the notice of termination unless before that date the partnership
23	cures each ground for termination stated in the notice of termination or the notated information.

6	SECTION 1102 1111. STATEMENT OF FOREIGN QUALIFICATION
7	WITHDRAWAL OF REGISTRATION OF REGISTERED FOREIGN ENTITY.
8	(a) Before transacting business in this State, a foreign limited liability partnership must-
9	file a statement of foreign qualification. The statement must contain:
10	(1) the name of the foreign limited liability partnership which satisfies the
11	requirements of the State or other jurisdiction under whose law it is formed and ends with
12	"Registered Limited Liability Partnership", "Limited Liability Partnership", "R.L.L.P.", "L.L.P.",
13	"RLLP," or "LLP";
14	(2) the street address of the partnership's chief executive office and, if different, the
15	street address of an office of the partnership in this State, if any;
16	(3) if there is no office of the partnership in this State, the name and street address-
17	of the partnership's agent for service of process; and
18	(4) a deferred effective date, if any.
19	(b) The agent of a foreign limited liability company for service of process must be an-
20	individual who is a resident of this State or other person authorized to do business in this State.
21	(c) The status of a partnership as a foreign limited liability partnership is effective on the
22	later of the filing of the statement of foreign qualification or a date specified in the statement.
23	The status remains effective, regardless of changes in the partnership, until it is canceled
24	pursuant to Section 105(d) or revoked pursuant to Section 1003.
25	(d) An amendment or cancellation of a statement of foreign qualification is effective when it is

1	filed or on a deferred effective date specified in the amendment or cancellation.
2	(a) A foreign entity registered to do business in this state may withdraw its registration by
3	delivering a statement of withdrawal to the [Secretary of State] for filing. The statement of
4	withdrawal must set forth:
5	(1) the name of the foreign entity and the name of the jurisdiction under whose
6	law it is formed;
7	(2) that the entity is not doing business in this state and that it withdraws its
8	registration to do business in this state;
9	(3) that the entity revokes the authority of its registered agent to accept service on
10	its behalf; and
11	(4) an address to which service of process may be made under subsection (b).
12	(b) After the withdrawal of the registration of a foreign limited liability partnership,
13	service of process in any action or proceeding based on a cause of action arising during the time
14	the partnership was registered to do business in this state may be made by registered or certified
15	mail, return receipt requested, or by similar commercial delivery service, addressed to the limited
16	liability partnership at its principal office in accordance with any applicable judicial rules and
17	procedures and with the envelope conspicuously marked "important legal notice" or with words
18	of similar import. Service is effected under this subsection on the earliest of:
19	(1) the date the entity receives the mail or delivery by a similar commercial
20	delivery service;
21	(2) the date shown on the return receipt, if signed on behalf of the limited liability
22	partnership; or
23	(3) five days after its deposit with the United States Postal Service, or similar

1	commercial delivery service, if correctly addressed and with sufficient postage or payment.
2	(c) If process, notice, or demand cannot be served on a foreign limited liability
3	partnership pursuant to subsection (b), service may be made by handing a copy to a supervisor,
4	clerk, or other individual in charge of any regular place of business of the partnership if the
5	individual served is not a plaintiff in the action.

2	MISCELLANEOUS PROVISIONS

4	SECTION 1201. UNIFORMITY OF APPLICATION AND CONSTRUCTION.

6	law with respect to the subject of this [Act] among States enacting it. In applying and construing
7	this uniform act, consideration must be given to the need to promote uniformity of the law with
8	respect to its subject matter among states that enact it.
9	SECTION 1202. SHORT TITLE. This [Act] may be cited as the Uniform Partnership-
10	Act (1997).

17	(a) Before [all-inclusive date], this [act] governs only:
18	(1) a partnership formed on or after [the effective date of this act]; and
19	(2) a partnership formed before [the effective date of this act] which elects, in the
20	manner provided in its partnership agreement or by law for amending the partnership agreement,
21	to be subject to this [act].
22	(b) On and after [all-inclusive date] this [act] governs all partnerships.
23	SECTION 1207 1204. SAVINGS CLAUSE. This [Act] [act] does not affect an action

1	commenced, or proceeding commenced brought, or right accrued before this [Act] [act] takes
2	effect.
