    - ! Ability to sue and be sued

    - ! Limited liability for members and/or officers
  - ! Issues that concern the relationship of members to the association and each other
    - ! Management and governance
    - ! Standards of conduct
    - ! Member rights
  - ! Other issues
    - ! Creation of an association
    - ! Dissolution of an association
    - ! Conversion of an association from one type of entity into another type
    - ! Merger of an association with another entity.
