2	[ARTICLE] 1
3	GENERAL PROVISIONS
4	SECTION 101. SHORT TITLE. This [act] may be cited as the Revised Uniform
5	Limited Liability Company Act.
6	SECTION 102. DEFINITIONS. In this [act]:
7	(1) "Certificate of organization" means the certificate required by Section 201. The term
8	includes the certificate as amended or restated.
9	¹ (2) "Contribution", except in the phrase "right of contribution," means any benefit
10	provided by a person to a limited liability company in order to become a member or in the
11	person's capacity as a member.
12	² (3) "Debtor in bankruptcy" means a person that is the subject of:
13	(A) an order for relief under Title 11 of the United States Code or a comparable
14	order under a successor statute of general application; or
15	(B) a comparable order under federal, state, or foreign law governing insolvency.
16	³ (4) "Designated office" means:
17	(A) the office that a limited liability company is required to designate and
18	maintain under Section 113; or
19	(B) the principal office of a foreign limited liability company.
20	(5) "Distribution", except as otherwise provided in Section 405(g), means a transfer of
21	money or other property from a limited liability company to another person on account of a

- transferable interest and includes a redemption or other purchase by a limited company of a
 transferable interest.
 - ⁴(6) "Foreign limited liability company" means an unincorporated entity formed under the law of a jurisdiction other than this state and denominated by that law as a limited liability company.
- 6 (7) "Limited liability company", except in the phrase "foreign limited liability company",
 7 means an entity formed under this [act].
 - (8) "Manager" means a person that under the operating agreement of a manager-managed limited liability company is responsible, alone or in concert with others, for performing the management functions stated in Section 407(c).
 - (9) "Manager-managed limited liability company" means a limited liability company that qualifies under Section 407(a).
 - (10) "Member" means a person that has become a member of a limited liability company under Section 401 and has not dissociated under Section 602.
 - (11) "Member-managed limited liability company" means a limited liability company that is not a manager-managed limited liability company.
 - (12) "Operating agreement" means the agreement, whether or not referred to as an operating agreement and whether oral, in a record, implied, or in any combination thereof, of all the members of a limited liability company, including a sole member, concerning the matters described in Section 110(a). The term includes the agreement as amended or restated.

8	SECTION 103. KNOWLEDGE; NOTICE.

12	(b) A person has notice of a fact when the person:
13	(1) has reason to know the fact from all of the facts known to the person at the

15	(2) is deemed to have notice of the fact under subsection (d)(2);
16	(c) A person notifies another of a fact by taking steps reasonably required to inform the
17	other person in ordinary course, whether or not the other person knows the fact.

(11) except as otherwise provided in Sections 111 and 112(b), restrict the rights under this [act] of a person other than a member or manager.

(d) The operating agreement may specify the method by which a specific act or transaction that would otherwise violate the duty of loyalty may be authorized or ratified by one or more disinterested and independent persons after full disclosure of all material facts.

(e) To the extent the operating agreement of a member-managed limited liability company expressly relieves a member of a responsibility that the member would otherwise have under this [act] and imposes the responsibility on one or more other members, the operating agreement may, to the benefit of the member that the operating agreement relieves of the

Subject only to any court order issued under Section 503(b)(2) to effectuate a charging order, an amendment to the operating agreement made after a person becomes a transferee or dissociated member is effective with regard to any debt, obligation, or other liability of the limited liability company or its members to the person in the person's capacity as a transferee or dissociated member.
- (c) If a record that has been delivered by a limited liability company to the [Secretary of State] for filing and has become effective under this [act] contains a provision that would be

- (d) A limited liability company's indebtedness to a member incurred by reason of a distribution made in accordance with this section is at parity with the company's indebtedness to its general, unsecured creditors except to the extent subordinated by agreement
- (e) A limited liability company's indebtedness, including indebtedness issued in connection with or as part of a distribution, is not a liability for purposes of subsection (a) if the terms of the indebtedness provide that payment of principal and interest are made only to the extent that a distribution could be made to members under this section.
- (f) If indebtedness is issued as a distribution, each payment of principal or interest on the indebtedness is treated as a distribution, the effect of which is measured on the date the payment is made.⁴⁴

23	member to the extent the member knows any of the information described in paragraph (2).
24	(b) In a manager-managed limited liability company, the following rules apply:

1	(1) The informational rights stated in subsection (a) and the duty stated in
2	subsection (a)(3) apply to the managers and not the members.
3	(2) During regular business hours and at a reasonable location specified by the
4	company, a member may obtain from the company and inspect and copy full information
5	regarding the activities, financial condition, and other circumstances of the company as is just
6	and reasonable if:
7	(A) the member seeks the information for a purpose material to the
8	member's interest as a member;
9	(B) the member makes a demand in a record received by the company,
10	describing with reasonable particularity the information sought and the purpose for seeking the
11	information; and
12	(C) the information sought is directly connected to the member's purpose
13	(3) Within 10 days after receiving a demand pursuant to paragraph (2)(B), the
14	company shall in a record inform the member that made the demand:
15	(A) of the information that the company will provide in response to the
16	demand and when and where the company will provide the information; and
17	(B) if the company declines to provide any demanded information, the
18	company's reasons for declining.
19	(4) Whenever this [act] or an operating agreement provides for a member to give
20	or withhold consent to a matter, before the consent is given or withheld, the company shall,
21	without demand, provide the member with all information that is known to the company and is
22	material to the member's decision.
23	(c) On 10 days' demand made in a record received by a limited liability company, a
24	dissociated member may have access to information to which the person was entitled while a

- 1 member if the information pertains to the period during which the person was a member, the
- 2 person seeks the information in good faith, and the person satisfies the requirements imposed on
- 3 a member by subsection (b)(2). The company shall respond to a demand made pursuant to this
- 4 subsection in the manner provided in subsection (b)(3).
 - (d) A limited liability company may charge a person that makes a demand under this
- 6 section the reasonable costs of copying, limited to the costs of labor and material.
- 7 (e) A member or dissociated member may exercise rights under this section through an
- 8 agent or, in the case of an individual under legal disability, a legal representative. Any
- 9 restriction or condition imposed by the operating agreement or under subsection (g) applies both
- 10 to the agent or legal representative and the member or dissociated member.
- 11 (f) The rights under this section do not extend to a person as transferee.
- 12 (g) In addition to any restriction or condition stated in its operating agreement, a limited
- 13 liability company, as a matter within the ordinary course of its activities, may impose reasonable
- 14 restrictions and conditions on access to and use of information to be furnished under this section,
- including designating information confidential and imposing nondisclosure and safeguarding
- obligations on the recipient. In a dispute concerning the reasonableness of a restriction under
- this subsection, the company has the burden of proving reasonableness.

1	[ARTICLE] 5
2	TRANSFERABLE INTERESTS AND RIGHTS OF TRANSFEREES AND CREDITORS
3	SECTION 501. NATURE OF TRANSFERABLE INTEREST. A transferable
4	interest is personal property.
5	SECTION 502. TRANSFER OF TRANSFERABLE INTEREST.
6	(a) A transfer, in whole or in part, of a transferable interest:
7	(1) is permissible;
8	(2) does not by itself cause a member's dissociation or a dissolution and winding
9	up of the limited liability company's activities; and
10	(3) subject to Section 504, does not entitle the transferee to:
11	(A) participate in the management or conduct of the company's activities;
12	or
13	(B) except as otherwise provided in subsection (c), have access to records
14	or other information concerning the company's activities.
15	(b) A transferee has the right to receive, in accordance with the transfer, distributions to
16	which the transferor would otherwise be entitled.
17	(c) In a dissolution and winding up of a limited liability company, a transferee is entitled
18	to an account of the company's transactions only from the date of dissolution.
19	(d) A transferable interest may be evidenced by a certificate of the interest issued by the
20	limited liability company in a record, and, subject to this section, the interest represented by the
21	certificate may be transferred by a transfer of the certificate.
22	(e) A limited liability company need not give effect to a transferee's rights under this
23	section until the company has notice of the transfer.
24	(f) A transfer of a transferable interest in violation of a restriction on transfer contained in

- the operating agreement is ineffective as to a person having notice of the restriction at the time of transfer.
 - (g) Except as otherwise provided in Section 602(4)(B), when a member transfers a transferable interest, the transferor retains the rights of a member other than the interest in distributions transferred and retains all duties and obligations of a member.
 - (h) When a member transfers a transferable interest to a person that becomes a member with respect to the transferred interest, the transferee is liable for the member's obligations under Sections 403 and 406(c) known to the transferee when the transferee becomes a member.

SECTION 503. CHARGING ORDER.

- (a) On application by a judgment creditor of a member or transferee, a court may enter a charging order against the transferable interest of the judgment debtor for the unsatisfied amount of the judgment. A charging order constitutes a lien on a judgment debtor's transferable interest and requires the limited liability company to pay over to the person to which the charging order was issued any distribution that would otherwise be paid to the judgment debtor.
- (b) To the extent necessary to effectuate the collection of distributions pursuant to a charging order in effect under subsection (a), the court may:
- (1) appoint a receiver of the distributions subject to the charging order, with the power to make all inquiries the judgment debtor might have made; and
- (2) make all other orders necessary to give effect to the charging order.
- (c) Upon a showing that distributions under a charging order will not pay the judgment debt within a reasonable time, the court may foreclose the lien and order the sale of the transferable interest. The purchaser at the foreclosure sale only obtains the transferable interest, does not thereby become a member, and is subject to Section 502.
 - (d) At any time before foreclosure under subsection (c), the member or transferee whose

1	transferable interest is subject to a charging order under subsection (a) may extinguish the
2	charging order by satisfying the judgment and filing a certified copy of the satisfaction with the
3	court that issued the charging order.

- (e) At any time before foreclosure under subsection (c), a limited liability company or one or more members whose transferable interests are not subject to the charging order may pay to the judgment creditor the full amount due under the judgment and thereby succeed to the rights of the judgment creditor, including the charging order.
- (f) This [act] does not deprive any member or transferee of the benefit of any exemption laws applicable to the member's or transferee's transferable interest.
- (g) This section provides the exclusive remedy by which a person seeking to enforce a judgment against a member or transferee may, in the capacity of judgment creditor, satisfy the judgment from the judgment debtor's transferable interest.

SECTION 504. POWER OF PERSONAL REPRESENTATIVE OF DECEASED MEMBER. If a member dies, the deceased member's personal representative or other legal representative may exercise the rights of a transferee provided in Section 502(c) and, for the purposes of settling the estate, the rights of a current member under Section 410.

1 [ARTICLE] 6 2 MEMBER'S DISSOCIATION 3 SECTION 601. MEMBER'S POWER TO DISSOCIATE; WRONGFUL 4 DISSOCIATION. 5 (a) A person has the power to dissociate as a member at any time, rightfully or wrongfully, by withdrawing as a member by express will under Section 602(1). 45 6 7 (b) A person's dissociation from a limited liability company is wrongful only if the 8 dissociation: 9 (1) is in breach of an express provision of the operating agreement; or 10 (2) occurs before the termination of the company and: 11 (A) the person withdraws as a member by express will; 12 (B) the person is expelled as a member by judicial order under Section 13 602(5); 14 (C) the person is dissociated under Section 602(7)(A) by becoming a 15 debtor in bankruptcy; or 16 (D) in the case of a person that is not a trust other than a business trust, an 17 estate, or an individual, the person is expelled or otherwise dissociated as a member because it 18 willfully dissolved or terminated. 19 (c) A person that wrongfully dissociates as a member is liable to the limited liability 20 company and, subject to Section 901, to the other members for damages caused by the 21 dissociation. The liability is in addition to any other debt, obligation, or other liability of the 22 member to the company or the other members.

6	(2) an event stated in the operating agreement as causing the person's dissociation occurs
7	(3) the person is expelled as a member pursuant to the operating agreement;
8	(4) the person is expelled as a member by the unanimous consent of the other members if
9	(A) it is unlawful to carry on the company's activities with the person as a
10	member;
11	(B) there has been a transfer of all of the person's transferable interest in the
12	company, other than:
13	(i) a transfer for security purposes; or
14	(ii) a charging order in effect under Section 503 which has not been
15	foreclosed;
16	(C) the person is a corporation and, within 90 days after the company notifies the
17	person that it will be expelled as a member because the person has filed a certificate of
18	dissolution or the equivalent, its charter has been revoked, or its right to conduct business has
19	been suspended by the jurisdiction of its incorporation, the certificate of dissolution has not been
20	revoked or its charter or right to conduct business has not been reinstated; or
21	(D) the person is a limited liability company or partnership that has been
22	dissolved and whose business is being wound up;
23	(5) on application by the company, the person is expelled as a member by judicial order
24	because the person:

1	(A) has engaged, or is engaging, in wrongful conduct that has adversely and
2	materially affected, or will adversely and materially affect, the company's activities;
3	(B) has willfully or persistently committed, or is willfully and persistently
4	committing, a material breach of the operating agreement or the person's duties or obligations
5	under Section 409; or
6	(C) has engaged in, or is engaging, in conduct relating to the company's activities
7	which makes it not reasonably practicable to carry on the activities with the person as a member;
8	(6) in the case of a person who is an individual:
9	(A) the person dies; or
10	(B) in a member-managed limited liability company:
11	(i) a guardian or general conservator for the person is appointed; or
12	(ii) there is a judicial order that the person has otherwise become incapable
13	of performing the person's duties as a member under [this act] or the operating agreement;
14	(7) in a member-managed limited liability company, the person:
15	(A) becomes a debtor in bankruptcy;
16	(B) executes an assignment for the benefit of creditors; or
17	(C) seeks, consents to, or acquiesces in the appointment of a trustee, receiver, or
18	liquidator of the person or of all or substantially all of the person's property;
19	(8) in the case of a person that is a trust or is acting as a member by virtue of being a
20	trustee of a trust, the trust's entire transferable interest in the company is distributed;
21	(9) in the case of a person that is an estate or is acting as a member by virtue of being a
22	personal representative of an estate, the estate's entire transferable interest in the company is
23	distributed;
24	(10) in the case of a member that is not an individual, partnership, limited liability

1	company, corporation, trust, or estate, the termination of the member;
2	(11) the company participates in a merger under [Article] 10, if:
3	(A) the company is not the surviving entity; or,
4	(B) otherwise as a result of the merger, the person ceases to be a member;
5	(12) the company participates in a conversion under [Article] 10;
6	(13) the company participates in a domestication under [Article] 10, if, as a result of the
7	domestication, the person ceases to be a member; or
8	(14) the company terminates.
9	SECTION 603. EFFECT OF PERSON'S DISSOCIATION AS MEMBER.
10	(a) When a person is dissociated as a member of a limited liability company:
11	(1) the person's right to participate as a member in the management and conduct
12	of the company's activities terminates;
13	(2) if the company is member-managed, the person's fiduciary duties as a member
14	end with regard to matters arising and events occurring after the person's dissociation; and
15	(3) subject to Section 504 and [Article] 10, any transferable interest owned by the
16	person immediately before dissociation in the person's capacity as a member is owned by the
17	person solely as a transferee.
18	(b) A person's dissociation as a member of a limited liability company does not of itself
19	discharge the person from any debt, obligation, or other liability to the company or the other
20	members which the person incurred while a member.

2	DISSOLUTION AND WINDING UP
3	SECTION 701. EVENTS CAUSING DISSOLUTION.
4	(a) A limited liability company is dissolved, and its activities must be wound up, upon the
5	occurrence of any of the following:
6	(1) an event or circumstance that the operating agreement states causes
7	dissolution;
8	(2) the consent of all the members;
9	(3) the passage of 90 consecutive days during which the company has no
10	members;
11	(4) on application by a member, the entry by [appropriate court] of an order
12	dissolving the company on the grounds that:
13	(A) the conduct of all or substantially all of the company's activities is
14	unlawful; or
15	(B) it is not reasonably practicable to carry on the company's activities in
16	conformity with the certificate of organization and the operating agreement; or
17	(5) on application by a member, the entry by [appropriate court] of an order
18	dissolving the company on the grounds that the managers or those members in control of the
19	company:
20	(A) have acted, are acting, or will act in a manner that is illegal or
21	fraudulent; or
22	(B) have acted or are acting in a manner that is oppressive and was, is, or
23	will be directly harmful to the applicant.
24	(b) In a proceeding brought under subsection (a)(5), the court may order a remedy other

1 than dissolution. 2 SECTION 702. WINDING UP. 3 (a) A dissolved limited liability company shall wind up its activities, and the company 4 continues after dissolution only for the purpose of winding up. 5 (b) In winding up its activities, a limited liability company: 6 (1) shall discharge the company's debts, obligations, or other liabilities, settle and 7 close the company's activities, and marshal and distribute the assets of the company; and 8 (2) may: 9 (A) deliver to the [Secretary of State] for filing a statement of dissolution 10 stating the name of the company and that the company is dissolved; 11 (B) preserve the company activities and property as a going concern for a 12 reasonable time; 13 (C) prosecute and defend actions and proceedings, whether civil, criminal, 14 or administrative: 15 (D) transfer the company's property; 16 (E) settle disputes by mediation or arbitration; 17 (F) deliver to the [Secretary of State] for filing a statement of termination, 18 stating the name of the company and that the company is terminated and including any other information the limited liability company determines; and 19 20 (G) perform other acts necessary or appropriate to the winding up. 21 (c) If a dissolved limited liability company has no members, the legal representative of 22 the last person to have been a member may wind up the activities of the company. If the person 23 does so, the person has the powers of a sole manager under Section 407(c) and is deemed to be a 24 manager for the purposes of Section 304(a)(2).

1	(d) If the legal representative under subsection (c) declines or fails to wind up the
2	company's activities, a person may be appointed to do so by the consent of transferees owning a
3	majority of the rights to receive distributions as transferees at the time the consent is to be
4	effective. A person appointed under this subsection:
5	(1) has the powers of a sole manager under Section 407(c) and is deemed to be a
6	manager for the purposes of Section 304(a)(2); and
7	(2) shall promptly deliver to the [Secretary of State] for filing an amendment to
8	the company's certificate of organization to:
9	(A) state that the company has no members;
10	(B) state that the person has been appointed pursuant to this subsection to
11	wind up the company; and
12	(C) provide the street and mailing addresses of the person.
13	(e) The [appropriate court] may order judicial supervision of the winding up of a
14	dissolved limited liability company, including the appointment of a person to wind up the
15	company's activities:
16	(1) on application of a member, if the applicant establishes good cause;
17	(2) on the application of a transferee, if:
18	(A) the company does not have any members;
19	(B) the legal representative of the last person to have been a member
20	declines or fails to wind up the company's activities; and
21	(C) within a reasonable time following the dissolution a person has not
22	been appointed pursuant to subsection (c); or
23	(3) in connection with a proceeding under Section 701(a)(4) or (5).
24	SECTION 702B. REVERSING DISSOLUTION. At any time after the dissolution of

1	a limited liability company and before the winding up of its business is completed, all of the
2	members may waive the right to have the partnership's business wound up and the partnership
3	terminated. In that event:
4	(1) the limited liability company resumes carrying on its business as if dissolution had
5	never occurred, and any liability incurred by the limited liability company after the dissolution
6	and before the waiver is determined as if dissolution had never occurred; and
7	(2) the rights of a third party ⁴⁶ arising out of conduct in reliance on the dissolution before
8	the third party knew or received a notification of the waiver may not be adversely affected.
9	SECTION 703. KNOWN CLAIMS AGAINST DISSOLVED LIMITED
10	LIABILITY COMPANY. ⁴⁷
11	(a) Except as otherwise provided in subsection (d), a dissolved limited liability company
12	may give notice of a known claim under subsection (b), which has the effect as provided in
13	subsection (c).
14	(b) A dissolved limited liability company may in a record notify its known claimants of
15	the dissolution. The notice must:
16	(1) specify the information required to be included in a claim;
17	(2) provide a mailing address to which the claim is to be sent;
18	(3) state the deadline for receipt of the claim, which may not be less than 120 days
19	after the date the notice is received by the claimant; and
20	(4) state that the claim will be barred if not received by the deadline.
21	(c) A claim against a dissolved limited liability company is barred if the requirements of

2	(2) if the claim is timely received but rejected by the company:
3	(A) the company causes the claimant to receive a notice in a record stating
4	that the claim is rejected and will be barred unless the claimant commences an action against the
5	company to enforce the claim within 90 days after the claimant receives the notice; and
6	(B) the claimant does not commence the required action within the 90

10	SECTION 704. OTHER CLAIMS AGAINST DISSOLVED LIMITED LIABILITY

15	(b) The notice authorized by subsection (a) must:

20	(2) describe the information required to be contained in a claim and provide a
21	mailing address to which the claim is to be sent; and

(c) If a dissolved limited liability company publishes a notice in accordance with subsection (b), unless the claimant commences an action to enforce the claim against the company within five years after the publication date of the notice, the claim of each of the following claimants is barred:

(1) a claimant that did not receive notice in a record⁴⁹ under Section 703;

(2) a claimant whose claim was timely sent to the company but not acted on; and

(3) a claimant whose claim is contingent at, or based on an event occurring after,

(d) A claim not barred under this section or Section 703 may be enforced:

(1) against a dissolved limited liability company, to the extent of its undistributed assets; and

(2) except as provided in Section 704A(d), if assets of the company have been distributed after dissolution, against a member or transferee to the extent of that person's proportionate share of the claim or of the assets distributed to the member or transferee after dissolution, whichever is less, but a person's total liability for all claims under this paragraph does not exceed the total amount of assets distributed to the person after dissolution.

2 SECTION 706. REINSTATEMENT FOLLOWING ADMINISTRATIVE

DISSOLUTION.

(a) A limited liability company that is dissolved administratively under Section 705 may apply to the [Secretary of State] for reinstatement within two years after the effective date of dissolution. The application must state:

(1) the name of the company at the time of its administrative dissolution and, if needed, a different name that satisfies Section 108

- (2) the address of the principal⁶⁰ office of the limited liability company and the name and address of the registered agent;
 - (3) the effective date of limited liability company's dissolution; and
- 12 (4) that the grounds for dissolution either did not exist or have been eliminated;
 - (b) To be reinstated, a limited liability company must pay all fees, taxes, and penalties that were due to the [Secretary of State] at the time of its administrative dissolution and all fees, taxes, and penalties that would have been due to the [Secretary of State] while the limited liability company was dissolved administratively.

(c) If the [Secretary of State] determines that an application contains the information required by subsection (a), is satisfied that the information is correct, and determines that all payments required to be made to the [Secretary of State] by subsection (b) have been made, the [Secretary of State] shall cancel the declaration of dissolution and prepare a statement, of reinstatement that states the [Secretary of State's] determination and the effective date of restatement, file the original of the stateement, and serve a copy on the limited liability.

8	bylaws, and other agreements among its shareholders which are authorized by its governing
9	statute, or comparable records as provided in its governing statute; and
10	(F) for any other organization, the basic records that create the organization and
11	determine its internal governance and the relations among the persons that own it, have an
12	interest in it, or are members of it.
13	(11) "Personal liability" means liability for a debt, obligation, or other liability of an
14	organization which is imposed on a person that co-owns, has an interest in, or is a member of the
15	organization:
16	(A) by the governing statute solely by reason of the person co-owning, having an
17	interest in, or being a member of the organization; or
18	(B) by the organization's organizational documents under a provision of the
19	governing statute authorizing those documents to make one or more specified persons liable for
20	all or specified debts, obligations, or other liabilities of the organization solely by reason of the
21	person or persons co-owning, having an interest in, or being a member of the organization.
22	(12) "Surviving organization" means an organization into which one or more other
23	organizations are merged whether the organization preexisted the merger or was created by the

1	SECTION 1002. MERGER.
2	(a) A limited liability company may merge with one or more other constituent
3	organizations pursuant to this section, Sections 1003 through 1005, and a plan of merger, if:

21	SECTION 1003. ACTION ON PLAN OF MERGER BY CONSTITUENT
22	LIMITED LIABILITY COMPANY.
23	(a) Subject to Section 1014, a plan of merger must be consented to by all the members of
24	a constituent limited liability company.

1	(b) Subject to Section 1014 and any contractual rights, after a merger is approved, and at

7	(7) if the surviving organization is a foreign organization not authorized to

9	State] may use for the purposes of Section 1005(b); and
10	(8) any additional information required by the governing statute of any constituent
11	organization.
12	(c) Each constituent limited liability company shall deliver the articles of merger for
13	filing in the [office of the Secretary of State].
14	(d) A merger becomes effective under this [article]:
15	(1) if the surviving organization is a limited liability company, upon the later of:
16	(A) compliance with subsection (c); or
17	(B) subject to Section 205(c), as specified in the articles of merger; or
18	(2) if the surviving organization is not a limited liability company, as provided by
19	the governing statute of the surviving organization.
20	SECTION 1005. EFFECT OF MERGER.
21	(a) When a merger becomes effective:
22	(1) the surviving organization continues or comes into existence;
23	(2) each constituent organization that merges into the surviving organization
24	ceases to exist as a separate entity;

1	(3) an property owned by each constituent organization that ceases to exist vests

12	(8) except as otherwise agreed, if a constituent limited liability company ceases to
13	exist, the merger does not dissolve the limited liability company for the purposes of [Article] 7;
14	(9) if the surviving organization is created by the merger:
15	(A) if it is a limited liability company, the certificate of organization
16	becomes effective; or
17	(B) if it is an organization other than a limited liability company, the
18	organizational document that creates the organization becomes effective; and
19	(10) if the surviving organization preexisted the merger, any amendments
20	provided for in the articles of merger for the organizational document that created the
21	organization become effective.
22	(b) A surviving organization that is a foreign organization consents to the jurisdiction of
23	the courts of this state to enforce any debt, obligation, or other liability owed by a constituent
24	organization, if before the merger the constituent organization was subject to suit in this state on

the debt, obligation, or other liability. A surviving organization that is a foreign organization and not authorized to transact business in this state appoints the [Secretary of State] as its agent for service of process for the purposes of enforcing a debt, obligation, or other liability under this subsection. Service on the [Secretary of State] under this subsection must be made in the same manner and has the same consequences as in Section 116(c) and (d). SECTION 1006. CONVERSION. (a) An organization other than a limited liability company or a foreign limited liability company may convert to a limited liability company, and a limited liability company may convert to an organization other than a foreign limited liability company pursuant to this section, Sections 1007 through 1009, and a plan of conversion, if: (1) the other organization's governing statute authorizes the conversion; (2) the conversion is not prohibited by the law of the jurisdiction that enacted the other organization's governing statute; and (3) the other organization complies with its governing statute in effecting the conversion. (b) A plan of conversion must be in a record and must include: (1) the name and form of the organization before conversion; (2) the name and form of the organization after conversion; (3) the terms and conditions of the conversion, including the manner and basis for converting interests in the converting organization into any combination of money, interests in the converted organization, and other consideration; and (4) the organizational documents of the converted organization that are, or are
