1. Name Change Request

A motion was made and approved that the name of the Revised Uniform Disposition of Community Property Rights at Death Act be changed to the *Uniform Community Property Disposition at Death Act*.

A motion was made and approved granting privileges of the floor to reporters, ABA advisors, and selected observers to drafting committees. A list of individuals who were approved is included as Appendix A.

3. Drafting Committee Updates

Chair Robbins reported on drafting committee developments:

- a. The UCC and Emerging Technologies Committee will continue to draft but will not have a first reading in September.
- b. The Fundraising Through Public Appeals Act will move to inactive status.
- c. The Registration and Licensing of Direct-to-Consumer Sales of Wine and the Prevention of Illegal Sales Committee will not read in September. The chair and reporter will continue to talk to stakeholders and consider adjusting the scope of the project, possibly with a greater emphasis on enforcement.
