

## **Minutes**

### **Web and Audio Conference of the Executive Committee Uniform Law Commission**

June 29, 2021  
Chicago, IL

Daniel Robbins, Chair of the Executive Committee, called the meeting to order on June 29, 2021, at 2:02 p.m. Chicago Time.

The following members of the Committee were present: Carl H. Anita Ramasastry, Immediate Past President, did not attend the meeting.

Also present: Tim Schnabel, Executive Director; Elizabeth Cotton-Murphy, Chief Administrative Officer; Ben Orzeske, Chief Counsel; and Katie Robinson, Legislative Program Director.

#### 1. Minutes

A motion was made and approved accepting the minutes of the Executive Committee Meeting held May 4, 2021.

#### 2. Request for name change

A motion was made and approved that the name of the Uniform College Athlete Name, Image and Likeness Issues Act be changed to the *Uniform College Athlete Name, Image or Likeness Act*.

A motion was made and approved that the name of the Unregulated Transfers of Adopted Children Act be changed to the *Unregulated Child Custody Transfer Act*.

A motion was made and approved that the name of the Uniform Covenants Not to Compete Act remain unchanged.

#### 3. Request for Uniform Designation

A motion was made and approved designating the Unregulated Child Custody Transfer Act and the Community Property Disposition at Death Act as Uniform Acts.

#### 4. Request for Privilege of the Floor

A motion was made and approved granting privileges of the floor to reporters, ABA advisors, and selected observers to drafting committees. A list of individuals who were approved is included as Appendix A.

5. Request for Waiver of Line-by-Line Reading

A motion was made and approved granting the requests for a waiver of line-by-line reading of certain sections of the following acts pursuant to ULC Bylaw 44A.4: Uniform Community Property Disposition at Death Act; Uniform Cohabitants' Economic Rights Act; and Uniform Commercial Code and Emerging Technologies.

6. Annual Meeting Discussion

President Lisman reported on plans for the 2021 hybrid annual meeting.

7. Health Law JEB Consideration

Executive Director Tim Schnabel summarized the written proposal submitted for the Committee's consideration. The goal of creating a JEB on this topic would be to draw on outside expertise in identifying possible new projects, hopefully leading to a more productive exploration of this area of law.

After discussion, a motion was made and approved discharging the Committee to Monitor Developments in Healthcare Law and authorizing the creation of a Joint Editorial Board on Health Law.

The meeting was adjourned at 2:30 p.m. Central Time.
