## Open Letter from NCCUSL President

To Persons Writing Letters:

I have been receiving a number of letters, addressed to me as President of the National Conference of Commissioners on Uniform State Laws, from individuals expressing concerns about the impact that Article 2B of the Uniform Commercial Code might have on consumers, software developers, and others, and suggesting delay of any approval of Article 2B by both NCCUSL and the American Law Institute. Those concerns have been passed on to the Drafting Committee, and will continue to be addressed by the Committee, and I am sure, by the general membership of both organizations.

As to the suggested delay of final approval, my letter of May 6, 1998, which has also been posted at <http://www.law.upenn.edu/library/ulc/ulc.htm>, sets forth the anticipated schedule for both NCCUSL and the Institute for further action on Article 2B. Interested parties are urged to get any specific proposed changes to the NCCUSL office, with explanations, by October 10, 1998, in order for them to be circulated to the Drafting Committee before its November 1998 meeting.
