6	<b>1. Introduction.</b> This draft contains proposed statutory text only, with the
7	exception of this Prefatory Comment, Reporters' Comments to new Part 7 (transition
8	provisions), Reporters' Comments to Appendix I (related and conforming revisions of
9	other articles of the Uniform Commercial Code ("UCC), and Reporters' Comments
10	to Appendix II (model provisions for production-money priority).
11	The draft has been revised to take account of the Drafting Committee's
12	deliberations during its March, 1998, meeting, which was its last formal meeting.
13	However, the Drafting Committee has not yet reviewed the revisions. The draft is
14	submitted for final approval by the membership of the American Law Institute ("ALI )
15	. It will receive a final reading by the membership of the National Conference of
16	Commissioners on Uniform State Laws ("NCCUSL) during its 1998 Annual Meeting.
17	We expect the final version of the text and Official Comments to be ready for
18	submission to state legislatures early in 1999.
19	2. Background and History of Article 9 Revisions.
20	In 1990, the Permanent Editorial Board for the Uniform Commercial Code
20	("PEB ), with the support of its sponsors, the ALI and NCCUSL, established a
21	committee ("Study Committee ) to study Article 9 of the UCC. The PEB charged the
22	Study Committee to consider whether Article 9 and related provisions of the UCC are
24	in need of revision. The PEB also requested the Study Committee to recommend the
25	nature and the substance of any revisions that it thought desirable. The Study
26	Committee issued its report as of December 1, 1992 ("Report ).
20	Commune issued its report as of December 1, 1992 (Treport ).
27	The principal recommendation of the Report called for the creation of a
28	drafting committee ("Drafting Committee ) for the revision of Article 9. The Report
29	also recommended numerous specific changes to Article 9. The ALI and NCCUSL
30	acted favorably upon the Report's principal recommendation. The Drafting
31	Committee was organized in 1993.
32	3. Status and Schedule.
22	
33	The Drafting Committee has met fourteen times (November, 1993; March,
34	1994; September-October, 1994; December, 1994; March, 1995; June, 1995;

1 December, 1995; March, 1996; June, 1996; November, 1996; March, 1997; 2 November, 1997; February, 1998; and March, 1998). Meetings of the ALI Members 3 Consultative Group on Article 9 were held on December 16-17, 1994, November 17, 4 1995, and October 31, 1996. NCCUSL considered the 1995 Annual Meeting Draft of 5 revised Article 9 at its annual meeting in August, 1995, the 1996 Annual Meeting 6 Draft of revised Article 9 at its annual meeting in July, 1996, and the 1997 Annual 7 Meeting Draft of revised Article 9 at its annual meeting in July, 1997. The ALI 8 Council reviewed Council Draft No. 1 (November 15, 1995) at its meeting on 9 December 8, 1995, Council Draft No. 2 (November 15, 1996) at its meeting on 10 December 13, 1996, and Council Draft No. 3 (November 20, 1997) at its meeting on December 11, 1997. The Chair of the Drafting Committee and the Reporters made 11 12 informational reports to the membership of the ALI during its annual meetings in May, 1995, May, 1996, and May, 1997. The draft before the ALI membership at its May, 13 14 1997, meeting was Discussion Draft No. 2 (April 14, 1997).

## 4. Reorganization and Renumbering; Style.

16 Discussion Draft No. 2 reflected a substantial reorganization of Article 9 and 17 renumbering of many sections. That reorganization and renumbering largely survives 18 in this draft. However, during the last year's drafting process several sections have 19 been deleted and several have been added or subdivided. Consequently, some sections 20 in this draft are missing and some have a suffix "A or "B. The draft to be submitted 21 to the NCCUSL Annual Meeting in 1998 will be renumbered consecutively and its 22 cross-references will be adjusted accordingly. In addition, that draft may reorder 23 certain sections and will reflect revisions suggested by NCCUSL's Committee on Style, which will consider the draft at its meeting on April 17, 1998. 24

### 5. Summary of Revisions.

Following is a brief summary of some of the more significant proposed revisions of Article 9 that are included in the draft. The summary focuses on substantive revisions that would change current law. No effort is made to summarize all of the proposed revisions of Article 9.

- 30 a. Scope of Article 9.
- 31 The draft expands the scope of Article 9 in several respects.

32 *Deposit accounts.* Section 9-112 includes within Article 9's scope deposit 33 accounts as original collateral, except in consumer transactions. Current Article 9 34 deals with deposit accounts only as proceeds of other collateral.

1 Sales of payment intangibles. Section 9-112 also includes within the scope of 2 Article 9 most sales of "payment intangibles, defined in Section 9-103 as general 3 intangibles under which an account debtor's principal obligation is a monetary 4 obligation. Current Article 9 includes sales of accounts and chattel paper, but not sales 5 of payment intangibles. In its inclusion of sales of payment intangibles, the draft 6 continues the drafting convention found in current Article 9, which provides that the 7 sale of accounts, chattel paper, or payment intangibles creates a "security interest. 8 The definition of "account in Section 9-103 has been expanded to include various 9 rights to payment that would be general intangibles under current Article 9.

Sales of promissory notes. Under the draft the scope of Article 9 also includes
 sales of promissory notes. See Section 9-102 (defining "promissory note), 9-112.
 The Drafting Committee, as well as a task force organized to advise it, concluded that
 sales of these rights to payment should not be distinguished from sales of payment
 intangibles.

Healthcare insurance receivables. Section 9-112 narrows Article 9's exclusion
 of transfers of interests in insurance policies by carving out "healthcare insurance
 receivables (defined in Section 9-103) transferred by or to a healthcare provider. See
 Section 9-112. A healthcare insurance receivable is included within the definition of
 "account in Section 9-103.

20 Nonpossessory statutory agricultural liens. Section 9-112 brings 21 nonpossessory statutory agricultural liens within the scope of Article 9. See Section 22 9-112. In doing so, it relies heavily upon the report and recommendations of the 23 Article 9 Task Force of the Subcommittee on Agricultural and Agri-Business 24 Financing, Committee on Commercial Financial Services, Section of Business Law, 25 American Bar Association ("Agricultural Financing Task Force). However, unlike Discussion Draft No. 2, this draft no longer extends the scope of Article 9 to statutory 26 27 liens other than agricultural liens.

*Consignments.* Section 9-112 provides that "true consignments–bailments for
 the purpose of sale by the bailee–are security interests covered by Article 9, with
 certain exceptions. See Sections 9-102 (defining "consignment ), 9-112. Currently,
 many consignments are subject to Article 9's filing requirements by operation of
 Section 2-326.

*Support obligations and property securing rights to payment.* The draft also addresses explicitly (i) obligations, such as guaranties and letters of credit, that support payment or performance of collateral such as accounts, chattel paper, and payment intangibles, and (ii) and property (including real property) that secures a right to payment that is subject to an Article 9 security interest. See Sections 9-203, 9-308. 1 *Commercial tort claims.* Section 9-112 expands the scope of Article 9 to 2 include the assignment of commercial tort claims by narrowing the exclusion of tort 3 claims generally. However, the draft continues to exclude tort claims for bodily injury 4 or other non-business tort claims of a natural person. See Section 9-102 (defining 5 "commercial tort claim ).

6 *Transfers by States and governmental units of States.* Section 9-112 narrows 7 the exclusion of transfers by States and their governmental units. It excludes only 8 transfers covered by another statute (other than a statute generally applicable to 9 security interests), to the extent the statute governs the creation, perfection, priority, 10 or enforcement of security interests.

*Nonassignable general intangibles, healthcare insurance receivables, and letter-of-credit rights.* Finally, the draft enables a security interest to attach to letter-ofcredit rights, healthcare insurance receivables, and general intangibles, including contracts, permits, licenses, and franchises, notwithstanding a contractual or statutory prohibition against or limitation on assignment. The draft explicitly protects third parties against any adverse effect of the creation or attempted enforcement of the security interest. See Sections 9-406 and 9-406A.

18 Subject to these exceptions and two others (Sections 9-404B, concerning 19 accounts, chattel paper, and payment intangibles, and 9-405, concerning interests in 20 leased goods), Section 9-401 establishes a baseline rule that the inclusion of 21 transactions and collateral within the scope of Article 9 has no effect on non-Article 22 9 law dealing with the alienability or inalienability of property. For example, if the 23 assignment of a commercial tort claim is invalid under other applicable law, the fact 24 that a security interest in the claim is within the scope of Article 9 does not override 25 the other applicable law.

26 **b.** Choice of Law.

The choice-of-law rules for the law governing perfection, the effect of perfection or nonperfection, and priority are found in Part 3, Subpart 1, of the draft (Sections 9-301 through 9-307).

30 *Where to file: Location of debtor.* The draft changes the choice-of-law rule 31 governing perfection (i.e., where to file) for most collateral to the law of the 32 jurisdiction where the debtor is located. See Section 9-301. Under current law, the 33 jurisdiction of the debtor's location governs only perfection and priority of a security 34 interest in accounts, general intangibles, mobile goods, and, for purposes of perfection 35 by filing, chattel paper and investment property.

1 Determining debtor's location. As a general matter, Section 9-307 of the draft 2 follows current law, under which the location of the debtor is the debtor's place of 3 business (or chief executive office, if the debtor has more than one place of business). 4 Section 9-307 provides three exceptions. First, a "registered organization, such as a 5 corporation or limited liability company, is located in the State under whose law the 6 debtor is organized, e.g., a corporate debtor's State of incorporation. Second, an 7 individual debtor (i.e., human being) is located at his or her principal residence. Third, 8 the draft contains special rules for determining the location of the United States and 9 registered organizations organized under the law of the United States.

10 *Location of non-U.S. debtors.* If, applying the foregoing rules, a debtor is 11 located in a jurisdiction whose laws do not require public notice as a condition of 12 perfection of a security interest, the entity is deemed located in the District of 13 Columbia. See Section 9-307. Thus, to the extent that revised Article 9 applies to 14 non-U.S. debtors, perfection could be accomplished in many cases by a domestic 15 filing.

*Priority.* For tangible collateral such as goods and instruments, Section 9-301
 provides that the law applicable to priority and the effect of perfection or nonperfection
 will remain the law of the jurisdiction where the collateral is located, as under current
 law. For intangible collateral, such as accounts, the applicable law for priority will be
 that of the jurisdiction in which the debtor is located.

*Agricultural liens.* Section 9-302 provides that perfection, the effect of
 perfection or nonperfection, and priority of an agricultural lien are governed by the law
 of the jurisdiction where the farm products subject to the lien are located.

Goods covered by certificates of title; deposit accounts; letter-of-credit rights; *investment property*. The draft also includes several refinements to the treatment of
choice-of-law matters for goods covered by certificates of title. See Section 9-303.
It also provides special choice-of-law rules, similar to those for investment property
under current Articles 8 and 9, for deposit accounts (Section 9-304), letter-of-credit
rights (Section 9-304A), and investment property (Section 9-305).

- 30 c. Duties of Secured Party.
- 31 The draft provides for expanded duties of secured parties.

*Release of control.* Section 9-208 of the draft imposes upon a secured party with control over a deposit account, investment property, or letter-of-credit rights the duty to release control when there is no secured obligation and no commitment to give value. Section 9-208A contains analogous provisions when an account debtor has been notified to pay a secured party. 1 *Information.* Section 9-209 of the draft expands a secured party's duties to 2 provide the debtor with information concerning collateral and the obligations that it 3 secures.

## d. Perfection.

4

5 The rules governing perfection of security interests and agricultural liens are 6 found in Part 3, Subpart 2, of the draft (Sections 9-308 through 9-314).

7 Deposit accounts; letter-of-credit rights: Control. With certain exceptions, 8 the draft provides that a security interest in a deposit account or letter-of-credit rights may be perfected *only* by the secured party's acquiring "control over the deposit 9 10 account or letter-of-credit rights. See Sections 9-310 and 9-312. Under Section 9-109, 11 a secured party has "control of a deposit account when, with the consent of the debtor, 12 the secured party obtains the depositary bank's agreement to act on the secured party's 13 instructions (including when the secured party becomes the account holder) or when 14 the secured party is itself the depositary bank. The control requirements are patterned 15 on current Section 8-106, which specifies the requirements for control over investment 16 property. Under Section 9-110, "control of a letter-of-credit right occurs when the 17 issuer or nominated person consents to an assignment of proceeds or the letter-of-18 credit is transferred to the secured party.

*Investment property: Control.* The perfection requirements for "investment
 property (defined in Section 9-107), including perfection by control under Section 9 108, remain substantially as under current law. However, a new provision in Section
 9-312 is designed to ensure that a secured party remains in control in "repledge
 transactions that are typical in the securities markets.

24 *Electronic chattel paper: Control.* Responding to industry requests concerning 25 emerging practices in electronic contracting and to the suggestions of a working group established within the ABA Business Law Section, Section 9-102 of the draft includes 26 27 a new defined term: "electronic chattel paper. This type of collateral is chattel paper 28 that consists of information stored in an electronic medium and retrievable in 29 perceivable form (i.e., it is not written). Perfection of a security interest in electronic 30 chattel paper may be by control or filing. See Sections 9-110A (sui generis definition 31 of control over electronic chattel paper), 9-312 (perfection by control), 9-310 (filing).

*Instruments, agricultural liens, and commercial tort claims: Filing.* The draft expands the types of collateral in which a security interest may be perfected by filing to include instruments. See Section 9-310. Agricultural liens and security interests in commercial tort claims also are perfected by filing, under the draft. See Sections 9-308 and 9-309.

1 Sales of payment intangibles and promissory notes: Automatic perfection. 2 Current Article 9 covers the outright sale of accounts and chattel paper. The Drafting 3 Committee recognizes that sales of most other types of receivables likewise are 4 financing transactions to which Article 9 should apply. Accordingly, Section 9-103 5 expands the definition of "account to include many types of receivables that Article 6 9 currently classifies as "general intangibles, including the newly defined "healthcare 7 insurance receivable. It thereby subjects to Article 9's filing system sales of more 8 types of receivables than does current law. Certain sales of payment 9 intangibles-primarily bank loan participation transactions-should not be subject to the 10 Article 9 filing rules. These transactions fall in a residual category of collateral, "payment intangibles (general intangibles under which the account debtor's principal 11 obligation is monetary), the sale of which is exempt from the filing requirements of 12 13 Article 9. See Sections 9-103, 9-112, 9-308A (perfection upon attachment). The 14 perfection rules for sales of promissory notes are the same as those for sales of 15 payment intangibles.

16 *Possessory security interests.* Several provisions of the draft address aspects 17 of security interests when the secured party or a third party is in possession of the 18 collateral. In particular, Section 9-311 resolves a number of uncertainties under current law. It provides that a security interest in collateral in the possession of a third 19 20 party is perfected when the third party acknowledges in an authenticated record that 21 it holds for the secured party's benefit. Section 9-311 also provides that a third party 22 need not so acknowledge and that its acknowledgment does not impose any duties on 23 it, unless it otherwise agrees. A special rule in Section 9-311 (which did not appear 24 in Discussion Draft No. 2) provides that if a secured party is already in possession of 25 collateral, its security interest remains perfected by possession if it delivers the 26 collateral to a third party accompanied by instructions to hold it for the secured party 27 or to redeliver it to the secured party. The draft also clarifies the circumstances under 28 which a security interest in goods covered by a certificate of title may be perfected by 29 the secured party's taking possession.

30 Automatic perfection. Section 9-308A of the draft lists various types of 31 security interests as to which no public-notice step is required for perfection (e.g., purchase-money security interests in consumer goods other than automobiles). This 32 automatic perfection also extends to a transfer of a healthcare insurance receivable to 33 34 a healthcare provider. Those transfers normally will be made by natural persons who 35 receive healthcare services; the Drafting Committee saw little value in requiring filing 36 for perfection in that context. Automatic perfection also applies to security interests 37 created by sales of payment intangibles and promissory notes. Section 9-308 provides 38 that a perfected security interest in collateral supported by a "support obligation (such 39 as an account supported by a guaranty) also is a perfected security interest in the support obligation, and that a perfected security interest in an obligation secured by a 40

security interest or lien on property (e.g., a real estate mortgage) also is a perfected
 security interest in the security interest or lien.

3 e. Priority.

4 The rules governing priority of security interests and agricultural liens are 5 found in Part 3, Subpart 3, of the draft (Sections 9-315 through 9-336). The draft 6 includes several new priority rules.

7 Purchase-money security interests: Definition; inventory. Section 9-104 of 8 the draft substantially rewrites the definition of purchase-money security interest 9 (PMSI). The substantive changes, however, apply only to non-consumer-goods 10 transactions. (Consumer transactions and consumer-goods transactions are discussed 11 below in part 5.i.) The definition makes clear that a security interest in collateral may 12 be (to some extent) both a PMSI as well as a non-PMSI, in accord with the "dual 13 status rule applied by some courts under current law (thereby rejecting the "transformation rule). The definition provides an even broader definition of a PMSI 14 15 in inventory, yielding a result that accords with private agreements entered into in response to the uncertainty of current law. It also treats consignments as purchase-16 17 money security interests in inventory. Section 9-322 of the draft revises the PMSI 18 priority rules, but for the most part without material change in substance. However, 19 an Official Comment will make clear that a secured party that holds a possessory 20 purchase-money security interest in inventory that has not been delivered to the debtor 21 need not give notice to the holder of a conflicting security interest in order to achieve 22 PMSI priority. Section 9-322 also clarifies the priority rules for competing PMSIs in the same collateral. 23

*Purchase-money security interests in livestock; agricultural liens.* Section 9 322 of the draft follows the Agricultural Financing Task Force's recommendation to
 provide a special PMSI priority, similar to the inventory PMSI priority rule, for
 livestock. Section 9-319 (which contains the baseline first-to-file-or-perfect priority
 rule) also follows the Task Force's recommendations on special non-Article 9 priority
 rules for agricultural liens, which can override the baseline first-in-time rule.

30 Software purchase-money security interests. Section 9-322 contains a new 31 priority rule for a software purchase-money security interest. (The draft incorporates 32 the definition of "software from Section 2B-102 of the current draft of Article 2B.) 33 A software PMSI is defined in Section 9-104 to include a PMSI in software that is 34 used in goods that are also subject to a PMSI. (Note also that the definition of "chattel 35 paper has been expanded to include records that evidence a monetary obligation and 36 a security interest in or lease of specific goods and software used in the goods.)

1 The priority rules for investment property are *Investment* property. 2 substantially similar to the priority rules found in current Section 9-115, which were 3 added to current law in conjunction with the 1994 revisions to UCC Article 8. See 4 Section 9-324. Under Section 9-324, if a secured party has control over investment 5 property (Sections 8-106, 9-108), its security interest is senior to a security interest 6 perfected in another manner (e.g., by filing). Also under Section 9-324, security 7 interests perfected by control generally rank according to the time that the control 8 arrangement is entered into (this is a change from current Section 9-115 and from 9 Discussion Draft No. 2, under each of which they would rank equally), but as between 10 a securities intermediary's security interest in a security entitlement that it maintains for the debtor and a security interest held by another secured party, the securities 11 12 intermediary's security interest is senior.

13 Deposit accounts. The draft's priority rules applicable to deposit accounts are 14 found in Section 9-325. They are patterned on and are similar to those for investment 15 property in current Section 9-115 and Section 9-324 of the draft. Under Section 9-325, 16 if a secured party has control over a deposit account, its security interest is senior to 17 a security interest perfected in another manner (i.e., as cash proceeds). Also under 18 Section 9-325, security interests perfected by control rank according to the time that the control arrangement is entered into (this is a change from Discussion Draft No. 2, 19 20 under which they would rank equally), but as between a depositary bank's security 21 interest and one held by another secured party, the depositary bank's security interest 22 is senior. A corresponding rule in Section 9-337 makes a depositary bank's right of 23 setoff generally senior to a security interest held by another secured party.

24 Letter-of-credit rights. The draft's priority rules for security interests in letter-25 of-credit rights are found in Section 9-326. They are somewhat analogous to those for 26 deposit accounts. A security interest perfected by control has priority over one 27 perfected in another manner (i.e., as a support obligation for the collateral in which a 28 security interest is perfected). Security interests in letter-of-credit rights perfected by 29 control rank according to the time that the control arrangement is entered into (this is 30 a change from Discussion Draft No. 2, under which they would rank equally), but one 31 held by a transferee beneficiary has priority over other security interests.

32 Chattel paper and instruments. Section 9-327 of the draft is the successor to 33 current Section 9-308. After extensive discussions and comment during the last year, the Drafting Committee has settled on revisions to Section 9-327 that appear to reflect 34 35 a satisfactory balance to all concerned, although the result is a somewhat complicated 36 formulation. As under current Section 9-308, differing priority rules apply to 37 purchasers of chattel paper who give new value and take possession of the collateral 38 depending on whether a conflicting security interest in the collateral is claimed merely 39 as proceeds. The principal difference relates to the role of knowledge and the effect 40 of an indication of a previous assignment on the collateral. In addition, to qualify for

- priority, purchasers of chattel paper, but not of instruments, must purchase in the
   ordinary course of their business. Section 9-327 also affords priority to purchasers of
   instruments who take possession in good faith and without knowledge that the
   purchase violates the rights of the competing secured party.
- 5 *Proceeds*. Section 9-319 contains new priority rules that clarify when a special 6 priority of a security interest in collateral continues or does not continue with respect 7 to proceeds of the collateral.

8 Miscellaneous priority provisions. The draft also includes (i) clarifications of 9 selected good-faith-purchase and similar issues (Sections 9-315, 9-317, [9-318]); (ii) new priority rules to deal with the "double debtor problem arising when a debtor 10 creates a security interest in collateral acquired by the debtor subject to a security 11 12 interest created by another person (Section 9-323); (iii) new priority rules to deal with 13 the problems created when a change in corporate structure or the like results in a new 14 entity that has become bound by the original debtor's after-acquired property 15 agreement (Section 9-323A); (iv) a provision enabling most transferees of money to 16 take free of a security interest (Section 9-329); (v) substantially rewritten and refined 17 priority rules dealing with accessions and commingled goods (Sections 9-332, 9-333); (vi) revised priority rules for security interests in goods covered by a certificate of title 18 19 (Section 9-334); and (vii) provisions designed to ensure that security interests in 20 deposit accounts will not extend to most transferees of funds on deposit or payees from 21 deposit accounts and will not otherwise "clog the payments system (Sections 9-338, 22 9-339).

23 Model provisions relating to production-money security interests. Appendix 24 II to the draft contains a model definition and priority rule for "production-money" 25 security interests held by secured parties that give new value used in the production of crops. No consensus emerged on this issue within the Task Force, the Drafting 26 27 Committee, or the agricultural financing community. For this reason, the Drafting Committee has included the production-money provisions in an Appendix. Under this 28 29 approach, the UCC sponsors would make no recommendation one way or the other. 30 In contrast to Section 9-321 of Discussion Draft No. 2, which presented the 31 production-money priority rule as proposed uniform statutory text, Appendix II 32 presents the rule as a "model.

33 **f.** 

f. Proceeds.

34 Section 9-313 of the draft expands the definition of "proceeds of collateral to 35 include additional rights and property that arise out of collateral, including 36 distributions on account of collateral and claims arising out of the loss or 37 nonconformity of, defects in, or damage to collateral. The term also includes 38 collections on account of "support obligations, such as guarantees.

## g. Filing.

1

Part 5 (formerly Part 4) of Article 9 has been substantially rewritten to simplify
the statutory text and to deal with numerous problems of interpretation and
implementation that have arisen over the years. Many of the revisions during the last
year are stylistic or structural and are not mentioned here.

6 *Medium-neutrality.* The draft continues to be "medium-neutral ; that is, it 7 makes clear that parties may file and otherwise communicate with a filing office by 8 means of records communicated and stored in media other than on paper.

9 Identity of person who files a record; authorization. Part 5 of the draft is largely indifferent as to the person who effects a filing. Instead, it addresses whose 10 11 authorization is necessary for a person to file a record with a filing office. The filing scheme does not contemplate that the identity of a "filer will be a part of the 12 13 searchable records. This is a change from the approach reflected in Discussion Draft 14 No. 2. However, it is consistent with, and a necessary aspect of, eliminating signatures 15 or other evidence of authorization from the system (except to the extent that filing 16 offices may choose to employ authentication procedures in connection with electronic 17 communications). As long as the appropriate person authorizes the filing, or, in the 18 case of a termination statement, the debtor is entitled to the termination, it is largely 19 insignificant whether the secured party or another person files any given record.

20 Section 9-508 of the draft collects in one place most of the rules that determine 21 when a record may be filed. In general, the debtor's authorization is required for the 22 filing of an initial financing statement or an amendment that adds collateral. With one 23 further exception, a secured party of record's authorization is required for the filing of 24 other amendments. The exception arises if a secured party has failed to provide a 25 termination statement that is required because there is no outstanding secured obligation or commitment to give value. In that situation, a debtor is authorized to file 26 27 a termination statement indicating that it has been filed by the debtor.

28 Financing statement formal requisites. The formal requisites for a financing 29 statement are set out in Section 9-502 of the draft. A financing statement must provide 30 the name of the debtor and the secured party and an indication of the collateral that it 31 covers. Sections 9-503 and 9-506 address the sufficiency of a name provided on a 32 financing statement and clarify when a debtor's name is correct and when an incorrect 33 name is insufficient. Section 9-504 addresses the indication of collateral covered. 34 Under Section 9-504, a super-generic description (e.g., "all assets or "all personal 35 property ) in a financing statement is a sufficient indication of the collateral. (Note, 36 however, that a super-generic description is inadequate for purposes of a security 37 agreement. See Sections 9-111, 9-203.) To facilitate electronic filing, the draft does not require that the debtor's signature or other authorization appear on a financing 38

statement. Instead, it prohibits the filing of unauthorized financing statements and
 imposes liability upon those who violate the prohibition. See Sections 9-508, 9-624.

3 Filing office operations. The draft, as did Discussion Draft No. 2, contains 4 several provisions governing filing operations. First, it prohibits the filing office from 5 rejecting an initial financing statement or other record for a reason other than one of 6 the few set forth in the draft. See Sections 9-521, 9-515. Second, the filing office is 7 obliged to link all subsequent records (e.g., assignments, continuation statements, etc.) 8 to the initial financing statement to which they relate. See Section 9-520. Third, under 9 the draft, the filing office may delete a financing statement and related records from 10 the files no earlier than one year after lapse (lapse normally is five years after the filing date), and then only if a continuation statement has not been filed. See Sections 9-516, 11 9-520, 9-522. Thus, a financing statement and related records would be discovered by 12 13 a search of the files even after the filing of a termination statement. This approach helps eliminate filing office discretion and also eases problems associated with 14 15 multiple secured parties and multiple partial assignments. Fourth, the draft mandates performance standards for filing offices. See Section 9-520, 9-521, 9-523. Fifth, it 16 17 provides for the promulgation of administrative rules to deal with details best left out 18 of the statute and a duty of the filing office to submit periodic reports. See Section 9-19 528, 9-529.

20 Correction of Records: Missing secured parties and fraudulent filings. In 21 some areas of the country, serious problems have arisen from fraudulent financing 22 statements that are filed against public officials and other prominent persons. In part 23 to address and deter fraudulent filings of all kinds, Section 9-520 of Discussion Draft 24 No. 2 included an alternative formulation that would have required that the filing 25 office communicate to each debtor and secured party of record on a financing 26 statement the information contained in the financing statement and in each related 27 record. That requirement has been removed from Section 9-520 in this draft. The 28 Drafting Committee as well as many filing officers are of the view that the enormous 29 costs of these communications would not worthwhile, on balance. Instead, the 30 Drafting Committee believes that the fraud problem is addressed by providing the opportunity for a debtor to file a termination statement when a secured party 31 32 wrongfully refuse to provide a terminations statement, as discussed above. This 33 opportunity also addresses the problem of secured parties that simply disappear 34 through mergers or liquidations. In addition, Section 9-519 of the draft affords a 35 statutory method by which a debtor who believes that a filed record is inaccurate or 36 was wrongfully filed may indicate that fact in the files by filing a correction statement, 37 albeit without affecting the efficacy, if any, of the challenged record.

Extended period of effectiveness for certain financing statements. Section 9 516 contains an exception to the usual rule that financing statements are effective for
 five years unless a continuation statement is filed to continue the effectiveness for

another five years. Under that section, an initial financing statement filed in
 connection with a "public-finance transaction or a "manufactured-home transaction
 (terms defined in Section 9-102) is effective for 30 years.

*National form of financing statement and related forms*. The draft provides for
 uniform, national written forms of financing statements and related written records that
 a filing office may not refuse to accept. See Section 9-521.

## h. Default and Enforcement.

8 Part 6 (formerly Part 5) of Article 9 extensively revises current law. Certain
9 consumer-protection provisions are discussed below in section 5.i.

10 Debtor, secondary obligor; waiver. Section 9-602 clarifies the identity of 11 persons who have rights and persons to whom a secured party owes specified duties 12 under Part 6. Under that section, the rights and duties are enjoyed by and run to the 13 "debtor, defined in Section 9-102 to mean any person with a non-lien property interest 14 in collateral, and to any "secondary obligor. The latter is a new term defined in 15 Section 9-102 to include one who is secondarily obligated on the secured obligation, e.g., a guarantor. However, under Section 9-626, the secured party is relieved from 16 17 any duty or liability to any person unless the secured party knows that the person is a 18 debtor or a secondary obligor. Under Discussion Draft No. 2, a non-debtor obligor (in 19 a non-consumer transaction) could effectively waive its rights and the secured party's 20 duties to the extent and in the manner provided by other law, e.g., the law of 21 suretyship. This draft changes that rule. It generally prohibits waiver by a secondary obligor. See Section 9-602. However, Section 9-623 permits a secondary obligor (and 22 23 a debtor) to waive the right to notification of disposition of collateral and, in a non-24 consumer transaction, the right to redeem collateral, if the secondary obligor agrees to 25 do so after default.

26 *Rights of collection and enforcement of collateral.* Section 9-607 explains in 27 greater detail the rights of a secured party that seeks to collect or enforce collateral, 28 including accounts, chattel paper, and payment intangibles. It also sets forth the 29 enforcement rights of a depositary bank holding a security interest in a deposit account 30 maintained with the depositary bank. Section 9-607 relates solely to the rights of a 31 secured party to vis-a-vis a debtor with respect to collections and enforcement. It does 32 not affect the rights or duties of third parties, such as account debtors on collateral, 33 which are addressed elsewhere (e.g., Section 9-404B). Section 9-608 clarifies the 34 manner in which proceeds of collection or enforcement are to be applied.

35 *Disposition of collateral: Warranties of title.* Section 9-610 imposes on a 36 secured party that disposes of collateral the warranties of title, quiet possession, and the like that are otherwise applicable under other law, and it provides rules for the
 exclusion or modification of those warranties.

3 Disposition of collateral: Notification, application of proceeds, surplus and 4 deficiency, and other effects. Section 9-611 requires a secured party to give 5 notification of a disposition of collateral to other secured parties and lien holders who 6 have filed financing statements against the debtor which cover the collateral. (That 7 duty was eliminated by the 1972 revisions to Article 9.) However, that section relieves the secured party from that duty when the secured party undertakes a search of the 8 9 records and a report of the search is unreasonably delayed. Section 9-613, which applies to non-consumer transactions, specifies the contents of a sufficient notification 10 of disposition and provides that a notification sent 10 days or more before the earliest 11 time for disposition is sent within a reasonable time. Section 9-614 addresses the 12 13 application of proceeds of disposition, the entitlement of a debtor to any surplus, and the liability of an obligor for any deficiency. Section 9-615 clarifies the effects of a 14 15 disposition by a secured party, including the rights of transferees of the collateral.

16 Rights and duties of secondary obligor. Section 9-616 provides that a 17 secondary obligor obtains the rights and assumes the duties of a secured party if the secondary obligor receives an assignment of a secured obligation, agrees to assume 18 19 the secured party's rights and duties upon a transfer to it of collateral, or becomes 20 subrogated to the rights of the secured party with respect to the collateral. The 21 assumption, transfer, or subrogation is not a disposition of collateral under Section 9-22 616, but it relieves the secured party of further duties. In contrast, Section 9-616 of 23 Discussion Draft No. 2 provided that a secured party would not be relieved of its 24 duties. Current Section 9-504(5) does not address whether a secured party is relieved 25 of its duties in this situation.

*Transfer of record or legal title.* Section 9-617 contains a new provision
 making clear that a transfer of record or legal title to a secured party is not of itself a
 disposition under Part 6. This rule applies regardless of the circumstances under which
 the transfer of title occurs.

30 Strict foreclosure. Section 9-618 permits a secured party to accept collateral 31 in partial satisfaction, as well as full satisfaction, of the obligations secured. This right 32 of strict foreclosure extends to intangible as well as tangible property. Section 9-320 33 clarifies the effects of an acceptance of collateral on the rights of junior claimants. It 34 rejects the approach taken by some courts-deeming a secured party to have 35 constructively retained collateral in satisfaction of the secured obligations-in the case 36 of a secured party's unreasonable delay in the disposition of collateral. Instead, 37 unreasonable delay is relevant when determining whether a disposition under Section 38 9-610 is commercially reasonable. (Special consumer-protection rules affecting these 39 provisions are described in section 5.i. below.)

1 Effect of noncompliance: "Rebuttable presumption" test. Section 9-625 2 adopts the "rebuttable presumption test for the failure of a secured party to proceed 3 in accordance with certain provisions of Part 6. (As noted below in section 5.i., in this 4 draft the rebuttable presumption rule applies only to transactions other than consumer 5 transactions.) Under this approach, the deficiency claim of a noncomplying secured 6 party is calculated by crediting the obligor with the greater of the actual net proceeds 7 of a disposition and the amount of net proceeds that would have been realized if the 8 disposition had been conducted in accordance with Part 6, e.g., in a commercially 9 reasonable manner. The draft rejects the "absolute bar test that some courts have 10 imposed; that approach bars a noncomplying secured party from recovering any deficiency, regardless of the loss (if any) the debtor suffered as a consequence of the 11 12 noncompliance.

13 "Low-price" dispositions: Calculation of deficiency and surplus. Section 9-614(h) addresses the problem of procedurally regular dispositions that fetch a low 14 15 price. Subsection (h) provides a special method for calculating a deficiency if the proceeds of a disposition of collateral to a secured party, an person related to the 16 17 secured party, or a secondary obligor are "significantly below the range of proceeds 18 that a complying disposition to a person other than the secured party, a person related to the secured party, or a secondary obligor would have brought. ("Person related to 19 20 is defined in Section 9-614(a).) In these situations there is reason to suspect that there 21 may be inadequate incentives to obtain a better price. Consequently, instead of 22 calculating a deficiency (or surplus) based on the actual net proceeds, the deficiency 23 (or surplus) would be calculated based on the proceeds that would have been received 24 in a disposition to an unrelated person. The Drafting Committee envisions that the 25 Official Comments would not attempt explain the test for low price sales beyond 26 references to the statutory formulation. Application would be left to the courts.

27

## i. Consumer Transactions.

The draft includes several provisions applicable only to "consumer
 transactions or "consumer-goods transactions. Each term is defined in Section 9 102.

31 Background. In 1995, NCCUSL appointed a subcommittee of the Drafting 32 Committee to consider whether and to what extent Article 9 draft should contain 33 consumer-protection provisions. The subcommittee made several recommendations 34 that the Drafting Committee considered during its meetings in 1996 and 1997. Many 35 of the provisions that the Drafting Committee adopted, and which the ALI membership 36 discussed at its 1997 annual meeting, remained highly controversial. The draft that 37 emerged proved unsatisfactory to many representatives of both consumers and 38 consumer creditors.

$ \begin{array}{c} 1\\2\\3\\4\\5\\6\\7\\8\\9\\10\\11\\12\\13\\14\\15\end{array} $	<i>Proposed compromise solution.</i> In 1997, the Chair of the Drafting Committee initiated a renewed effort to reach a consensus solution that would not be actively opposed by consumer or consumer-creditor interests. After many rounds of discussions and much "shuttle diplomacy, a tentative solution was reached during the February, 1998, meeting of the Drafting Committee. During that meeting, the Drafting Committee approved in principle, and asked the Reporters to incorporate in the next draft, a list of proposed revisions relating to consumer transactions. Most of the proposals, but not all, related to Part 6, Default. The Chair of the Drafting Committee presented the proposals as a compromise, explaining that if the package of proposals were accepted by the Drafting Committee and its sponsors, representatives of consumer interests involved in the process would actively support, and advocates of Article 9. The Chair explained further that the alternative could be widespread opposition, with pitched battles in the various legislatures during the enactment process. This controversy could delay or inhibit enactment of the revisions.
16 17 18	<i>Deleted provisions.</i> Under the proposal, several consumer-protection provisions in the January, 1998, draft, which had been approved by the Drafting Committee, would be deleted:
19 20	(i) Section 9-104(d) and (e) (allocation of payments for determining purchase-money status in consumer-goods transactions);
21 22	(ii) Section 9-613(b)(3) (notice of disposition containing minor errors not seriously misleading is sufficient);
23 24	(iii) Section 9-622 (reinstatement rights of consumer debtor or secondary obligor);
25 26 27	(iv) Section 9-624(d) and (e) (reduction of secured party's liability for statutory damages by amount of loss of deficiency or actual damages awarded to consumer);
28 29	(v) Section 9-625, Alternative A (absolute bar of deficiency alternative for secured party noncompliance in consumer transactions);
30	(vi) Section 9-627(d) (good-faith error defense to statutory damages);
31	(viii) Section 9-627(e) (limitation on recoveries in class actions); and
32	(vii) Section 9-628 (reciprocal attorney's fees in consumer transactions).

1 *Revised provisions.* The proposal also called for revision of several other 2 provisions.

3 (i) In addition to deleting Alternative A of Section 9-625 (absolute bar 4 rule), the rebuttable presumption rule in Section 9-624 would be made applicable only 5 to transactions other than consumer transactions. The draft would remain silent as to 6 the effect of a secured party's noncompliance in consumer transactions, leaving that 7 issue to the courts. (During its March, 1998, meeting the Drafting Committee decided 8 that the draft should contain a statutory statement that no implications for consumer 9 transactions should be drawn from the statutory rebuttable presumption rule for non-10 consumer transactions. See Section 9-625(b) of this draft.)

(ii) Sections 9-104(f) and (g) (approving "dual status rule for purchasemoney security interests (i.e., rejecting "transformation rule) and setting burden of
proof) would be applicable only to non-consumer-goods transactions. (During its
March, 1998, meeting the Drafting Committee decided that the draft should contain
a statutory statement that no implications for consumer-goods transactions should be
drawn from the statutory treatment of non-consumer-goods transactions. See Section
9-104(i) of this draft.)

(iii) Either the definition of "buyer in ordinary course of business would
not be revised to provide that BIOCOB status depends on a possessory right as against
the seller, or certain proposed provisions in revised Article 2 would accompany revised
Article 9 to provide protection for a prepaying buyer. (During its March, 1998,
meeting the Drafting Committee adopted the latter approach, reflected in this draft.
See Appendix I.)

(iv) The comment to Section 9-111 would contain no examples of
sufficient collateral descriptions in consumer transactions (e.g., the previous approval
of "all jewelry in the Reporters' Comments would be deleted).

- (v) Sections 9-403 and 9-404 would be expanded to make effective the
   FTC's anti-holder-in-due-course rule (when applicable) even in the absence of the
   required legend.
- 30 (vi) Section 9-614A (post-disposition notice) would be revised to provide
  31 for a somewhat more refined statement of how a deficiency or surplus was calculated.
- (vii) The comments would be modified to delete any explicit statement that
  "price is not a term of a disposition which is required to be commercially reasonable,
  and an explanatory comment would be added to the effect that a low price mandates
  enhanced judicial scrutiny of the terms of a disposition.

(viii) Section 9-618 would be revised to prohibit partial strict foreclosure
 for consumer goods.

3 Drafting Committee resolution. During its March, 1998, meeting, the Drafting 4 Committee considered the Reporters' efforts, incorporated in the January, 1998, draft, 5 to implement the proposed solution. The Drafting Committee gave its general approval to the proposed solution. It also considered a number of specific issues that 6 7 had been raised by the consumer and consumer creditor representatives. The Drafting 8 Committee resolved all remaining material issues. This draft reflects that resolution. 9 However, we should note three caveats. First, inasmuch as less than two weeks were available for us to revise the draft following the March, 1998, meeting, this draft has 10 not been reviewed by anyone other than the Reporters. Second, several elements of 11 the proposed solution for the consumer-related issues implicate the language of the 12 13 Official Comments that will accompany the final revised text of Article 9. While substantial progress has been made in formulating these comments, they have not yet 14 15 been finalized. Finally, the proposed solution of the consumer-related issues has been recognized by all concerned as a compromise. The statutory text that has emerged is 16 17 less than ideal in substance and approach. It represents a balance struck in the hope 18 that it will enhance the opportunities for prompt and uniform enactment of revised 19 Article 9

20

## Additional consumer-related provisions.

- 21 Description of consumer goods and certain investment property. Section 22 9-111 provides that in a consumer transaction a description of consumer goods, a 23 security entitlement, securities account, or commodity account by Article 9-defined 24 "type alone (e.g., "all consumer goods or "all securities accounts ) is not a sufficient 25 collateral description in a security agreement.
- 26 *Notification of disposition of collateral*. Section 9-613A contains a safe 27 harbor form of notification, in "plain English, for consumer transactions.
- *Notification of calculation of deficiency*. Section 9-614A requires a secured
   party to provide a debtor with a notification of how it calculated a deficiency at the
   time it first undertakes to collect a deficiency.
- **j.** Good Faith.
- Section 9-102 contains a new definition of "good faith that includes not only
  "honesty in fact but also "the observance of reasonable commercial standards of fair
  dealing. The definition is similar to the ones adopted in connection with other,
  recently completed revisions of the UCC.

## k. Transition Provisions.

Part 7 of the draft (Sections 9-701 through 9-708) contains transition provisions. A subcommittee of the Drafting Committee presented a report on transition issues to the Drafting Committee at its February, 1998, meeting. At the March, 1998, meeting, the Reporters presented draft provisions based on the report and the Drafting Committees discussion. Part 7 of this draft reflects the Drafting Committee's deliberations and the Reporters' further refinements. Part 7 contains Reporters' Comments.

## I. Conforming and Related Amendments to Other UCC Articles.

- 10 Appendix I to the draft contains several proposed revisions to the provisions 11 and Official Comments of other UCC articles . For the most part the revisions are 12 explained in the Reporters' Comments to the proposed revisions.
- Article 1. Revised Section 1-201 contains revisions to the definitions of "buyer
   in ordinary course of business, "purchaser, "security interest, and "send.
- 15 *Article 2.* Sections 2-210, 2-326, 2-502, and 2-716 have been revised to 16 address the intersection between Article 2 and Article 9.
- Article 5. New Section 5-118 is patterned on current Section 4-210. It
   provides for a security interest in documents presented under a letter of credit in favor
   of the issuer and a nominated person on the letter of credit.
- Article 8. Revisions to Section 8-110, dealing with a "securities intermediary's
   jurisdiction, conform it to the treatment of a "commodity intermediary's jurisdiction
   in Section 9-305. We contemplate that there will be some additional refinements to
   certain provisions of Article 8 and its Official Comments which have material effects
   on security interests in investment property.
- 25 6. Miscellaneous Style and Citation Conventions.

The draft reflects extensive revisions to reflect NCCUSL's currently applicable style requirements. A few issues remain open and under discussion with NCCUSL's Committee on Style. That Committee will meet to discuss remaining Article 9 style issues on April 17, 1998.

description of the collateral and, if the security interest covers timber to be cut, a
description of the land concerned;
(B) the collateral is in the possession of the secured party under Section
9-311 pursuant to the debtor's security agreement;
(C) the collateral is a certificated security and the security certificate has
been delivered to the secured party under Section 8-301 pursuant to the debtor's
security agreement; or
(D) the collateral is <u>a deposit account, electronic chattel paper</u> ,
investment property, a deposit account, or a letter-of-credit right, and the secured party
has control pursuant to the debtor's security agreement.
(c) A person becomes bound as debtor by a security agreement entered into by
another person if, by operation of other law or by contract:
(1) the security agreement becomes effective to create a security interest in
the person's property; or
(2) the person:
(A) becomes generally obligated for the obligations of the other person,
including the obligation secured under the security agreement; and

1	(B) acquires or succeeds to all or substantially all of the assets of the
2	other person.
3	(d) If a new debtor becomes bound as debtor by a security agreement entered
4	into by another person:
5	(1) the agreement satisfies the requirements of subsection $(b)(3)$ with

14	PART 3
15	PERFECTION AND PRIORITY OF SECURITY INTERESTS
16	[SUBPART 1. LAW GOVERNING PERFECTION AND PRIORITY]
17	SECTION 9-301. LAW GOVERNING PERFECTION AND PRIORITY OF
18	SECURITY INTERESTS. Except as otherwise provided in Sections 9-303 through
19	9-305, the following rules determine the law governing perfection, the effect of
20	perfection or nonperfection, and the priority of a security interest in collateral:

1 (1) Except as otherwise provided in this section, while a debtor is located in 2 a jurisdiction, the local law of that jurisdiction governs perfection, the effect of 3 perfection or nonperfection, and the priority of a security interest in collateral.

4 (2) While collateral is located in a jurisdiction, the local law of that jurisdiction
5 governs perfection, the effect of perfection or nonperfection, and the priority of a
6 possessory security interest in that collateral.

7 (3) Except as otherwise provided in paragraphs (4), (5), and (6), while goods,
8 chattel paper, instruments, money, or negotiable documents are located in a
9 jurisdiction, the local law of that jurisdiction governs the effect of perfection or
10 nonperfection and the priority of a nonpossessory security interest.

(4) While goods are located in a jurisdiction, the local law of that jurisdiction
governs perfection of a security interest in the goods by filing a fixture filing.

- 13 (5) The local law of the jurisdiction in which timber to be cut is located14 governs perfection of a security interest in the timber.
- 15 (6) The local law of the jurisdiction in which the wellhead or minehead is
  16 located governs perfection, the effect of perfection or nonperfection, and the priority
  17 of a security interest in as-extracted collateral.

18 **SECTION 9-302. LAW GOVERNING FILING, PERFECTION, AND** 19 **PRIORITY OF AGRICULTURAL LIENS.** While collateral is located in a 20 jurisdiction, the local law of that jurisdiction governs perfection, the effect of 21 perfection or nonperfection, and the priority of an agricultural lien on the collateral.

# SECTION 9-303. LAW GOVERNING PERFECTION AND PRIORITY OF SECURITY INTERESTS IN GOODS COVERED BY A CERTIFICATE OF TITLE.

- 4 (a) Goods become covered by a certificate of title when a valid application for
  5 the certificate of title and the applicable fee are delivered to the appropriate authority.
- 6 (b) The local law of the jurisdiction under whose certificate of title the goods 7 are covered governs perfection, the effect of perfection or nonperfection, and the 8 priority of a security interest in goods covered by a certificate of title from the time the 9 goods become covered by the certificate until the earlier of the time the certificate 10 becomes ineffective under the law of that jurisdiction or the time the goods become 11 covered subsequently by a certificate of title from another jurisdiction. After that time, 12 the goods are not covered by the first certificate of title.
- (c) This section applies to goods covered by a certificate of title even if there
  is no other relationship between the jurisdiction under whose certificate of title the
  goods are covered and the goods or the debtor.

### SECTION 9-304. LAW GOVERNING PERFECTION AND PRIORITY OF SECURITY INTERESTS IN DEPOSIT ACCOUNTS.

- (a) The local law of a bank's jurisdiction governs perfection, the effect of
  perfection or nonperfection, and the priority of a security interest in a deposit account
  maintained with that bank.
- (b) The following rules determine a bank's jurisdiction for purposes of thissection:

1	(1) If an agreement between the bank and the debtor expressly provides a
2	particular jurisdiction as the bank's jurisdiction for purposes of this part, this article,
3	or [the Uniform Commercial Code], that jurisdiction is the bank's jurisdiction.
4	(2) If paragraph $(1)$ does not apply and an agreement between the bank and
5	its customer expressly provides that it is governed by the law of a particular
6	jurisdiction, that jurisdiction is the bank's jurisdiction.
7	(3) If neither paragraph (1) nor paragraph (2) applies and an agreement
8	between the bank and its customer expressly provides that the deposit account is
9	maintained at an office in a particular jurisdiction, that jurisdiction is the bank's
10	jurisdiction.
11	(4) If none of paragraph $(1)$ , $(2)$ , or $(3)$ applies, the bank's jurisdiction is
12	the jurisdiction in which is located the office identified in an account statement as the
13	office serving the customer's account.
14	(4) If none of the preceding paragraphs applies, the bank's jurisdiction is
15	the jurisdiction in which is located the chief executive office of the bank.
16	SECTION 9-304A. LAW GOVERNING PERFECTION AND PRIORITY
17	OF SECURITY INTERESTS IN LETTER-OF-CREDIT RIGHTS.
18	(a) Subject to subsection (c), the local law of the issuer's jurisdiction or a
19	nominated person's jurisdiction governs perfection, the effect of perfection or
20	nonperfection, and the priority of a security interest in a letter-of-credit right if the
21	issuer's jurisdiction or nominated person's jurisdiction is a State.

(b) The local law of an issuer's jurisdiction or nominated person's jurisdiction
 is the local law of the jurisdiction governing its liability with respect to the letter-of credit right as provided in Section 5-116.

4 (c) This section does not apply to a security interest that is perfected only
5 under Section 9-308(d).

### 6 SECTION 9-305. LAW GOVERNING PERFECTION AND PRIORITY OF 7 SECURITY INTERESTS IN INVESTMENT PROPERTY.

(a) Except as otherwise provided in subsection (b), the following rules apply:

9 (1) While a security certificate is located in a jurisdiction, the local law of 10 that jurisdiction governs perfection, the effect of perfection or nonperfection, and the 11 priority of a security interest in the certificated security represented thereby.

12 (2) The local law of the issuer's jurisdiction as specified in Section
13 8-110(d) governs perfection, the effect of perfection or nonperfection, and the priority
14 of a security interest in an uncertificated security.

(3) The local law of the securities intermediary's jurisdiction as specified
in Section 8-110(e) governs perfection, the effect of perfection or nonperfection, and
the priority of a security interest in a security entitlement or securities account.

18 (4) The local law of the commodity intermediary's jurisdiction governs
19 perfection, the effect of perfection or nonperfection, and the priority of a security
20 interest in a commodity contract or commodity account.

1	(5) The following rules determine a commodity intermediary's jurisdiction
2	for purposes of paragraph 4 and Section 9-314:
3	(A) If an agreement between the commodity intermediary and
4	commodity customer expressly provides the commodity intermediary's jurisdiction for
5	purposes of this part, this article, or [the Uniform Commercial Code], that jurisdiction
6	is the commodity intermediary's jurisdiction.
7	(B) If subparagraph (A) does not apply and an agreement between the
8	commodity intermediary and commodity customer expressly provides that it is
9	governed by the law of a particular jurisdiction, that jurisdiction is the commodity
10	intermediary's jurisdiction.
11	(C) If neither subparagraph (A) nor subparagraph (B) applies and an
12	agreement between the commodity intermediary and commodity customer expressly
13	provides that the commodity account is maintained at an office in a particular
14	jurisdiction, that jurisdiction is the commodity intermediary's jurisdiction.
15	(D) If none of subparagraph (A), (B), or (C) applies, the commodity
16	intermediary's jurisdiction is the jurisdiction in which is located the office identified
17	in an account statement as the office serving the commodity customer's account.
18	(E) If none of the preceding subparagraphs applies, the commodity
19	intermediary's jurisdiction is the jurisdiction in which is located the chief executive
20	office of the commodity intermediary.
21	(b) The local law of the jurisdiction in which the debtor is located governs:
22	(1) perfection of a security interest in investment property by filing;

1	(2) automatic perfection of a security interest in investment property
2	granted by a broker or securities intermediary; and
3	(3) automatic perfection of a security interest in a commodity contract or
4	commodity account granted by a commodity intermediary.
5	<b>SECTION 9-306.</b>

7	SECTION 9-307. LOCATION OF DEBTOR.
8	(a) In this section, a "place of business is a place where a debtor conducts its
9	affairs.
10	(b) Except as otherwise provided in this section, the following rules determine
11	a debtor's location:
12	(1) An individual debtor is located at the individual's residence.
13	(2) Any other debtor having only one place of business is located at its
14	place of business.
15	(3) Any other debtor having more than one place of business is located at
16	its chief executive office.
17	(c) Subsection (b) applies only if a debtor's residence, place of business, or
18	chief executive office, as applicable, is located either in a State or in a jurisdiction,
19	other than a State, whose law requires information concerning the [possible] existence
20	of a security interest to be made publicly available as a condition or result of the
21	security interest's obtaining priority over the rights of a lien creditor with respect to the

1	collateral. If subsection (b) does not apply, the debtor is located in [the District of

3	(d) A registered organization that is organized under the law of a State is
4	located in its jurisdiction of organization that State.
5	(e) Except as otherwise provided in subsection (h), a registered organization
6	that is organized under the law of the United States and a branch or agency of a bank
7	that is not organized under the law of the United States or a State are located:
8	(1) in the State that the law of the United States designates, if the law
9	designates a State of location;
10	(2) in the State that the registered organization designates, if the law of the
11	United States authorizes the registered organization to designate its State of location;

13	(3) in the District of Columbia, if neither paragraph (1) nor paragraph (2)

15	(f) A registered organization continues to be located in the jurisdiction

4	(i) A foreign air carrier under the Federal Aviation Act of 1958, as amended,
5	is located at the designated office of the agent upon which service of process may be
6	made on behalf of the carrier.
7	(j) This section applies only for purposes of this part.
8	[SUBPART 2. PERFECTION]
9	SECTION 9-308. WHEN SECURITY INTEREST OR AGRICULTURAL
10	LIEN IS PERFECTED; CONTINUITY OF PERFECTION.
11	(a) (1) Except as otherwise provided in this section and Section 9-308A, a
12	security interest is perfected if it has attached and all of the applicable requirements for
13	perfection in Sections 9-309 through 9-314A have been satisfied. A security interest
14	is perfected when it attaches if the applicable requirements are satisfied before the
15	security interest attaches.
16	(b) An agricultural lien is perfected if it has become effective and all of the
17	applicable requirements for perfection in Sections 9-309 and 9-314A have been
18	actisfied. An agricultural lies is perfected when it becomes affective if the applicable
	satisfied. An agricultural lien is perfected when it becomes effective if the applicable

1	(c) A security interest or agricultural lien is perfected continuously if it is
2	originally perfected in one manner under this article and is later perfected in another
3	manner under this article, without an intermediate period when it was unperfected.
4	(d) Perfection of a security interest in collateral chattel paper, document,
5	instrument, [insurance policy,] general intangible, or security also perfects a security
6	interest in a support obligation for the collateral.
7	(e) Perfection of a security interest in a securities account also perfects a
8	security interest in all the security entitlements carried in the securities account;
9	(f) Perfection of a security interest in a commodity account also perfects a
10	security interest in all the commodity contracts carried in the commodity account.
11	(g) Perfection of a security interest in a right to payment or performance also
12	perfects a security interest in a lien on personal or real property securing the right,
13	notwithstanding other law to the contrary.
14 15	Legislative Note: To avoid confusion, any statute conflicting with subsection (g) should be made expressly subject to that subsection.
16	SECTION 9-308A. SECURITY INTEREST PERFECTED UPON
17	ATTACHMENT. The following security interests are perfected when they attach:

12	(8) a security interest of an issuer or nominated person arising under Section
13	<u>5-118.</u>
14	$(\underline{9})$ a security interest arising in the purchase or delivery of a financial asset
15	under Section 9-206;
16	$(\underline{10})$ a security interest in investment property created by a broker or securities
17	intermediary;
18	$(\underline{11})$ a security interest in a commodity contract or a commodity account created
19	by a commodity intermediary;
20	$(\underline{12})$ an assignment for the benefit of all the creditors of the transferor and
21	subsequent transfers by the assignee thereunder; and

1	$(\underline{13})$ a security interest created by an assignment of a beneficial interest in a
2	decedent's estate.
3	SECTION 9-309. WHEN FILING REQUIRED TO PERFECT SECURITY
4	INTEREST OR AGRICULTURAL LIEN; SECURITY INTERESTS AND
5	AGRICULTURAL LIENS TO WHICH FILING PROVISIONS DO NOT
6	APPLY.
7	(a) Except as otherwise provided in subsections (b) and (c), a financing
8	statement must be filed to perfect all security interests and agricultural liens.
9	(b) The filing of a financing statement is not necessary to perfect a security
10	interest:
11	(1) in a support obligation under Section 9-308(d);
12	(2) that is perfected when it attaches (Section 9-308A);
13	(3) in property subject to a statute, regulation, or treaty described in Section
14	9-309A(a);
15	(4) in instruments, certificated securities, or documents perfected without
16	filing or possession under Section 9-310(e) or (f);
17	(5) in collateral in the secured party's possession under Section 9-311;
18	(6) in a certificated security which is perfected by delivery of the security
19	certificate to the secured party under Section 9-311;
20	$(\underline{7})$ in investment property, a deposit account, or a letter-of-credit right that
21	is perfected without filing under Section 9-312;
22	(8) in proceeds under Section 9-313(f); or

1	$(\underline{9})$ that is perfected under Section 9-314.
2	(c) The filing of a financing statement is not necessary to perfect an
3	agricultural lien on proceeds under Section 9-313(f).
4	(d) If a secured party assigns a perfected security interest or agricultural lien,
5	a filing under this article is not required to continue the perfected status of the security
6	interest against creditors of and transferees from the original debtor.
7	SECTION 9-309A. PERFECTION OF SECURITY INTERESTS IN
8	PROPERTY SUBJECT TO CERTAIN STATUTES, REGULATIONS, AND
9	TREATIES.
10	(a) Except as otherwise provided in subsection ( $\underline{e}$ ), the filing of a financing
11	statement is not necessary or effective to perfect a security interest in property subject
12	to:
13	(1) a statute, regulation, or treaty of the United States whose requirements
14	for a security interest's obtaining priority over the rights of a lien creditor with respect
15	to the property preempt Section 9-309(a); [or]
16	(2) [list any certificate-of-title statute covering automobiles, trailers,
17	mobile homes, boats, farm tractors, or the like, which provides for a security interest

- 6 (c) Except as otherwise provided in <u>subsection (e) and</u> Sections 9-311 and 7 9-314 (c)[, (d) , and (e) ] for goods covered by a certificate of title, a security interest 8 in property subject to a statute, regulation, or treaty described in subsection (a) may be 9 perfected only by compliance with those requirements, and a security interest so 10 perfected remains perfected notwithstanding a change in the use or transfer of 11 possession of the collateral.
- (d) Except as otherwise provided in <u>subsection (e) and</u> Section 9-314 (c), [ (d)
  ; and (e), ] duration and renewal of perfection of a security interest perfected by
  compliance with the requirements prescribed by a statute, regulation, or treaty
  described in subsection (a) are governed by the statute, regulation, or treaty. In other
  respects the security interest is subject to this article.
- 17 (e) During any period in which collateral is inventory held for sale or lease by
  18 a person or leased by that person as lessor and that person is in the business of selling
  19 or leasing goods of that kind, subsection [s] (a)(2) [does] [and (3) do] this section does
  20 not apply to a security interest in that collateral created by that person as debtor.

1	SECTION 9-310. PERFECTION OF SECURITY INTERESTS IN
2	INSTRUMENTS, CHATTEL PAPER, INVESTMENT PROPERTY,
3	DOCUMENTS, MONEY, DEPOSIT ACCOUNTS, LETTER-OF-CREDIT
4	RIGHTS, AND GOODS COVERED BY DOCUMENTS; PERFECTION BY
5	PERMISSIVE FILING; TEMPORARY PERFECTION WITHOUT FILING OR
6	TRANSFER OF POSSESSION.
7	(a) A security interest in instruments, chattel paper, investment property, or
8	negotiable documents may be perfected by filing.
9	(b) Except as otherwise provided in Section 9-313(e) for [cash] proceeds:
10	(1) a security interest in money may be perfected only by the secured party's
11	taking possession under Section 9-311;
12	(2) a security interest in a deposit account may be perfected only by control
13	under Section 9-312; and
14	(3) a security interest in a letter-of-credit right may be perfected only by
15	control under Section 9-312, except as otherwise provided in Section 9-308(d).
16	(c) While goods are in the possession of a bailee that has issued a negotiable
17	document under Section 7-104(1) [or federal law] covering the goods:
18	(1) a security interest in the goods is perfected by perfecting a security
19	interest in the document; and
20	(2) any security interest in the goods otherwise perfected during the period
21	is subordinate to the security interest perfected in the document.

(d) A security interest in goods in the possession of a bailee that has issued a
non-negotiable document under Section 7-104(2) [or federal law] covering the goods
is perfected by:
(1) issuance of a document in the name of the secured party;
(2) the bailee's receipt of notification of the secured party's interest; or
(3) filing as to the goods.
(e) A security interest in instruments, certificated securities, or negotiable
documents is perfected without filing or the taking of possession for a period of 20
days from the time it attaches to the extent that it arises for new value given under an
authenticated security agreement.
(f) A security interest remains perfected for 20 days without filing if a secured
party having a perfected security interest in an instrument, a certificated security, a
negotiable document, or goods in possession of a bailee other than one that has issued
a negotiable document for the goods:
(1) makes available to the debtor the goods or documents representing the
goods for the purpose of:
(A) ultimate sale or exchange; or
(B) loading, unloading, storing, shipping, transshipping, manufacturing,
processing, or otherwise dealing with them in a manner preliminary to their sale or
exchange, but priority among conflicting security interests in the goods is subject to
Section 9-322; or

1	(2) delivers the instrument or certificated security to the debtor for the

4	(B) presentation, collection, enforcement, renewal, or registration of

6	(g) After the 20-day period specified in subsection (e) [or] [and] (f) expires,
7	perfection depends upon compliance with this article.
8	SECTION 9-311. WHEN POSSESSION BY SECURED PARTY PERFECTS
9	SECURITY INTEREST WITHOUT FILING.
10	(a) Except as otherwise provided in subsection (b), a security interest in goods,
11	instruments, money, negotiable documents, or tangible chattel paper may be perfected
12	by the secured party's taking possession of the collateral. A security interest in
13	certificated securities may be perfected by delivery of the security certificates
14	certificated securities under Section 8-301 to the secured party under Section 8-301.
15	(b) A security interest in goods covered by a certificate of title issued by this
16	State may be perfected by the secured party's taking possession of the collateral only
17	in the circumstances described in Section 9-314(e).
18	(c) With respect to collateral other than certificated securities and goods
19	covered by a document, a secured party acquires possession of collateral in the
20	possession of a person other than the debtor, the secured party, or a lessee of the
21	collateral from the debtor in the ordinary course of the debtor's business, when:

1	(1) the person in possession authenticates a record acknowledging that it
2	holds possession of the collateral for the secured party's benefit; or
3	(2) the person takes possession of the collateral after having authenticated
4	a record acknowledging that it will hold possession of collateral for the secured party's
5	benefit.
6	(d) A secured party that has possession of collateral does not relinquish
7	possession by delivering the collateral to a person other than the debtor or a lessee of
8	the collateral from the debtor in the ordinary course of the debtor's business if the
9	person was instructed before the delivery or is instructed contemporaneously with the
10	delivery:
11	(1) to hold possession of the collateral for the secured party's benefit; or
12	(2) to redeliver the collateral to the secured party.
13	(e) A security interest is perfected by possession when the secured party takes
14	possession [, without a relation back,] and remains perfected by possession only while
15	the secured party retains possession. , unless otherwise provided in this article.
16	(f) A security interest in a certificated security is perfected by delivery when
17	the secured party takes delivery of the security certificate delivery of the certificated
18	security occurs under Section 8-301 [, without a relation back,] and remains perfected
19	by delivery until the debtor obtains possession of the security certificate.
20	(g) A person in possession of collateral is not required to acknowledge that it
21	holds possession for a secured party's benefit.

1	(h) If a person acknowledges that it holds possession for the secured party's
2	benefit:
3	(1) the acknowledgment is effective under subsection (c) $\frac{1}{2}$ Section
4	8-301(a)] even if the acknowledgment violates the rights of a debtor; and
5	(2) unless the person otherwise agrees or other law otherwise provides, the
6	person does not owe any duty to the secured party and is not required to confirm the

13	SECTION 9-312. PERFECTION BY CONTROL.

# 6 SECTION 9-315A. RIGHTS AND TITLE OF CONSIGNEE AND SELLER 7 OF ACCOUNT OR CHATTEL PAPER WITH RESPECT TO CREDITORS 8 AND PURCHASERS.

9 (a) For purposes of determining the rights of creditors of, and purchasers for 10 value of an account or chattel paper from, a debtor that has sold an account or chattel 11 paper, while the buyer's security interest is unperfected, the debtor has rights and title 12 to the account or chattel paper identical to those the debtor sold.

(b) Except as otherwise provided in subsection (c), for purposes of determining
the rights of creditors of, and purchasers for value of goods from, a consignee, the
consignee has rights and title to the goods identical to those the consignor had or had
power to transfer while the goods are in the possession of the consignee.

17 (c) For purposes of determining the rights of a creditor of a consignee, other
18 law determines the rights and title of a consignee while goods are in the consignee's
19 possession if, under this part, a perfected security interest held by the consignor would
20 be senior to the rights of the creditor.

#### SECTION 9-316. BUYER OF GOODS.

2	(a) Except as otherwise provided in subsection (e), a buyer in ordinary course
3	of business {, other than a person buying farm products from a person engaged in
4	farming operations, takes free of a security interest created by the buyer's seller, even
5	if the security interest is perfected and the buyer knows of its existence.
6	(b) Except as otherwise provided in subsection (e), a buyer of consumer goods
7	takes free of a security interest, even if perfected, if the buyer buys:
8	(1) without knowledge of the security interest;
9	(2) for value;
10	(3) for the buyer's own personal, family, or household purposes; and
11	(4) before a person files a financing statement covering the goods.
12	(c) To the extent that it affects the priority of a security interest over a buyer
13	of consumer goods under subsection (b), the period of effectiveness of a filing made
14	in the jurisdiction in which the debtor is located is governed by Section 9-314(a) and
15	(b).
16	(d) [Except as otherwise provided in subsection (e) a] [A] buyer in ordinary
17	course of business buying oil, gas, or other minerals at the wellhead or minehead or
18	after extraction takes free of an interest arising out of an encumbrance.
19	(e) This section does Subsections (a) and (b) do not affect a security interest
20	in goods in the possession of the secured party under Section 9-311.

SECTION 9-317. LESSEE OF GOODS IN ORDINARY COURSE OF
 BUSINESS. A lessee of goods in ordinary course of business takes the leasehold
 interest free of a security interest in the goods created by the lessor even if the security
 interest is perfected and the lessee knows of its existence.

### 7 SECTION 9-319. PRIORITIES AMONG CONFLICTING SECURITY

#### 8 INTERESTS AND AGRICULTURAL LIENS IN SAME COLLATERAL.

9 (a) Except as otherwise provided in this part, Section 4-210 with respect to a 10 security interest of a collecting bank, and Section 5-118 with respect to a security 11 interest of an issuer or nominated person, priority among conflicting security interests 12 and agricultural liens in the same collateral is determined according to the following 13 rules:

(1) Conflicting security interests and agricultural liens rank according to
priority in time of filing or perfection. Priority dates from the earlier of the time : (A)
a filing covering the collateral is first made ; or (B) the security interest or agricultural
lien is first perfected, if there is no period thereafter when there is neither filing nor
perfection.

(2) The first security interest or agricultural lien to attach or become
effective has priority if conflicting security interests and agricultural liens are
unperfected.
(b) For the purposes of subsection (a), a date of filing or perfection as to
collateral is also a date of filing or perfection as to proceeds.
(c) A security interest in collateral which qualifies for priority over a
conflicting security interest under Section 9-324, 9-325, 9-326, 9-327, or 9-328 also
has priority in:
(1) cash proceeds of the collateral; and
(2) other proceeds of the collateral if the proceeds are chattel paper,
negotiable documents, instruments, investment property, or letter-of-credit rights.
(d) Subject to subsection (e), if a security interest in chattel paper, deposit
accounts, negotiable documents, instruments, investment property, or letter-of-credit
rights is perfected by a method other than filing, conflicting security interests in and
agricultural liens on proceeds of the collateral rank according to priority in time of
filing.
(e) Subsection (d) applies only if the proceeds of the collateral are not cash
proceeds, chattel paper, negotiable documents, instruments, investment property, or
letter-of-credit rights.
(f) If a statute under which an agricultural lien in collateral is created provides
that the agricultural lien has priority over a conflicting security interest or agricultural

lien in the same collateral, the statute governs priority if the agricultural lien is
 perfected.

5 SECTION 9-320. FUTURE ADVANCES.

(a) Except as otherwise provided in subsection (c), for purposes of determining
the priority of a security interest under Section 9-319(a), perfection of the security
interest dates from the time an advance is made to the extent that the security interest
secures an advance that:

10 (1) is not made pursuant to commitment; and

(2) is made while the security interest is temporarily perfected under
Section 9-310(d) or (e) for is perfected when it attaches under Section 9-308A] and by
no other method.

(b) Except as otherwise provided in subsection (c), a security interest is
subordinate to the rights of a person that becomes a lien creditor while the security
interest is perfected only to the extent that it secures advances made more than 45 days
after the person becomes a lien creditor unless the advance is made:

(1) without knowledge of the lien; or

(2) pursuant to a commitment entered into without knowledge of the lien.
(c) Subsections (a) and (b) do not apply to a security interest held by a secured
party that is a buyer of accounts, chattel paper, or payment intangibles or a consignor.

1	(d) Except as otherwise provided in subsections (e) and (g), a buyer of goods
2	other than a buyer in ordinary course of business takes free of a security interest to the
3	extent that it secures advances made after the earlier of:
4	(1) the time the secured party acquires knowledge of the buyer's purchase;
5	or
6	(2) 45 days after the purchase.
7	(e) Subsection (d) does not apply if the advance is made pursuant to a
8	commitment entered into without knowledge of the buyer's purchase and before the
9	expiration of the 45-day period.
10	(f) Except as otherwise provided in subsection (g), a lessee of goods other than
11	a lessee of goods in ordinary course of business takes the leasehold interest free of a
12	security interest to the extent that it secures advances made after the earlier of:
13	(1) the time the secured party acquires knowledge of the lease; or
14	(2) 45 days after the lease contract becomes enforceable.
15	(g) Subsections (d) and (f) do not apply if the advance is made pursuant to a
16	commitment entered into without knowledge of the lease and before the expiration of
17	the 45-day period.

# SECTION 9-322. PRIORITY OF PURCHASE-MONEY SECURITY INTERESTS.

3	(a) Subject to subsection (b), and except as otherwise provided in subsection
4	(g), a perfected purchase-money security interest in inventory has priority over a
5	conflicting security interest in the same inventory, has priority over a conflicting
6	security interest in chattel paper or an instrument constituting proceeds of the inventory
7	and in proceeds of the chattel paper or instrument as provided in Section 9-327, and,
8	except as otherwise provided in Section 9-325, also has priority in identifiable cash
9	proceeds of the inventory to the extent the identifiable cash proceeds are received on
10	or before the delivery of the inventory to a buyer, if:
11	(1) the purchase-money security interest is perfected when the debtor
12	receives possession of the inventory;
13	(2) the purchase-money secured party gives an authenticated notification
14	to the holder of the conflicting security interest;
15	(3) the holder of the conflicting security interest receives the notification
16	no earlier than five years before the debtor receives possession of the inventory; and
17	(4) the notification states that the person giving the notification has or
18	expects to acquire a purchase-money security interest in inventory of the debtor and
19	describes the inventory by item or type.
20	(b) Subsections (a)(2) through (4) apply only if the holder of the conflicting
21	security interest had filed a financing statement covering the same types of inventory:

1	(1) if the purchase-money security interest is perfected by filing, before the
2	date of the filing; or
3	(2) if the purchase-money security interest is temporarily perfected without
4	filing or possession under Section 9-310(f), before the beginning of the 20-day period
5	thereunder.
6	(c) Subject to subsection (e) and except as otherwise provided in subsection
7	(g), a perfected purchase-money security interest in livestock that are farm products
8	has priority over a conflicting security interest in the same livestock and, except as
9	otherwise provided in Section 9-325, also has priority in its identifiable proceeds and
10	identifiable products in their unmanufactured states if:
11	(1) the purchase-money security interest is perfected when the debtor
12	receives possession of the livestock;
13	(2) the purchase-money secured party gives an authenticated notification
14	to the holder of the conflicting security interest;
15	(3) the holder of the conflicting security interest receives the notification
16	no earlier than six months before the debtor receives possession of the livestock; and
17	(4) the notification states that the person giving the notification has or
18	expects to acquire a purchase-money security interest in livestock of the debtor and
19	describes the livestock by item or type.
20	(d) Subsections (d)(2) through (4) apply only if the holder of the conflicting
21	security interest had filed a financing statement covering the same types of livestock:

1	(1) if the purchase-money security interest is perfected by filing, before the
2	date of the filing; or
3	(2) if the purchase-money security interest is temporarily perfected without
4	filing or possession under Section 9-310(f), before the beginning of the 20-day period
5	thereunder.
6	(e) Except as otherwise provided in subsection (g), a purchase-money security
7	interest in goods other than inventory or livestock has priority over a conflicting
8	security interest in the same collateral and, except as otherwise provided in Section
9	9-325, also has priority in its identifiable proceeds if the purchase-money security
10	interest is perfected when the debtor receives possession of the collateral or within 20
11	days thereafter.
12	(f) If more than one security interest qualifies for priority in the same collateral
13	under subsection (a), (d), or (f):
14	(1) a security interest securing an obligation incurred [by an obligor] as <u>all</u>
15	or part of the price of the collateral has priority over a security interest securing an
16	obligation incurred [by an obligor] for value given to enable the debtor to acquire
17	rights in or the use of collateral; and
18	(2) in all other cases, Section 9-319(a) applies to the qualifying security
19	interests.
20	(g) A purchase-money security interest in software has priority over a
21	conflicting security interest in the same collateral and, except as otherwise provided
22	in Section 9-325, also has priority in its proceeds to the extent that the purchase-money

1	security interest in the goods in which the software was acquired for use has priority
2	in the goods and proceeds of the goods under this section.
3	SECTION 9-323. PRIORITY OF SECURITY INTERESTS IN
4	<b>TRANSFERRED COLLATERAL.</b> [(a)] [Subject to subsection (b), a][A] security
5	interest created by a debtor is subordinate to a security interest in the same collateral
6	created by another person, notwithstanding anything to the contrary in this part, if:
7	(1) the debtor acquired the collateral subject to a security interest created
8	by the other person;
9	(2) the security interest created by the other person was perfected when the
10	debtor acquired the collateral; and
11	(3) there is no period thereafter when the security interest is unperfected.
12	[(b) If the security interest created by the other person is unperfected when the
13	debtor acquires the property or at any time thereafter, the other provisions of this part,
14	as applicable, determine its priority.]
15	SECTION 9-323A. PRIORITY OF SECURITY INTERESTS CREATED BY

17	(a) Subject to subsection (b), a security interest that is perfected by a filed
18	financing statement that is effective solely under Section 9-510 in collateral in which
19	a new debtor has or acquires rights is subordinate to a security interest in the same

1 (b) If more than one security interest in the same collateral is subordinate 2 under this section, the other provisions of this part, as applicable, determine the 3 priority among of the subordinated security interests.

4 SECTION 9-324. PRIORITY OF SECURITY INTERESTS IN
5 INVESTMENT PROPERTY. The following rules govern priority among conflicting
6 security interests in the same investment property:

- 7 (1) A security interest of a secured party that has control over investment
  8 property has priority over a security interest of a secured party that does not have
  9 control over the investment property.
- (2) A possessory security interest in a certificated security [in registered form]
  which is perfected under Section 9-311(a) has priority over a conflicting security
  interest perfected by a method other than control.
- 13 (3) Except as otherwise provided in paragraphs (4) and (5), conflicting security
  14 interests of secured parties each of which has control rank according to priority in time
  15 of obtaining control.
- 16 (4) A security interest held by a securities intermediary in a security
  17 entitlement or a securities account maintained with the securities intermediary has
  18 priority over a conflicting security interest held by another secured party.
- (5) A security interest held by a commodity intermediary in a commodity
   contract or a commodity account maintained with the commodity intermediary has
   priority over a conflicting security interest held by another secured party.

1	(6) Conflicting security interests granted by a broker, securities intermediary,
2	or commodity intermediary which are perfected without control rank equally.
3	(7) In all other cases, priority among conflicting security interests in
4	investment property is governed by Sections 9-319 and 9-320.
5	SECTION 9-325. PRIORITY OF SECURITY INTERESTS IN DEPOSIT
6	ACCOUNTS. The following rules govern priority among conflicting security
7	interests in the same deposit account:
8	(1) A security interest held by a secured party that has control over the deposit
9	account has priority over a conflicting security interest held by a secured party that
10	does not have control.
11	(2) Except as otherwise provided in paragraphs (3) and (4), security interests
12	perfected by control rank {according to priority in time of obtaining control} {equally}.
13	(3) Except as otherwise provided in paragraph (4), a security interest held by
14	the bank with which the deposit account is maintained has priority over a conflicting
15	security interest held by another secured party.

(b) A transferee of funds from a deposit account takes the funds free of a

  exist under this article in ordinary building materials incorporated into an improvement

16	to the security interest or disclaimed an interest in the goods as fixtures; or
17	(2) the debtor has a right to remove the goods as against the encumbrancer
18	or owner.
19	( <u>h</u> ) The priority of the security interest under subsection ( <u>g</u> ) continues for a
20	reasonable time if the debtor's right to remove the goods as against the encumbrancer
21	or owner terminates.

1 (i) Except as otherwise provided in subsections (f) and (g), a security interest 2 in fixtures is subordinate to a construction mortgage recorded before the goods become 3 fixtures if the goods become fixtures before the completion of the construction. A 4 mortgage has this priority to the same extent as a construction mortgage to the extent 5 that it is given to refinance a construction mortgage. 6 **SECTION 9-332. of the other goods, other than the debtor, for the cost of repair of any physical injury
 to the whole or the other goods. The secured party need not reimburse the
 encumbrancer or owner for any diminution in value of the whole or the other goods
 caused by the absence of the accession removed or by any necessity for replacing it.
 A person entitled to reimbursement may refuse permission to remove until the secured
 party gives adequate assurance for the performance of the obligation to reimburse.

8 (a) In this section, "commingled goods means goods that are physically united

SECTION 9-334. PRIORITY OF SECURITY INTERESTS IN GOODS
COVERED BY CERTIFICATE OF TITLE. If, while a security interest in goods
is perfected by any method under the law of another jurisdiction, this State issues a
certificate of title that does not show that the goods are subject to the security interest
or contain a statement that they may be subject to security interests not shown on the
certificate:

(1) a buyer of the goods, other than a person that is in the business of selling
goods of that kind, takes free of the security interest if the buyer gives value and
receives delivery of the goods after issuance of the certificate and without knowledge
of the security interest; and

certificate and without the conflicting secured party's knowledge of the security
interest.

1 **SECTION 9-335.** PRIORITY OF SECURITY INTEREST OR 2 LIEN PERFECTED BY EFFECTIVE FINANCING AGRICULTURAL STATEMENT CONTAINING INCORRECT INFORMATION. A security 3 4 interest or agricultural lien perfected by a filed financing statement complying with 5 Section 9-502(a) and (b) but containing information described in Section 9-515(b)(5) 6 which is incorrect is subordinate to the rights of a holder of a perfected security interest 7 in or [another purchaser] [a buyer] of the collateral to the extent that the secured party 8 or [other purchaser] [buyer] gives value in reasonable reliance upon the incorrect information. 9

(b) A statutory lien, other than an agricultural lien, perfected by a filed
financing statement complying with Section 9-502(a) but containing information
described in Section 9-515(b)(5) which is incorrect is subordinate to the rights of a
holder of a perfected security interest in the collateral to the extent that the secured
party gives value in reasonable reliance upon the incorrect information.

#### 15 SECTION 9-336. PRIORITY SUBJECT TO SUBORDINATION. This article

16 does not prevent subordination by agreement by a person entitled to priority.

#### 17 [SUBPART 4. RIGHTS OF BANK]

### SECTION 9-337. EFFECTIVENESS OF RIGHT OF RECOUPMENT OR SET-OFF AGAINST DEPOSIT ACCOUNT.

15	SECTION 9-603. AGREEMENT ON STANDARDS CONCERNING

19	standards are not manifestly unreasonable.

- 15 (c) Subject to the other provisions of this part, if a secured party holding a 16 security interest in fixtures has priority over all owners and encumbrancers of the real 17 property, the secured party may, on default remove the collateral from the real property. 18 (d)  $\{Unless otherwise agreed, a\}$  secured party that removes collateral shall 19 promptly reimburse any encumbrancer or owner of the real property, other than the 20 debtor, for the cost of repair of any physical injury caused by the removal. The secured 21 party need not reimburse the encumbrancer or owner for any diminution in value of the 22 real property caused by the absence of the goods removed or by any necessity of

replacing them. A person entitled to reimbursement may refuse permission to remove
 until the secured party gives adequate assurance for the performance of the obligation
 to reimburse.

1 SECTION 9-608. APPLICATION OF PROCEEDS OF COLLECTION OR 2 ENFORCEMENT; LIABILITY FOR DEFICIENCY AND RIGHT TO 3 SURPLUS. 4 (a) If a security interest or agricultural lien secures payment or performance of 5 an obligation, the following rules apply: 6 (1) A secured party shall apply or pay over for application the cash 7 proceeds of collection or enforcement under this section in the following order to: 8 (A) the reasonable expenses of collection and enforcement and, to the 9 extent provided for by agreement and not prohibited by law, reasonable attorney's fees 10 and legal expenses incurred by the secured party; 11 (B) the satisfaction of obligations secured by the security interest or 12 agricultural lien under which the collection or enforcement is made; and 13 (C) the satisfaction of obligations secured by any subordinate security 14 interest in or other lien on the collateral subject to the security interest or agricultural 15 lien under which the collection or enforcement is made if the secured party receives an authenticated demand for proceeds before distribution of the proceeds is completed. 16 17 (2) If requested by a secured party, a holder of a subordinate security 18 interest or other lien shall furnish reasonable proof of the interest or lien within a 19 reasonable time. charges credit service charge plus 10 percent of the principal amount of the obligation
or the time-price differential plus 10 percent of the cash price.

(d) A debtor whose deficiency is eliminated under Section 9-625 may recover
damages for the loss of any surplus. However, a debtor or [secondary] [an] obligor
whose deficiency is eliminated or reduced under Section 9-625 may not otherwise
recover under subsection (b) for noncompliance with [Sections 9-607 through 9-614A,

(a) This section applies in In an action arising from a transaction, other than a consumer transaction, in which the amount of a deficiency or surplus is in issue, the following rules apply: (b) If a deficiency or surplus is calculated under Section 9-614(h), the debtor

has the burden of establishing that the amount of proceeds of the disposition is
 significantly below the range of prices that a complying disposition to an unrelated
 third person would have brought.

(c) Except in a consumer-goods transaction, the following rules apply:

- (1) A secured party need not prove compliance with [Sections 9-607
  through 9-614A, 9-618, and 9-619] [the provisions of this part relating to collection,
  enforcement, disposition, or acceptance] unless the debtor or a secondary obligor
  places the secured party's compliance in issue.
- (2) If the secured party's compliance is placed in issue, the secured party
   has the burden of establishing that the collection, enforcement, disposition, or
   acceptance was conducted in accordance with [Sections 9-607 through 9-614A, 9-618,
   and 9-619, as applicable] [the applicable provisions of this part].
- (3) Except as otherwise provided in Section 9-627, if a secured party fails
   to prove that the collection, enforcement, disposition, or acceptance was conducted in
   accordance with [Sections 9-607 through 9-614A, 9-618, and 9-619] [the provisions

1 of this part relating to collection, enforcement, disposition, or acceptance, the liability 2 of a debtor or a secondary obligor for a deficiency is limited to an amount by which the 3 sum of the secured obligation, expenses, and attorney's fees exceeds the greater of: 4 (A) the proceeds of the collection, enforcement, disposition, or 5 acceptance; or 6 (B) the amount of proceeds that would have been realized had the 7 noncomplying secured party proceeded in accordance with [Sections 9-607 through 9-614A, 9-618, and 9-619] [the provisions of this part relating to collection, 8 9 enforcement, disposition, or acceptance<sup>1</sup>. 10 (4) For purposes of paragraph (3)(B), the amount of proceeds that would 11 have been realized is equal to the sum of the secured obligation, expenses, and 12 attorney's fees unless the secured party proves that the amount is less than that sum. 13 (5) If a deficiency or surplus is calculated under Section 9-614(h), the 14 debtor has the burden of establishing that the amount of proceeds of the disposition is 15 significantly below the range of prices that a complying disposition to an unrelated 16 third person would have brought. 17 (b) The limitation of the rules in subsection (a) to transactions other than 18 consumer transactions is intended to leave to the court the determination of the proper 19 rules in consumer transactions. 1	(d) Approval under subsection (c) need not be obtained and lack of approval

4	SECTION 9-627. NONLIABILITY AND LIMITATION ON LIABILITY OF
5	SECURED PARTY; LIABILITY OF SECONDARY OBLIGOR.
6	(a) Unless a secured party knows that a person is a debtor or secondary obligor,
7	knows the identity of the person, and knows how to communicate with the person:

#### **TRANSITION**

Reporters' Prefatory Comment

11

12 1. Background. A uniform law as complex as Article 9 necessarily gives rise 13 to difficult problems and uncertainties during transition--i.e., while some states have 14 enacted revised Article 9 and some retain former Article 9. As is customary for 15 uniform laws, revised Article 9 is based on the general assumption that all jurisdictions will have enacted substantially identical versions. Section 9-702, which encourages 16 17 states to adopt a uniform effective date for revised Article 9, is an attempt to reduce the 18 length of the transition period.

19 Other problems arise from transactions and relationships that were entered into 20 under former Article 9 or under non-UCC law and which remain outstanding on the 21 effective date of revised Article 9. The difficulties arise primarily because revised 22 Article 9 expands the scope of former Article 9 to cover additional types of collateral 23 and transactions and because it provides new methods of perfection for some types of collateral, different priority rules, and different choice-of-law rules governing 24 25 perfection and priority. This part addresses primarily this second set of problems.

26 2. Status. The statutory text of Part 7 remains somewhat tentative and subject 27 to further drafting refinements. Part 7 was not reviewed by the Drafting Committee 28 until its March, 1998, meeting. However, the Drafting Committee has settled on the

1 2	general principles reflected by Part 7. The Drafting Committee has not reviewed the Reporters' Comments.

7. Continuation Statements. In some cases, this article reclassifies collateral 1 2 covered by a financing statement filed under former Article 9. For example, collateral 3 consisting of the right to payment for real estate sold would be a "general intangible" 4 under the former article but an "account under this article. To continue perfection 5 under those circumstances, which include the circumstances described in subsection 6 (c), (d), (e), and (f), under subsection (g) a continuation statement must comply not 7 only with the normal requirements for a continuation statement (see Section 9-516) but 8 also must contain an indication of collateral that satisfies the requirement of Section 9 9-502(a). Similarly, the sufficiency of the debtor's name and the secured party's name 10 on the continued financing statement must comply with this article after it takes effect.

**Example 2:** A pre-effective date financing statement covers "all 11 12 general intangibles of a debtor. A "general intangible, as defined 13 under former Article 9 would include rights to payment for lottery 14 winnings. These rights to payment are "accounts under revised Article 15 9, however. The second sentence of the subsection is new and tracks Section 6-102(1)(m). It explains what it means to buy "in the ordinary course.
17 18 19 20 21 22 23 24	The penultimate sentence of subsection (9) also is new. It prevents a buyer that does not have the right to possession against the seller from taking free of the rights of third parties. Concerning when a buyer obtains possessory rights, see Sections 2-502 and 2-716, below. This revision is not intended to affect a buyer's status as a buyer in ordinary course of business in cases (such as a "drop shipment ) involving delivery by the seller to a person buying from the buyer or a donee from the buyer. Rather, the disappointed buyer must resort to an action to recover damages. This section contains a very narrow exception that rarely, if ever, has been utilized successfully: A buyer of goods who has paid at least part of the price may recover the goods upon making and keeping good a tender of any unpaid portion of the price, but only if the seller becomes insolvent within ten days after receipt of the first installment of the price. The revisions, which are based upon Section 2-505 of the March, 1998, draft of Revised Article 2, would enable every buyer of consumer goods who paid at least part of the price to recover the goods from a defaulting seller.

19 1. Consumer Goods. The revisions to this section implement part of the 20 agreement concerning consumer-goods transactions. This section contains two 21 exceptions to the general rule that a buyer of goods has no right to recover the goods 22 from a seller who repudiates or fails to deliver in accordance with the contract. Rather, 23 the disappointed buyer must resort to an action to recover damages. Borrowing from 24 Section 2-824 of the March, 1998, draft of Revised Article 2, subsection (3) has been 25 revised to provide that, for consumer goods, the buyer's right to replevin vests upon the 26 buyer's acquisition of a special property, which occurs upon identification of the goods to the contract See Section 2-501 27

2. Interaction with Article 9. Inasmuch as a secured party normally acquires 1 2 no greater rights in its collateral that its debtor had or had power to convey, see Section 3 2-403(1) (first sentence), a buyer who acquires a right of replevin under subsection (3) 4 will take free of a security interest that attaches to the goods after the goods have been 5 identified to the contract. The buyer will take free even if the buyer does not buy in ordinary course and even if the security interest is perfected. Of course, to the extent 6 7 that the buyer pays the price after the security interest attaches, the payments will 8 constitute proceeds of the security interest.

#### 1 1. **Source.** New.

2 2. Article 5 Security Interest. This section gives the issuer of a letter of credit 3 or a nominated person thereunder an automatic perfected security interest in a 4 "document (as that term is defined in Section 5-102(a)(6)). The security interest arises 5 only if the document is presented to the issuer or nominated person under the letter of credit and to the extent of the value that is given. This security interest is analogous 6 7 to that awarded to a collecting bank under Section 4-210. Under subsection (b)(2), the 8 security interest is perfected and has first priority. Because the security interest is 9 conditioned on presentation of the document, perfection by possession under Section 10 9-311 normally would occur even without the automatic perfection provided by subsection (b)(2). Documents that are written on paper and that are not an otherwise-11 12 defined type of collateral (e.g., a certificated security or a document of title) would be 13 goods, for example. The issuer or nominated party also could rely on temporary 14 perfection, under Section 9-310, or filing. However, because the definition of document in Section 5-102(a)(6) includes records (e.g., electronic records) that may not 15 be goods, it is necessary to provide for automatic perfection (i.e., without filing). The 16 17 priority afforded by subsection (b) is limited by subsection (c), which recognizes that 18 subsequent purchasers of negotiable collateral or chattel paper should obtain protection 19 under Section 9-327 or 9-328, when applicable, as should transferees of funds under 20 Section 9-329.

21 It is arguable that this section is not necessary for a document that is a 22 certificated security, a negotiable instrument, or a negotiable document that is presented to an issuer or nominated person. Those parties might achieve the same 23 24 result under a proper interpretation of Sections 2-506 and 4-210 and the good-faith-25 purchaser rules of Articles 3, 7, and 8. See Section 9-328. However, those rules would 26 not apply to other types of documents. An issuer or nominated person might find these 27 non-negotiable documents to be quite important. For example, a confirmer who pays 28 the beneficiary must be assured that its rights to all documents are not impaired. It will 29 find it necessary to present all of the required documents to the issuer in order to be 30 reimbursed. For this reason, we believe that taking the general approach taken by 31 Section 4-210 is sound. However, because the security interest is not dependent on 32 continued possession, it is necessary to qualify the priority of the security interest 33 pursuant to subsection (c).

18	2. Production-Money Priority; "Production-Money Security Interest." There
19	appears to be a general consensus that the former rule affording special priority to
20	those who provide secured credit that enables a debtor to produce crops, found in
21	former Section 9-312(2), is not workable. However, after years of discussion, no
22	consensus concerning the rule has arisen among those who engage in agricultural
23	financing. The issue remains controversial, and opinions differ strongly over whether
24	to replace the rule with one that affords greater protection to providers of production
25	inputs or whether to eliminate the rule without replacing it.
26	Model Section 9-320A contains a revised production-money priority rule. That
27	section is a model, not uniform, provision. The sponsors of the UCC have taken no
28	position as to whether it should be enacted, instead leaving the matter for state
	215

legislatures to consider if they are so inclined. This position reflects the likely division 1 2 of views among state legislatures as to the desirability of the rule. In conjunction with 3 the new priority rule, this section-also a model section-provides a definition of 4 "production-money security interest." It is patterned closely on Section 9-104, which 5 defines "purchase-money security interest." Subsection (b) makes clear that a security 6 interest can obtain production-money status only to the extent that it secures value that 7 actually can be traced to the direct production of crops. To the extent that a security 8 interest secures indirect costs of production, such as general living expenses, the 9 security interest is not entitled to production-money treatment.

19 *1. Source.* New.

20 2. Legislative Option. This model section replaces the limited priority in crops 21 afforded by former Section 9-312(2). As explained in Section 9-104A, Comment 2, that 22 priority generally has been thought to be of little value for its intended beneficiaries. 23 Neither the Drafting Committee nor the agricultural financing community has been 24 able to reach a consensus on the desirability of including a special production-money 25 priority rule in Article 9. For this reason, the rule appears as a model, not a uniform, 26 optional provision for each State to consider during the legislative enactment process. 27 The Sponsors of the UCC have taken no position on this priority rule.

1 3. Priority of Production-Money Security Interests and Conflicting Security 2 *Interests.* This section attempts to balance the interests of the production-money 3 secured party with those of a secured party who has previously filed a financing 4 statement covering the crops that are to be produced. For example, to qualify for 5 priority under this section, the production-money secured party must notify the earlier-6 filed secured party prior to extending the production-money credit. The notification 7 affords the earlier secured party the opportunity to prevent subordination by extending 8 the credit itself. Subsection (d) makes this explicit. If the holder of a security interest 9 in production-money crops which conflicts with a production-money security interest 10 gives new value for the production of the crops, the security interests rank according 11 to priority in time of filing under Section 9-319(a).

4. Multiple Production-Money Security Interests. In the case of multiple
 production-money security interests that qualify for priority under subsection (a), the
 first to file has priority. See subsection (c). Note that only a security interest perfected
 by filing is entitled to production-money priority. See subsection (b)(1). Consequently,
 subsection (c) does not adopt the first-to-file-or-perfect formulation.

17 5. Holder of Agricultural Lien and Production-Money Security Interest.
 18 Subsection (e) deals with a creditor who holds both an agricultural lien and an Article
 19 9 production-money security interest in the same collateral. In these cases, the priority
 20 rules applicable to agricultural liens govern. The creditor can avoid this result by
 21 waiving its agricultural lien.
