### ITEM INSTRUCTIONS

17. Enter file number of Initial Financing Statement as shown on the Amendment to which this Amendment Additional Party relates, exactly as shown in item 1a of Amendment (Form UCC3).
18. Enter information exactly as shown in item 9 of Amendment (Form UCC3).
